CLASS B FARM AT NEWPORT NEWS, IF HE WERE SIX YEARS YOUNGER...

HE IS THROWN INTO THE POSTWAR RECONSTRUCTION OF BASEBALL, AND PLACED IN COMPETITION WITH A VAST NUMBER OF YOUNGER, MORE SKILLED AND MORE EXPERIENCED PLAYERE...THE FIRST FACTOR ALONE APPEARS LIKELY TO BEAT HIM DOWN." (STOLE PARAGRAPH)
