Heartiest greetings from the Lindenwood campus! It is almost startling to realize that another year has passed since our last Donor Report. As we commenced Lindenwood's 182nd year of service to students, it occurred to me again that this stately frontier college is currently enjoying its greatest era of growth and outreach.



We now employ approximately 200 full-time faculty members, about the same number of full-time staff members and administrators, and more than 800 excellent adjunct professors – practicing professionals – from the Greater St. Louis Metropolitan Area. The St. Charles campus spans more than 500 contiguous acres, we have ten extension campuses in the region, and we teach and mentor more than 14,000 students each year.


This fall we debuted Lindenwood's majestic Center for the Fine and Performing Arts, with Liza Minnelli providing an opening-night audience of nearly 1,200 patrons with one of the most memorable evenings of their lives. The kickoff of the expansion of Harmon Hall into a center for business and entrepreneurship took place just in the nick of time because we have petitioned our accrediting agency – the Higher Learning Commission – for approval to offer a Doctor of Business Administration degree in the near future. I also need to mention the groundbreaking ceremony scheduled for early in 2009 for the new Lindenwood Commons: a 120,000 square-foot facility that will include a dedicated student center, intramural and fitness areas, and a second full-service dining hall with several innovative meal options.

We are writing another wonderful chapter in Lindenwood's history. Like a successful marriage, though, a great university is a product of both sincere dedication and ample sustenance. You have received this report because you help provide both ingredients through your abiding interest in and generosity toward this school. Without your help it would be much more difficult to bring about the inspiring developments mentioned in this letter. Without your gifts, fewer students would have access to what we offer, and the latter would be of lesser quality.

I promise you this: Every dollar you donate to Lindenwood goes into providing present and future students with the best higher education available anywhere. Bequests

A will is the easiest and most effective means to ensure that you provide for your family and that your assets will be distributed as you wish. Ask your financial advisor about bequest options and assistance.

Appreciated Real Property

Donations of appreciated property can provide both a generous contribution to Lindenwood and financial benefits for you.

Gifts of Securities

Transfer of stock and other appreciated securities to Lindenwood can give you a substantial tax savings. Donors can receive an income tax deduction equal to the fair market value of the stock on the date of the gift — thus reducing your taxable capital gains.

Charitable Gift Annuity

This gift frees up your assets in order to generate current income to you during your lifetime. You make an initial gift to Lindenwood and then a set payment is paid during your lifetime or at a designated time such as retirement.

Charitable Remainder Trust

This is a managed and invested trust that provides you and/or other beneficiaries you name with a stream of income for life or a period of years. Almost any asset can be used to fund the trust, and the trust can be tailored to suit your personal financial needs. A Charitable Remainder Trust can have substantial tax benefits for you.

Charitable Lead Trust

This is almost the opposite of a Charitable Remainder Trust. Instead of the donor's receiving the income, Lindenwood would receive the income for a specified number of years. At the end of the trust, the remaining principal is returned to you or another a person of your choosing. You can potentially receive a charitable tax deduction for the percentage paid to Lindenwood.

Life Insurance

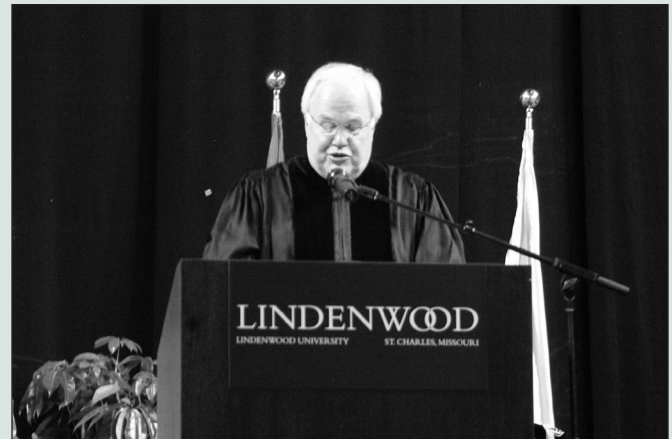

Interest generated by the fund may be held and applied to the principal to help complete the fund or may be blended with other endowment interest to award scholarships until the fund reaches \$25,000. Only the interest generated by the fund is awarded. The corpus or principal of the fund is invested and is not distributed.

Gift payments may be made to the named award fund monthly, quarterly or annually until the fund is fully endowed. Funding must be completed within 10 years after the initial gift.
