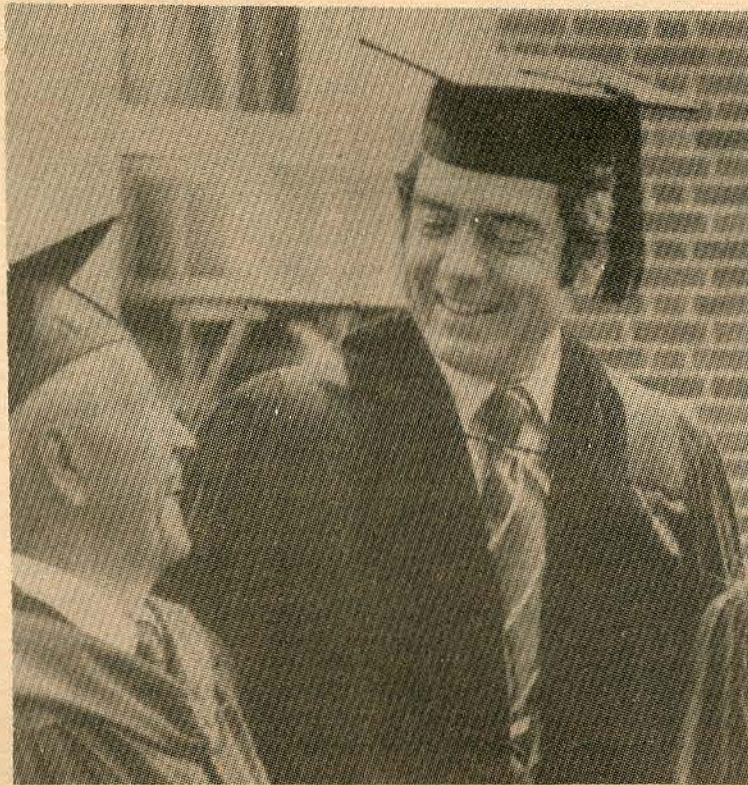
COMMENCEMENT '74

Dan Rather, White House Correspondent for CBS News, gave Lindenwood's commencement address. The 42 year old reporter, who has gained national recognition for his hard questioning of President Richard M. Nixon and his press aides, did not make any reference to Watergate, the Presidency, or his relationship with Nixon. He chose rather to speak to the 144 graduates about the American spirit. He defined this as a "willingness of heart, a willingness to believe that all problems are solvable."

As an undergraduate at Sam Houston College in Huntsville, Texas, Rather read the works of F. Scott Fitzgerald, and there he found this definition of the essence of Americanism. "The European and the Oriental mind find the American belief that all problems are solvable childlike. Philosophically and historically they may be right. The American experiment may be proved wrong, but nevertheless this is what we are about—a willingness of heart."

Rather quoted Jeb Magruder, the convicted lawyer formerly on Nixon's White House Staff, who said: "We Americans have lost our ethical compass." Rather agreed that this may be so, but added: "We have not lost everything if we have a willingness of heart."

Labeling Americans an endangered species, Rather sounded a note of warning concerning the freedoms that we, as Americans, have taken for granted as our birthright. Speaking to the crowd of 1,200 people gathered on the lawn of the campus, Rather said: "What a precious thing you have as a free person. Your father gave it (freedom) to you, and his father before him passed it down. We are, however, a vanishing species. The world has become more and more authoritarian in my own life time. The tide is running away

from freedom. My generation has not been able to reverse this tide, and you may not be able to either, but we must not follow the herd. A new and dangerous strain is appearing in the American character—we are becoming too turkey-like."

Rather concluded his address by urging the 1974 graduates to remember the meaning of the words liberal and conservative. "The American liberal is one who is dedicated to the achievement of the American revolution no matter who is against it, and the American conservative is one who is dedicated to the conservation of the American values. The true liberal and conservative must not

disappear from the American scene."

Immediately following his address, Rather received the Honorary Degree of Doctor of Laws for his outstanding achievement in the field of journalism. The award was presented by Robert Hyland, the Vice President of CBS and Chairman of the Board of Control of the Lindenwood Colleges.

The senior gift was presented by Jennifer Vacek, president of the class of 1974. The gift is a Linden tree, which is to be planted in the fall in front of Roemer Hall. At the base of the tree will be placed a plaque inscribed with the words "Lindenwood I 1974."

Alumnae Reunion Weekend May 4

One hundred and fifty alumnae representing classes from 1905 to 1974 took part in the annual alumnae reunion on Friday and Saturday, May 2nd and 3rd. The enthusiastic tone of the reunion was set on Friday at the spirited hospitality hour held at Dean Doris Crozier's residence, The Gables, the wood frame house erected in 1905 by the Sigma Sorority and acquired by the college in 1921.

Alumnae seemed like the students they had once been, meeting each other fondly after having been parted by a vacation.

On Saturday morning the day began with a buffet breakfast held in the Garden Room of Cobbs Hall. This was followed by the Alumnae Association Meeting in the new Jelkyl Center for the Performing Arts. The meeting, ably presided over by President Marie Christensen Robb of Indianapolis, included a report on the bylaws, the alumnae annual giving, a nominating committee report, and then the alumnae club reports. A sense of pride was felt by all the alumnae as they heard that the percentage of alumnae who donate to their college is increasing, and that the existing clubs throughout the country are very active.

President Robb then introduced Howard Barnett, Vice President and Dean of the Faculty. The focus of Dean Barnett's remarks was on the history of Lindenwood in the past decade and its place in the larger picture of higher education in America. His frame of reference was two points in time, 1966-67, which was the last year of the balanced budget with 824 students—792 of whom were full time and 600 in residence; and, 1973-74 in which we had a head count of 900 students, highest in the history of the college, but only 500 were full time

and only 300 in residence. Dr. Barnett explained that changes such as the addition of Lindenwood II, the 4-1-4 calendar, the career-oriented liberal arts program, and off-campus study represent Lindenwood's response to the difficult situation in higher education today and our attempt to reach out for enrollment programs that are attractive to students. They have been enthusiastically received; and now we must work on residence enrollment. Dean Barnett concluded, "Lindenwood will make it through the '70's, in spite of the difficulties of our times, because our physical and spiritual resources are rich and our students and alumnae care deeply about the continued existence of their Alma Mater."

President Robb then introduced Mr. Edwin Gorsky, the new Director of Admissions, who spoke about his plans to double the number of resident students. He showed a great sense of confidence that he will be able to reach this long range goal. He has been recruiting coast-to-coast—even in St. Louis.

He reported that it actually costs less, on the average, for a St. Louisan to live on the campus rather than commute. He also spoke of the importance of alumnae and students in attracting new students to Lindenwood. He wants to make more use of alumnae—asking them to contact some of the prospective students and to see that interested students come to visit the campus.

He believes that once they are here the college sells itself.

Dr. Franc L. McCluer, Interim President, then spoke about the new career-oriented liberal arts program—showing how the two are working together to prepare for a job and to prepare for life. In

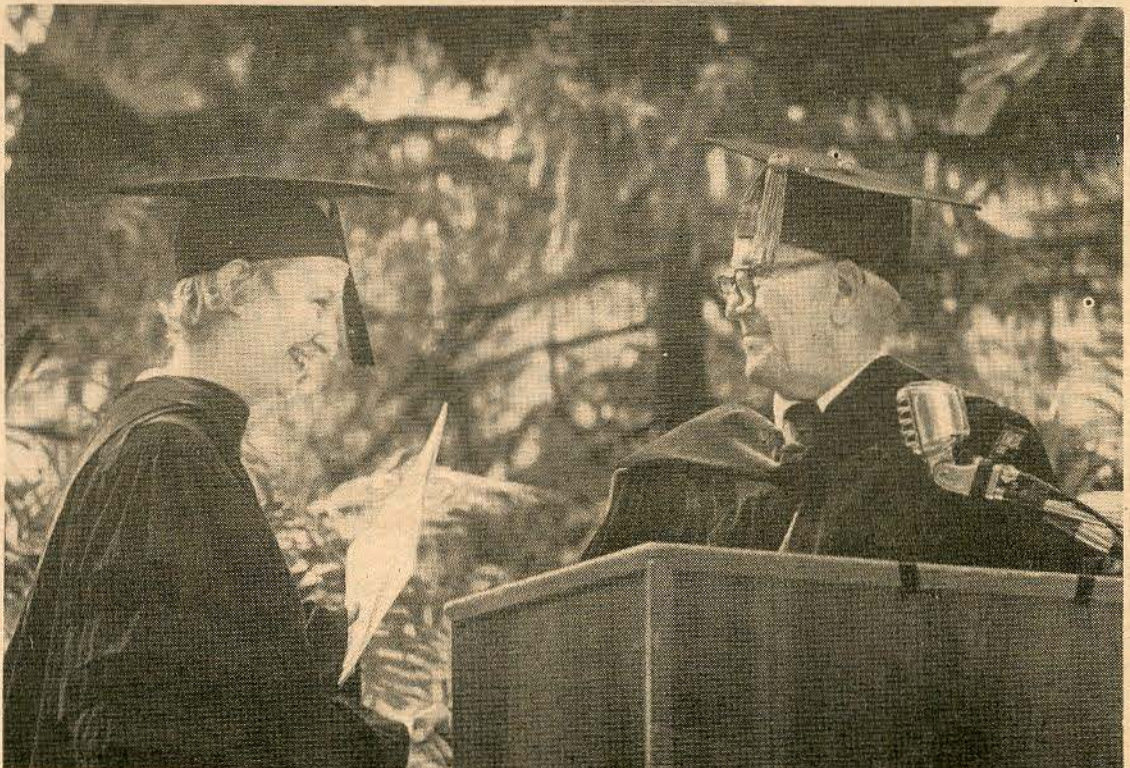
Lindenwood College is an exciting and stimulating place and this is reflected in the accomplishments of the graduates of this institution. One such young woman, who mirrors the greatness of Lindenwood, is Deann DUFF Smith. She graduated from this college in 1963 with a B.A. degree in Political Science. She continued her education at Stanford University, where she was granted a law degree in 1966.

Deann Smith then came back to her native Missouri and in 1968 was appointed as Assistant to the Attorney General of Missouri. She was the first woman to hold this position. From 1969 to 1970, Deann

served as an attorney for the National Labor Relations Board in St. Louis. She then returned to her home town of Houston, Missouri, and was elected as Probate and Magistrate Judge of Texas County, and was the first woman ever elected to this position. She is currently running for re-election.

Her husband, Jay Smith, is the owner and manager of Radio Stations KBTC-AM and KSCM-FM in Houston, Missouri. There is another member of the Smith family—a little two year old girl named Amy, who is a sixth generation Texas Countain and, we hope, a future Lindenwood student.

In addition to her duties as a judge, a wife, and a mother, Deann is active in all the usual community organizations. She is, also, a member of the Board of Overseers of Lindenwood College for Women. We are truly proud of this young lady and are happy that she is "one of our own."

PRESIDENTIAL SEARCH

At the joint meeting of the Boards of The Lindenwood Colleges on May 10 it was decided not to elect any of the presidential candidates who had been seen by the Search Committee, and to continue the search.

Associated Educational Consultants Corporation will assist in locating well qualified candidates. Frank Lloyd is the Director of this corporation. The direction of the search will be assigned to that consultant who seems best suited to us. He will meet with our Board and have a series of talks with faculty and students to learn as much as possible about the nature of Lindenwood and the community. He will ask the Board to

review the philosophy of the school, to establish criteria, and set a job description.

A list of candidates will be assembled from suggestions of members of the Boards, faculty, parents, or alumni, in addition to those developed by the consultants. Those candidates who meet the established criteria will be carefully evaluated. Interviews will then be arranged. The final selection will, of course, be made by the Boards.

If you have additional names of candidates to suggest, we shall appreciate it if you will send them to President McCluer. Dr. McCluer has agreed to continue as Interim President until a president is elected.

this way students will be ready to meet the challenges in the rapidly changing society. He assured the alumnae that he finds the College he directed from 1947 to 1966 to be vigorous and vital in 1974. He feels that a spirit of optimism about the College's future and a belief in the strength of the school's faculty and facilities permeate Lindenwood today. He closed by saying that he feels a year younger since returning to the campus. The alumnae's loving response to Dr. McCluer was very moving.

At the close of the meeting, the alumnae joined the faculty and administration for the reunion luncheon in the Amber Room of Ayres Hall. While the guests enjoyed their lunch and good talk with old friends and classmates, they were entertained by Lindenwood's choral group under the direction of Dr. Kenneth Greenlaw, Chairman of the Music Department. The students sang excerpts from the musical *Oliver*.

The seven members of the Class of 1924—Gladys Campbell Billings, Isabella McMenemy Cheek, Adaline Ayres Cross, Roma Key Diekman, Ruth Kern Messing, Katharine Tinsman Patton, Ruth Steedman Wright—were honored with a gift and special recognition by the Alumnae Association.

Recognition was also given to the retiring members of the faculty who were present—Mary Ambler, Librarian; Lula Clayton Beale, Registrar; Hazel Toliver, Chairman and Professor, Classics. After lunch door prizes were given, and fate determined that Florence Bloebaum Null, Class of 1905, the oldest alumna attending the reunion, received the first prize.

The afternoon was filled with many activities. At the Country Fair a great assortment of items was sold that had been handmade and donated by individual alumna and clubs throughout the country. The beautiful and colorful materials included ecology boxes, macrame, needlework, decoupage, art work of all kinds, and delicious baked goods. The Country Fair netted \$425 to be added to the fund for the celebration of Lindenwood's one hundred and fiftieth birthday in 1977. Upon leaving the Country Fair, alumnae attended the Beta Chi Horse Show at the Fairgrounds and the Student Art Exhibit held in the Fine Arts Building.

On Saturday evening the alumnae attended reunion parties planned by various classes or went to the Copper Platter Restaurant in the historic district of St. Charles. Spring Council Meeting

The Annual Spring Alumnae Council met on the campus May 2 and 3. The agenda included the revision of the Bylaws, discussion of plans for the Sesquicentennial, choosing the Merit Award candidate, consideration of the Chapter Handbook, and the Nominating Committee report.

Reports to the Council were made by Dr. McCluer, Dr. Barnett, Dean Crozier and Dean Delaney. Mr. Henren gave a full account of the January Term programs and Tom Smith, Acting Development Director, brought the Council up-to-date on the Alumnae Annual Giving Campaign. Lucy Morros, Editor of the Key Persons Newsletter, told of her work with the Key Persons and Mr. Gorsky, the Director of Admissions, discussed the admissions picture both from the national point of view and the Lindenwood situation.

Those present were, Marie Robb, President, Folsa Gibbons, Vice-President, Pam Carter, Secretary, Marilyn Donnelly, Jean Evans, Marilyn Heilman, Janice Vassar, Joan Johnson and Marian Ellis. Dorothy Warner represented the Board of Directors, Nancy Orr talked with the Council concerning the Sesquicentennial plans. Mary Lichliter, Director of Alumnae Affairs, and Dorothy Barklage, Associate Director were also present.

New Faculty Appointed

Three new professors and a librarian will join the Lindenwood faculty this fall. All are coming as replacements for faculty members who have taken other positions or retired.

Dr. Penelope Biggs has been appointed as Assistant Professor of English and comes to us with a doctorate from Washington University in the field of comparative literature. At Lindenwood she will be teaching in areas covered by Dr. Agnes Sibley and Dr. Hazel Toliver, both of whom are retiring this spring.

Mr. James Evans, who is completing his doctoral work at Iowa State University, will join the faculty as Assistant Professor in the Psychology Department.

Dr. Steve B. Rukavina, who has been assistant professor in the Department of Curriculum and Instruction at the University of Wyoming, has joined the faculty as Associate Professor in the Department of Education.

Miss Patricia Delks, currently of the Smith College Library, will assume the librarianship at Lindenwood beginning in August 1974. Miss Delks has degrees from Indiana University and Case Western Reserve and has served in libraries at the University of California at Los Angeles, Syracuse University, and Smith College where she has been head of the reference department.

Lindenwood Calls for More Key Persons

What is the Key Persons Program? It is an effort by the Alumni who have volunteered to be the information-and-personal contact arm of the College. It is an effort by those who care enough about the well-being of their alma mater to make Lindenwood more VISIBLE in their own local community, to share with others their interest in and enthusiasm for the college. It is not recruiting, but an aid to the recruitment process.

What can the Key Person do? The most effective way to help Lindenwood is the one best suited to the individual Key Person's own interests and involvement in the community—the community of churches, schools, social clubs, professional groups. A few examples may be of help.

1. By identifying prospective

students who are nearing college age, information can be sent to the Office of Admissions and they will immediately follow-up any lead.

2. By talking with young people about the kinds of programs and the kind of life Lindenwood College offers its students, you can stimulate their interest in learning more about the college through reading our literature and through visits to the campus.

3. By sending to the Office of Admissions names of college counselors from your local high schools in order to enlarge our contacts with those who are influential in recommending colleges and universities to their juniors and seniors.

4. By assisting, upon request, our Admissions Staff when College Fairs or College Nights are in your locality. This past year Katie Gaffney Velsor, Class of 1969,

helped Mr. Hatcher at the Philadelphia College Fair and Connie Herber Zimmer, Class of 1973, assisted him at the Boston College Fair.

5. By providing a social afternoon or evening in your home for interested students in order to acquaint them with information about the college.

If you have not been contacted and would like to serve the college in the capacity of a Key Person, please let us know. No matter how small your community or how limited your contacts might be—you may be able to interest even one student and you can be an integral and important part in our widening network of alumnae throughout the country. Monthly newsletters are sent to Key Persons in order to keep them AU COURANT with the continuing life of the College.

Outstanding Educators of America is an annual awards program honoring distinguished men and women for their exceptional service achievements and leadership in the field of education.

WE HONOR

On May 2, 1974, the Washington University Beta Upsilon Chapter of KAPPA DELTA PI, the National Honor Society of Education, honored Marjorie Ann Banks, a past president, for her exceptional contribution as an advisor to the Chapter.

On this occasion, Dr. Esther L. Johnson, Chairman of the Department of Philosophy and Religion of the Lindenwood Colleges spoke relating the many achievements of Miss Banks, an author of books for children, an inventor, a master teacher, and now Professor Emeritus of Education of The Lindenwood Colleges.

Summer Session Begins

Lindenwood's 1974 Summer Session is offering a wide range of courses, workshops, and conferences during the two sessions; the first begins June 10 and ends on July 5, and the second session begins on July 8 and runs until August 2. The entire Summer Session is designed to provide instruction in beginning and advanced undergraduate courses for students just beginning their college work, and for those already enrolled at Lindenwood or at other colleges and universities. Qualified high school students may enroll in some courses and have the credit banked for use when the student enters college.

This summer the offerings are more extensive and more diversified in content than previously. One exciting new development is a workshop offered by the Communication Arts Department. This workshop is designed for actors, directors, writers, and designers, and will be conducted in cooperation with the St. Charles Theatre and Opera House, a professional repertory company in St. Charles. The workshop will be organized around the company's summer repertoire: A STREETCAR NAMED DESIRE, LION IN WINTER, YOU CAN'T TAKE IT WITH YOU, and YOU'RE A GOOD MAN, CHARLIE BROWN. The faculty of the workshop will be made up of theatre professionals from across the United States, who will also serve as guest artists with the company. Another innovation is a course

in Environmental Psychology. This is a new area of study in the field of psychology. The course involves the study of the consequences of environmental manipulation on man; for example, an investigation of the effects of crowded living conditions on man's psyche and the effects of environmental noise on man's aggressivity. The course includes selected readings from multi-disciplinary areas, relating basic psychological processes to the environment.

From June 17 to June 21 there will be a conference on Children, Media, and Learning. This is to be co-sponsored by Miller-Brody Productions, publishers of multimedia materials for the young school child. This conference is designed to provide participants with an inside look at the world of commercial materials' production for children and youth.

From June 24 to June 28 there will be a second conference on Children's Literature, given with the assistance of Charles Scribner's Sons. This is a rich conference for teachers, writers, and library-media personnel who seek the opportunity to explore the current trends in the field of children's literature.

In addition to the Summer Session, Lindenwood's Evening College is offering a Summer Term in which students may register for courses in Business Administration, Communication Arts, English, Mathematics, Political Science, and Sociology.

ESTATE PLANNING

Many alumni have appreciated stocks or bonds which they would like to give to Lindenwood, but they feel the only feasible way of making such a gift is by will. The income from these assets is necessary for their annual living expenses.

If you are in a similar position, you should investigate the benefits of purchasing a Charitable Gift Annuity from Lindenwood. Consider the example of a Lindenwood alumna who recently purchased such a gift annuity. Instead of receiving an annual 7 per cent return from her public utility stock, Lindenwood promised her an annual return of 8.2 per cent on her investment for the rest of her life. This was particularly appealing to this individual because of the

uncertainty of the present stock market.

In addition, much of the annual income from a gift annuity contract with Lindenwood is considered to be tax free by the IRS, thus partially reducing the income tax burden and freeing more spendable dollars. And the donor is granted a charitable deduction for part of the gift, which results in a further savings of income taxes. Any capital gain resulting from the transaction is only partially recognized, and can be reported ratably over the life expectancy of the donor.

The Charitable Gift Annuity might be just the solution for you. In the case just mentioned, the alumna was thrilled to be able to make her gift to Lindenwood while she was still alive. The personal

presentation of her gift and the congratulatory words and letters to her from Dr. McCluer and others contributed to a much more rewarding and enjoyable experience than reliance upon a gift in the form of a bequest.

I would be happy to discuss confidentially with you the advantages of the Charitable Gift Annuity. There is also the possibility of a Deferred Charitable Gift Annuity, through which immediate income tax deductions are allowed but actual payments to the donor are deferred for a certain number of years. Lindenwood Fund Campaigns

Alumni Fund

This year's Annual Fund Campaign presently totals \$21,733, with donations continuing to arrive. Over 675 alumni have contributed this year, or about 7½ percent of all alumni contacted. This compares favorably with last year's percentage of about 4½ percent. The national average, however, is about 17 percent, so we still have work to do.

We are delighted to announce that the Southern California Chapter of the Lindenwood College Alumnae Association has contributed the sum of \$475 to the college, \$425 of which is to be spent on books for the library. The volumes which will be purchased through this gift will be marked and identified as gifts from the Southern California Alumnae Chapter. This money was raised with \$2.00 portions from the Chapter's \$3.00 dues and through their annual Mrs. Claus Mini Bazaar that features handicrafts and recipes of their membership.

Community Support

This year's Community Support Campaign is being headed by Tom Boschert, Vice President of The First National Bank of St. Charles. At the kick-off breakfast for the local citizens who made personal calls for the colleges, Mr. Boschert announced a total of \$5200 in advance gifts which had been pledged by four local firms.

In addition, The First National Bank pledged a total of \$100 in matching funds to the campaign. First National agreed to match dollar for dollar any new gift or any increase in a gift over last year.

Presently the campaign has resulted in over \$17,000 in gifts and pledges. Returns from mailings are also beginning to arrive and it is hoped that the total amount raised will be about \$25,000. President McCluer, noting the benefits of the Colleges to the local community, thanked those who worked on this year's campaign for their time and personal interest in Lindenwood. He stressed that contributions from friends of the colleges were important in maintaining the scope and quality of the educational opportunities at Lindenwood.

Sixty-six parents of present or former Lindenwood students contributed \$10,275 to this year's Parents' Fund Campaign. The campaign was given a significant boost by a \$5000 donation from the parents of a present student. These parents wanted to express their appreciation for the fine education which Lindenwood made available to their son. President McCluer expressed his sincere gratitude to all the parents who contributed to this year's campaign.

Professor to Make Home in England

Dr. Agnes Sibley, Professor of English, will emigrate to England at the end of this spring semester. After thirty years of teaching at Lindenwood, she has decided to retire early in order to have the time to complete her book on Charles Williams which is to be published by the Twayne English Authors Series. Charles Williams wrote metaphysical thrillers such as DESCENT INTO HELL, WAR IN HEAVEN, and ALL HALLOW'S EVE, as well as a cycle of poems on King Arthur, but he is perhaps most famous for his friendship with C. S. Lewis and Tolkien. Dr. Sibley's decision to move to England permanently is based on a long relationship with the country.

Twenty years ago, she was an exchange teacher at Bishop Otter College in Chichester, Sussex, and since that time, she has returned almost every year. In fact, in the last three years, she has spent one semester out of every two in England. She is drawn to England at this point in her life not only for research on Charles Williams but also for the friends she has made there over the years and for the slow-paced, leisurely life she so loves.

In England, she has the time to enjoy the pleasures of oil and pastel painting, the time for

vegetable printing with potatoes and cabbages, and the time to garden. Concerning the year-round growing season in England, she remarked, "In the winter, we just brush the snow off the cabbages; they rarely freeze." Dr. Sibley will live in Heyshott, a village at the edge of the Downs—low, rolling hills—which are only one-half hour away from the sea.

We, at Lindenwood, all regret her decision to retire early, but we join with her joy at the prospect of living in the beautiful English countryside of Sussex and of thus becoming part of that country whose literature she has studied and loved most of her life.

Retiree

Mrs. Helen Davies, Head Resident of McCluer Hall, is retiring at the end of this school year. Mrs. Davies first came to Lindenwood as a student in 1928 and 1929. She then married and lived with her husband in Australia for thirteen years and in Dodge City, Kansas, where she raised her family. In 1965 she returned to the college of which she had so many pleasant memories to become Head Resident of Butler Hall and in 1968, Head Resident of McCluer Hall.

Mrs. Davies speaks very lovingly of Lindenwood. Of her experience she says: "There have been many changes in the last ten years, some of them difficult, some of them very rich. I am glad that I have had the opportunity to be a part of the life of this college." Mrs. Davies is especially positive when she talks about the attitude students have shown toward their courses and the new programs in which they are involved. "I have seen students return from a January Term in Europe, or from an internship experience in St. Louis or St. Charles, with a new sense of confidence about their ability to function in the world. This confidence is reflected in everything they do."

Miss Beale is retiring this year after twenty years at Lindenwood. In that time she has served as the Head Resident of Butler Hall, the Assistant to the Dean of Students, and Registrar. Miss Beale came to the college in 1952 from Murray, Kentucky, where she had been an elementary school teacher in the public schools for twenty-three years. It was through her friendship with Harry Hendren, a fellow Kentuckian with whom she had taught, that the opportunity of a career at the college was made possible.

About her life at the college, she

says: "Oh, happy day that fixed my choice on Lindenwood." Her career has been a rich one not only for her but also for all the associates with whom she has worked and for the thousands of students who have had the privilege of knowing this genuinely caring and refined woman. The majority of her years at Lindenwood were spent when the college still had an all-woman population so she saw the college's change to a coordinate institution. Speaking about her career here, she said: "It's been a wonderful period and I've enjoyed every minute. I'll miss it all."

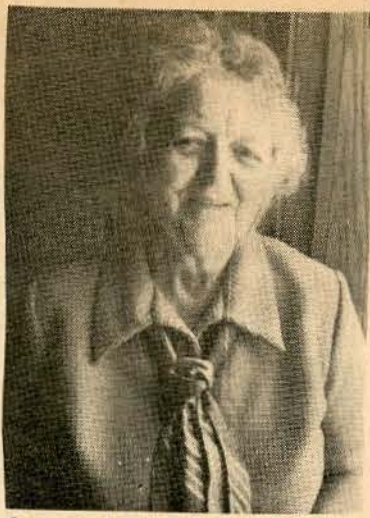
Dr. Toliver did her undergraduate work and earned her M.A. at the University of Arkansas in 1933. In 1942 she received a research fellowship to go to the University of Iowa where she earned her Ph. D. in 1945. From Iowa, she moved to the University of Indiana at Bloomington, where she taught for seven years. She then spent three years as Associate Professor of History and Classics at the University of Kansas City and two years at Northeast Missouri Teachers College before coming to Lindenwood.

Dr. Toliver has traveled extensively in Greece, Italy, England, France, Switzerland, Portugal, Turkey, the United States, and Canada. In 1969 she took her sabbatical in Greece, which is her favorite country not only because of its beauty and friendliness but because of its associations with the ancient Greek literature she loves and has taught so many years. Dr. Toliver has published numerous papers on classical topics since receiving her Ph.D. and is currently revising a book *The Influence of the Theater on Roman Society* for publication.

Dr. Toliver grew up in Northeast Arkansas, and upon retirement, she will return to Arkansas where she is having a house built in Pocahontas, "a little bit of a village" on the lake where she plans to do a lot of fishing.
