

Lawrence (Larry) Acker PhD Education University of Missouri-St. Louis

Larry Acker earned his PhD in Education from the University of Missouri-St.

Louis in 2003 and also holds a master's degree in health administration from Washington University and an AB in English literature from Saint Louis University. He taught healthcare administration as an adjunct professor at Webster University from 1984-2013. Alison J. Albee is a researcher and educator with a diverse scientific background. She earned her

doctorate in biochemistry studying cell division from the University of Wisconsin-Madison. She continued her training as a postdoctoral researcher in genetics at Washington University in St. Louis. Prior to obtaining her doctorate, Albee worked at Sigma-Aldrich. She obtained her bachelor's degree from Purdue University in molecular biology. Her current research interests lie in understanding how the cilium, a cellular organelle implicated in various human diseases, develops and functions using a combination of cell biology, genetics, and biochemistry. At Lindenwood University, she will be teaching general biology, cell biology, and genetics. In addition to teaching, she is also looking forward to involving Lindenwood students in her research on the biology of cilia.

**Geremy Carnes** PhD English University of Michigan

Geremy Carnes earned a doctor of philosophy in English literature

from the University of Michigan, where he taught as a graduate student instructor and lecturer for several years. He teaches composition as well as Restoration and eighteenth-century literature. His research focuses on the history and literature of religion in the eighteenth-century. His dissertation investigated the strategies adopted by eighteenth-century writers as they attempted to come to terms with the permanent presence of an "alien" religion, Catholicism, in England. An essay based on a chapter of this dissertation was published in the 2012 volume of The Eighteenth-Century Novel. Carnes is currently at work on a project that will use a large, digitized corpus of sermons and catechisms from the seventeenth and eighteenth centuries to track the development of the concept of liberty of conscience in the writings of Protestant and Catholic English clergy.

For the past four years, Carnes has volunteered at a therapeutic horse-riding program in Ann Arbor and plans to continue doing so at one of several such programs in the St. Louis area. He says helping riders grow in confidence and independence through their experiences on horseback has been one of the highlights of his life.

The tortoises have had a long history (over 20 years) of helping students in Nevada research aspects of tortoise ecology such as temperature preferences, habitat preferences, feeding ecology, and immunology.
