# Building Fund Campaign Announced

"Within three years, we want to have our annual support basis at \$2 million annually. We are on target now and want to address the college's serious problem of building renovation," said Edward D. Watkins, vice-president for institutional development.

In announcing Lindenwood's current building fund campaign, Watkins said the college is looking for major contributors - minimum donations of \$10,000 or more - to secure \$3 million for badlyneeded building restoration and repair.

As part of the college's Renaissance Campaign to secure \$10 million in pledges and contributions, the \$3 million has been broken down into historic eras in the college's history - \$500,000 for Sibley Hall, \$1.5 million for buildings constructed during the administration of John L. Roemer, \$500,000 for buildings

erected during the presidency of Franc L. McCluer and \$500,000 for new facilities as part of the Renaissance Campaign and the administration of James I. Spainhower.

"We are doing something most colleges and universities don't do," Watkins said, "for we are trying to preserve our heritage."

Buildings and residence halls to be addressed include Sibley, Ayres, Butler, Niccolls, Roemer, Irwin, Butler Library, the Memorial Arts Building, Cobbs, McCluer, Parker and Young halls.

Roofing repairs constitute much of the total sought while remaining funding will go to window repair, air conditioning, electrical work, heating and plumbing renovation and structural maintenance.

"Our buildings, as much a part of our heritage as our academics, need constant care and renovation," Watkins said. "Today, we must all envision ourselves as responsible for being the modern day patrons of the Lindenwood Renaissance. But, a true Renaissance will not happen at Lindenwood until we complete our \$10 million goal," he added.

The \$3 million sought for building repairs and renovations is in addition to the college's current fund-raising drive to generate \$800,000 each fiscal year for operating expenses, both of which total

## AT&T 'Reaches Out' with LCIE's Touch

Nearly 9,000 employees of American Telephone & Telegraph (AT&T) Information Systems will be eligible during the next two years for undergraduate or graduate education at the Lindenwood

College for Individualized Education (LCIE) through a unique program jointly approved by the two organizations.

Under terms of the program, the LCIE will offer individualized instruction that is tailored to meet specific needs of AT&T Information Systems employees in the metropolitan St. Louis area. The college will provide on-site instruction at several AT&T sites as well as at LCIE facilities in Clayton and west St. Louis County in addition to Lindenwood's main campus in St. Charles.

According to Arlene Taich, Ph.D., dean of the Lindenwood Evening College / LCIE and one of the organizers of the program, an estimated 400 AT&T Information Systems employees are expected to take part in the program during the next two years.

The LCIE will offer a bachelor of science degree in business administration at the undergraduate level and the Master's of Business Administration degree at the graduate level.

# president's message

We have made something new out of something old at Lindenwood!

How many of you alums remember the president's table? I am told that it was once the custom for students to alternate turns eating with the president in the dining hall. Many alumnae have expressed their appreciation for that opportunity because it allowed them to get to know the president of the college on a one-to-one basis.

The more I thought about that tradition, the more wonderful it seemed. But, I had difficulty in visualizing how the tradition could be restored, given our cafeteria-style of serving and the staggered schedules upon which students now eat. Our academic dean, Dr. James Hood, came up with an idea on how to revive the tradition. He suggested I

invite 10-15 students to eat with me at lunch once a week, and by the end of the year, every student could have his or her turn at the president's table. This fall we resurrected the tradition with the "Legacy Luncheons" in our new "Legacy Room." The Legacy Room is located in Ayres Cafeteria and its walls feature the pictures of former presidents of Lindenwood, former board members and others who have figured prominently in the grand history of the college.

The response from the students has been extremely positive and I am enjoying the opportunity of getting to know Lindenwood students personal-

It occurs to me that there is another area in which Lindenwood can make something new out of something old. I am referring to the old buildings on our campus — buildings that have meant so much to so many for so long a time. We need to take these historic buildings, many of them in need of dire repair, and make them appropriate for the needs of Lindenwood today.

As I walk around this campus,

As I walk around this campus, beneath a canopy of leaves and limbs which grew from seedlings planted by our college's ancestors, I am struck with a reverence for the insight of our forebearers. What vision and good taste had those who governed our college in years past!

This fall, I was privileged to meet with one of those who gave so much to the college in years past, Mr. John Black of Corona Del Mar, CA. Black served as member of our board of directors for many years, and for several of those years, was its chairman. It is because of the insistence on quality by people like Black that we have such fine buildings on our campus today.

Unfortunately, some of the buildings erected at the turn of the century, when John Roemer served as president of Lindenwood and Col. and Mrs. Charles G. Butler were the college's benefactors, are not in such good condition. As I walk by Sibley Hall, a building of stately grandeur with magnificent pillars on its inviting porch, I can't help but be concerned about the building's future. Although considerable renovation on Sibley was completed a few years ago, it houses an electrical system which needs rewiring. We had to cease utilizing Sibley as a residence hall because the electrical circuits are unable to adapt to today's student needs. Hi-fi stereo systems, hair dryers, radios and other gadgets that are a part of modern life, are too much for the old wires in Sibley.

Located next to Sibley is Ayres Hall, originally constructed at the turn of the century and re-named Jubilee Hall in honor of the college's 75th anniversary. I am sad because Ayres is closed. The building remains structurally sound, but the interior must be renovated extensively before it can be used as a residence hall.


Adjacent to Ayres is Butler Hall, a building constructed in 1914 and sadly, in worse repair than Ayres. Although we are still using Butler, it requires a new roof and renovation on all three interior floors.

The remaining buildings constructed during the Roemer years: Roemer Hall, the Margaret Leggat Butler Memorial Library, Niccolls Hall and Irwin Hall are all in sound structural condition, but each needs extensive renovation. In total, we estimate that over \$3 million will be needed in order to restore these buildings to first-class condition, thereby preserving our legacy from the past.

When I look at the buildings constructed during the years of Franc McCluer, I find some fine buildings that are basically in good condition and do not require much renovation. McCluer Hall is a beautiful residence hall and the Howard Young Science Building continues to serve the needs of our science department as

Col. James Gay Butler, a St. Louis industrialist, served on the college's board of directors and is one of the greatest benefactors of Lindenwood College.

During the 1930s and 1940s, Lindenwood College was able to build what many referred to as the "Wellesley of the West" primarily through the generosity of Col. James G. and Margaret Butler. The gifts from the Butler family totaled nearly \$4 million, a sum which is equivalent to more than \$25 million in today's economy.

During the Butlers' lifetime, Ayres, Butler and Niccolls halls were built. Funds from the interest from the Butler estate led to the construction of Roemer and Irwin halls, Butler Memorial Library, the Gables and Eastlick Residence.

We needed Col. James G. and Margaret Butler then. Certainly, we could use them now. Since we started looking for another Col. Butler, we have raised more than \$1 million and concluded the college's first successful fund drive in its 158-year history. In addition to increasing annual alumni giving from five to 25 percent this year, Lindenwood has increased all levels of its support - from faculty and staff to the board of directors and overseers, the St. Charles area community, the metropolitan area and corporations and foundations.

But, we still have much to do - and we need to find new sources of support to do it. We're determined to keep a balanced budget and not to shift funds from our academic and student scholarship programs to special projects, such as badly-needed building renovations and for the expansion of new facilities.

We need this generation's Col. Butler - a person of vision who would like the satisfaction of having a major influence upon our Renaissance Campaign and upon the future development of this historic college as well as to the generations of students who will graduate to serve a society that needs them.

Are you that kind of person - a man or woman willing to make a major and significant investment in Lindenwood College? If so, please call or visit our beautiful and historic campus.

# Funds Sought for KCLC Power Boost

Nearly \$9,000 in cash and contributions were raised this fall for Lindenwood's community radio station, KCLC, and its proposed power increase.

Funding from the one-week campaign will be used to increase power of the 1,500-watt station to 25,740 watts, a proposal approved recently by the Federal Communications Commission (FCC).

Money will be earmarked for the purchase of more modern station equipment, for operating expenses and for the expansion of broadcast facilities, said James A. Wilson, KCLC general manager and a member of the Communications Dept. facul-

Last fall's fund-raising drive was the second of five scheduled during an 18-month period. The first, held last spring, generated nearly \$12,000 in cash and contributions for the radio station.

Installation of new equipment and facilities to boost KCLC's signal to 25,740 watts must be completed by August, 1985, according to the FCC approval. More than \$100,000 will be needed for new equipment such as an antenna, transmitter and transmission lines as well as installation costs, Wilson said.

The increase in power wattage for KCLC, 89.1 MHz on the FM dial, will mean the radio

station can reach a much larger audience and have a greatly-improved signal for listeners in St. Charles and St. Louis counties.

To move closer to its funding goal, KCLC plans its third funding drive this spring.

Founded in 1969, KCLC is a community service of Lindenwood College and is the principal radio station in St. Charles County. It broadcasts educational, cultural and public service programs as well as Associated Press news, local sports events, Christian music and awardwinning bluegrass and jazz music.

As one of Lindenwood College's key instructional tools, KCLC is operated primarily by students and volunteers, reaching an estimated audience of nearly 50,000 listeners in Missouri and Illinois.

## President Receives Appointment

President James I. Spainhower has been appointed by the Missouri Chamber of Commerce and the Missouri State Teachers Association to the newlyformed Missouri Education/Business Partners, a group designed to strengthen business and educational cooperation in Missouri.

According to Missouri Gov. Christopher S. Bond, "The purpose of the partnership program is to encourage leading Missouri educators and business officials to work together to improve the quality of life in our state by strengthening public education."

As the only college president in the state appointed to the group, Spainhower will represent the education factor on the partnership's board of directors.

"Schools and businesses can work together to meet mutual needs and reap mutual benefits," said organizers of the group. "American education needs American business to help educate our youth. American business needs graduates with quality educations and skills. Together, both communities can insure a higher quality of life for us all," they added.

Goals of the Missouri Education/Business Partners parallel closely with Lindenwood College's mission statement that places a key emphasis on the traditional liberal arts program and workservice orientation.

A former state representative and state treasurer in Missouri, Spainhower has a lengthy history in higher education and has served as Lindenwood's 18th president since January, 1983.

## First Annual Report Is Published

For the first time in its history, Lindenwood College recently published *The State of the College*, a 24-page magazine that tells the current status of the institution.

Designed to be an annual publication, the magazine is being distributed to nearly 5,000 contributors who have pledged their support to the college, including key alumni.

Prepared by the college's Public Relations Office and printed by its Publications Dept., the magazine contains a message by President James I. Spainhower and reports from the President's Council, key administrators and faculty representatives.

Included is a report on the college's academic program from James F. Hood, Ph.D., acting Dean of Faculty; a summary of current adult education by Arlene Taich, Ph.D., dean of the Evening College and Lindenwood College for Individualized Education; a report by Jerry Rufkahr, vicepresident of administration, on the college's physical plant, the stadium, conferences and meetings, capital improvements, security and auxiliary services; a report on alumni activities by Esther Fenning, coordinator of alumni activities; an update on the college's public relations, advertising and marketing programs by Randy L. Wallick, director of the Public Relations Office; a detailed report on student recruitment by Miriam King-Watts, dean of admissions; a report on student retention and the Consolidated Advising Program (CAP) by Randi Kapp, director of the college's CAP Center; and an update on college life and student activities by Allen M. Schwab, Ph.D., dean of the Office of College Life.

Much of the editorial contents for *The State of the College* were supplied by Edward D. Watkins, vice-president for institutional development, and Lawrence C. Elam, vice-president of finance.

Watkins' report included a review of the college's development and fund-raising activities, an update on the in-

stitution's 18-month fundraising campaign launched in 1983 and the status of the current Lindenwood Renaissance Campaign that is designed to generate \$10 million within the next three years.

Included in his report were graphs showing the \$800,000 goal for 1984-85, and a comparison of giving of the last two 18-month periods. One of these graphs, which visually show the accomplishments and direction Lindenwood College has taken in recent months, are reproduced in this issue of the *Linden Word*.

Elam's report addressed the college's financial situation, including financial statements that show its percentages of revenue and expenditures, a comparative condensed balance sheet and a comparative statement of operations, as of June 30, 1984, that were approved by the auditing firm of Ernst & Ernst.

#### Carney Scholarship Is Formed

KMOX-AM Radio and CBS, Inc., have made a significant contribution to Lindenwood College for the establishment of a scholarship in memory of Jack Carney, one of the country's best-loved radio personalities.

The scholarship fund will provide tuition reduction to deserving students at both the undergraduate and graduate levels who want to study communications at Lindenwood.

Carney, 52, whose program was aired weekday mornings on KMOX-AM in St. Louis, died November 27 of an apparent heart attack.

He frequently aided communications students and faculty at the college as well as its community radio station, KCLC-FM. Carney recently donated nearly \$10,000 in radio equipment and albums from his private collection to the campus station.

His radio career began in 1951 in Tucumcari, NM, and expanded to radio and television positions at leading stations in Atlanta, Boston, Dallas, Galveston, Milwaukee, New York City and San Francisco. He joined KMOX-AM in 1971, according to Robert F. Hyland, general manager of the station and regional vice-president of CBS, Inc., who announced details of the scholarship.

KMOX and CBS's contribution will be combined with other taxdeductible donations to establish a permanent scholarship fund in

Carney's memory.

The funding is part of a \$500,000 goal Lindenwood College expects to raise during fiscal 1985 as part of its Renaissance

Campaign to secure \$10 million in cash and contributions. The \$500,000 is available for scholar-ship awards to deserving students to help offset the cost of higher education.

Last year, the college awarded nearly \$554,000 in scholarships, consisting of about \$124,000 from endowed sources and \$430,000 in direct support that was generated from tuition donations, and other revenue.

This amount of scholarship awards represented one of the largest in the college's history and was a drastic increase from the \$271,000 in scholarships that was awarded the previous fiscal year. Last year's record amount also was in addition to nearly \$1.5 million Lindenwood provided in

## College Revamps Adult Education

Adult education programs at Lindenwood College recently underwent a dramatic change. Once regarded as separate entities, the adult programs were combined and coordinated in order to serve students better.

According to Arlene Taich, Ph.D., dean of Lindenwood Evening College and the Lindenwood College for Individualized Education (LCIE), the reorganization of the adult programs has prompted more student interest and gained national recognition.

In a recent publication of "The State of the College," Lindenwood's annual report for 1984, Taich cited that "one-quarter of all adult Americans intend to complete schooling beyond high school within the next two years," and that "58 million adults currently are enrolled in formal learning activities."

Because of increased interest in higher education by non-traditional students, Lindenwood College developed the first of its adult programs with the inception of its Evening College in 1972. The college comprises baccalaureate programs specificially designed for adults who are unable to participate in conventional day time programs.

In conjunction with the adult programs offered in Lindenwood's Evening College, Taich said that additional programs are needed to respond to requests by corporate executives for the need to retrain their employees on a periodical basis.

According to reports, U. S. companies invest more than \$30 million annually on the education and development of its workforce. In order to meet growing corporate demands, Lindenwood introduced its Master's of Business Ad-

ministration (MBA) program into its Evening College format.

In 1975, Lindenwood College introduced its LCIE program, thus providing another aspect in its adult educational programs. The LCIE recently received accreditation by the North Central Association as "an innovative model for adult programs of its kinds."

"In the last decade, we (Lindenwood College) have refined and expanded our adult oriented studies to include several baccalaureate and master level graduate programs," Taich said. Lindenwood currently provides yearround educational services at several sites beyond the St. Charles campus. These sites include Clayton, St. Louis-Mansion House, West St. Louis County at Westport, Manchester and St. Charles County at Wentzville. "LCIE has more master's programs than any other adult evening "LCIE has more master's programs that any other adult evening college in the area." -Taich



college in the area," Taich said.

The recent merger of Lindenwood's LCIE and Evening College programs offers many advantages. According to Taich, the joint venture helps to coordinate the college admissions department and helps contain admission costs, provides more availability of programs for students and offers more individualized programs.

"Combining the Evening College and LCIE programs make education individualized for each student according to their academic and personal needs," she added.

# Lindenwood's Community 'Gifts'

As its gift to the St. Charles community, Lindenwood College presented its second Annual Christmas Walk, December 9 from 4-6 p.m.

The two-hour event attracted more than 500 persons and featured a variety of entertainment and festivities. The walk began at Roemer Hall, where guests were greeted by Lindenwood College President James I. Spainhower and student tour guides. After a brief walk to Butler Memorial Library, guests enjoyed the 10-ft. decorated Christmas tree, festive decorations and performances by the Niedner Handbell Choir of Immanuel Lutheran Church, St. Charles.

The walk continued with a visit to the Roemer Memorial Arts Building where performances by recorder artists Georgia O'Brien and Julie Switzel were featured.

Visits to campus residence halls were another featured attraction of this year's walk. Decorated by Lindenwood students, the three dormitories competed for a prize for the "most festive residence hall."

# Students Benefit from Scholarships ...

"I just can't believe it," Tammy L. Edmondson of St. Charles said after learning that she was one of two Lindenwood students to each receive nearly \$5,500 in academic scholarships and computers.

"It was only last night that my boyfriend and I were talking about finances, and I wondered how I was going to afford next semester's tuition and if I may have to drop out and take another part-time job," said the Lindenwood sophomore.

Edmondson along with Susan A. Eppers of Lake St. Louis each received an academic scholarship valued at up to \$2,800 and an Eagle Spirit Portable Computer, valued at nearly \$2,700, in a joint promotion involving the college, KYKY-FM Radio in St. Louis and ComputerLand of St. Louis.

Eppers has an undergraduate degree in communications from the Lindenwood College for Individualized Education (LCIE).

The joint promotion was a first venture for the three contributing sponsors, and one of the first times Lindenwood College has teamed with private enterprise. The college as well as ComputerLand of St. Louis, B&W Distributors and KY98 Radio each said it was well received and a successful promotion.

According to Gary L. Hendren, vice-president of marketing for B&W Distributors and a supplier to ComputerLand of St. Louis, "We're honored to be a part of the John Auble Scholarship program. Our participation is attributed to our admiration of Lindenwood College's progressive philosophy of quality education, community involvement and the ability to recognize the individual needs of its students," he said.



## Joint LCIE, AT&T Program

Primarily designed for working adults, the LCIE is one component of Lindenwood College that offers individualized, interdisciplinary studies in a vast number of programs leading to undergraduate and graduate degrees.

Playing a significant part in the decision by AT&T to select Lindenwood was the recognition recently given to the LCIE by the North Central Association of Colleges & Schools (NCACS), the official accrediting body for colleges and universities in the United States.

In a 34-page accrediting report issued earlier this year by an NCACS evaluation team, the association said, "... the work in LCIE can serve as a model for this kind of alternative education program for other institutions of higher education."

The report also stated, "It is very clear that everyone ... who is connected with this (LCIE) program is committed to making it a quality educational endeavor that meets the needs of its students in an effective manner.

"In addition to its uniqueness of delivery and format, LCIE also has developed some unique majors, notably art therapy and valuation sciences," the NCACS said.

According to Taich, "AT&T Information Systems recognized the LCIE's format and method of delivery and also noted that undergraduate and

graduate degrees can be tailored to the individual needs of its employees, such as in data processing."

Currently, nearly 100 AT&T Information Systems employees have enrolled in the LCIE program, which will begin January 8. They will join nearly 315 other full-time LCIE students to receive instruction provided by faculty advisers and adjunct professors on the LCIE faculty.

In addition to LCIE instruction, employees also can receive on-site individual and group career planning services provided by Lindenwood College's Consolidated Advising Program Center. Services will include turorial academic assistance, career planning and personal development "to provide a comprehensive, full-time program," Taich said.

"AT&T Information Systems evaluated several colleges and universities in the area and then selected the LCIE because of its method of delivery and its ability to tailor a program specifically to meet the needs of its employees," Taich said.

\$3.8 million of the \$10 million goal.

Broken down, the \$800,000 will consist of \$360,000 from corporations and foundations, \$140,000 from alumni, \$80,000 from the St. Charles community, \$76,000 from the Lindenwood College Board of Directors and Board of Overseers, \$15,000 from faculty and staff contributions and \$129,000 from other sources.

Much of this funding will be earmarked for scholarship awards to deserving students as a means of strengthening and expanding the college's traditional-age residential population.

Upon successful completions of the \$800,000 goal for three years, totaling \$2.4 million, and the \$3 million goal for building renovation and restoration, Lindenwood will

announce plans for securing funds for construction of its \$5 million Renaissance Cultural Center, the final phase of the Renaissance Campaign, Watkins said.

financial aid assistance to its
students.

According to Edward D. Watkins, vice-president for institutional development, Lindenwood is increasing its amount of available scholarships as a means of strengthening its residential population, which last year resulted in a nearly 95 percent increase in the number of students living on campus.

In addition, he said, the college has increased its average scholarship award from \$200 to \$1,200 per student, an amount that makes Lindenwood highly competitive among other private colleges and universities in the metropolitan area.

Tax-deductible donations of \$500 or more can be established in memory or recognition of a person and earmarked to the \$500,000 funding goal as part of the Renaissance Campaign, Walkins said.

According to James D. Thompson, major funds coordinator for the college, "We will be telephoning Lindenwood alumni in the northern portion of the country as well as those in the south who we were unable to reach during Phase 1. We hope to reach an additional 3,000 alumni during the four-week period," he said.

A goal of \$100,000 in pledges and contributions from alumni is planned during the two-phase phone-a-thon.

"We have to maintain our recently-increased percentage of alumni contributions in order to qualify for multi-year corporate donations," said Thompson, a 1980 alumnus. "A great concensus of spirit is building to support our Renaissance Campaign, and each one of us will need to pledge whatever we can to

make our renaissance a reality," he added. Phone-a-thon efforts will be

coordinated by Thompson while volunteer activities will be directed by Esther Fenning, a 1977 alumna and director of alumni activities for Lindenwood. Chairmen of this year's event are Jeri Herhold Stine of Chesterfield, a 1970 alumna, and Ann Hodges Pal of St. Charles, a 1965 alumna.

More than 5,000 alumni were contacted last year in the college's most successful telephone fund-raising event in its history. In addition to raising \$100,000 in cash and contributions from alumni throughout the United States, Lindenwood managed to increase its level of alumni contributions from five to 25 percent, a remarkable achievement in a short period of time, Thompson said.
