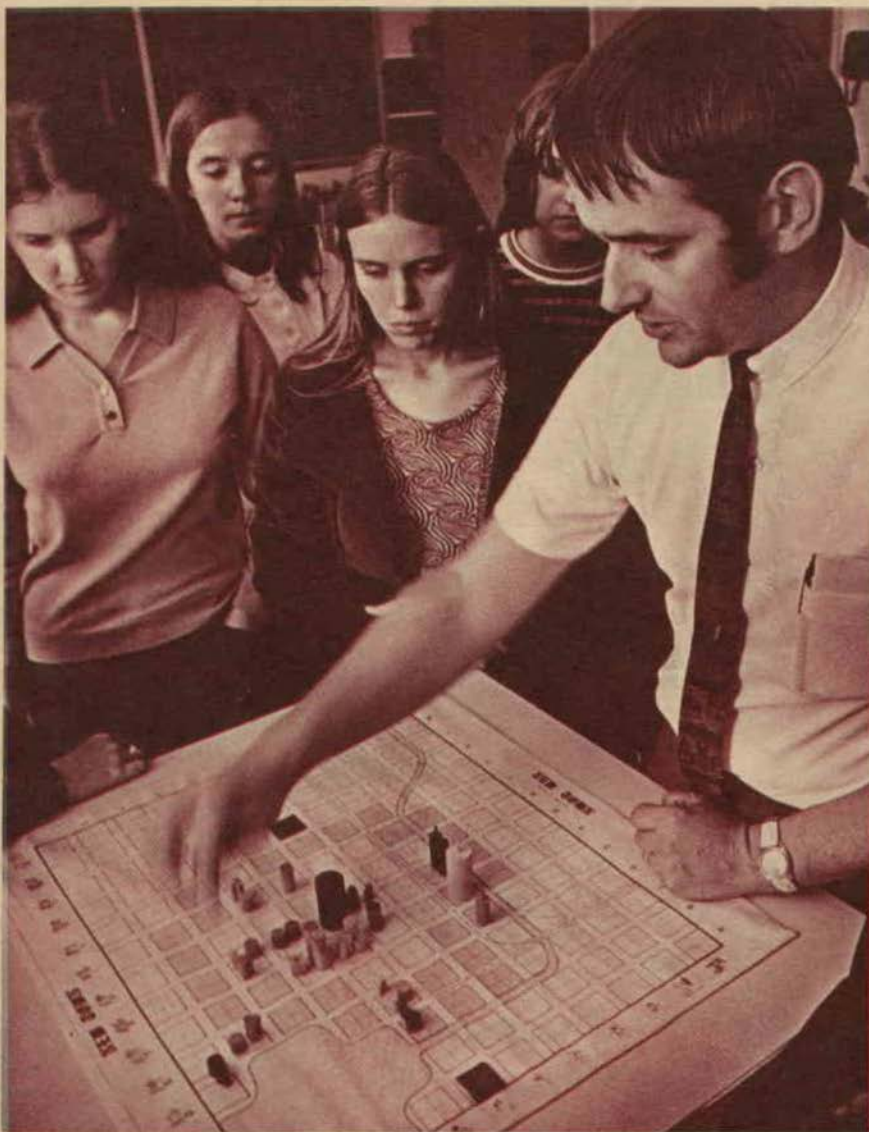

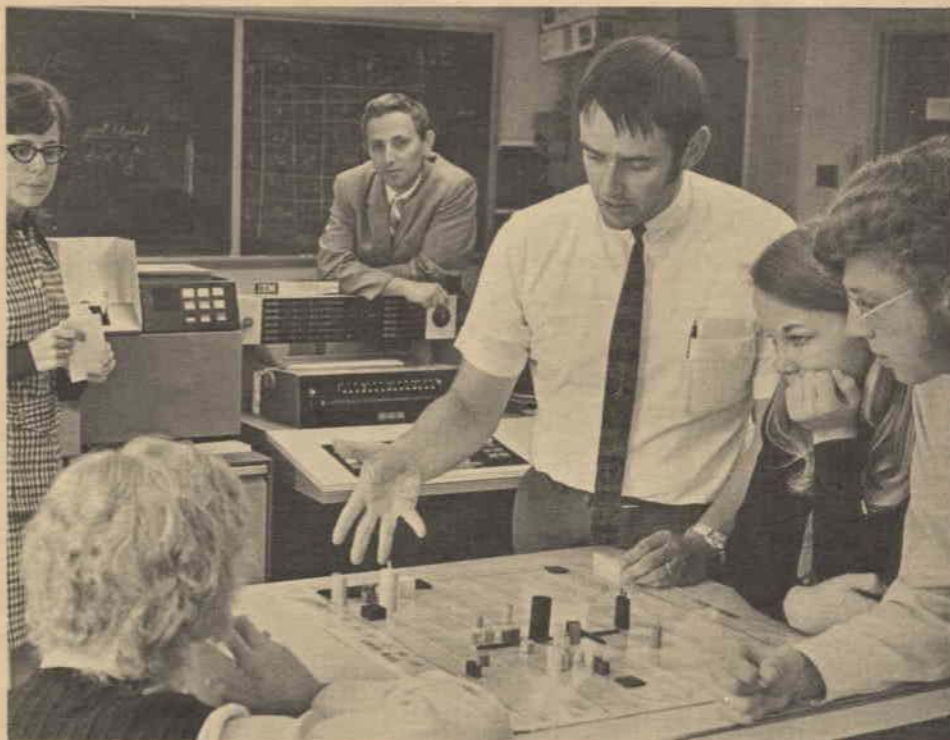
## *A game freshmen play*

A friendly alliance of man and machine marks an enterprising venture in this year's Lindenwood Common Course, interdisciplinary program required of all freshmen.

Students in the Social Science division of the Common are learning, by playing a game, how to develop a modern city. And they're using Lindenwood's new IBM 1130 Computer to provide quick, accurate calculations to help solve problems of urban planning—at least on the playing board.

Name of the game is "New Town," an urban game originated at Cornell University which simulates the socio-economic realities of building a city. The computerized program developed at Lindenwood is the creation of Dr. Aaron Konstam, Director of the Computer Center, and Miss Judy Johnston, a senior mathematics major from St. Charles, Mo. Their adaptation is being played this year in the Computer Center in Young Hall by teams of Freshman Common students directed by Professor John N. Bartholomew, chairman of the Sociology Department.

The teams represent the public and private sectors which develop a modern city. The game commences with a throw of the dice, simulating the vagaries of life. Teams then bid competitively on industrial and retail development, or build residences. Decisions on investments, developments, sales, loans, taxes and employment, during ten or more rounds of play, determine the outcome of the game. The team which succeeds in creating the best balanced development wins. Losers may end up bankrupt. "New Town" is a team version of

Monopoly with more sophisticated rules," Professor Bartholomew says.

In arriving at the decisions in the development of New Town, Lindenwood students not only learn the intricacies of urban planning but gain perception into the reasons for their actions. They realize why they have invested as they did, what effect their decisions will have on the total urban complex, and, most importantly, what value systems

they have assumed in structuring a city in which human beings must live.

The crystallization of such insights is facilitated by the IBM 1130 Computer. By calculating and swiftly delivering precise data on investment, taxes, profits, losses—all financial aspects of development, the computer frees time from mathematical drudgery for thought, analysis and moral judgment.



# Colleges accredited for next decade

Accreditation of the academic programs for The Lindenwood Colleges for the next ten years has been granted by the North Central Association of Colleges and Secondary Schools, according to an announcement released by John Anthony Brown, president of the colleges. Accreditation of Lindenwood College for Women and Lindenwood College II was lodged in a third corporation, chartered earlier this year as "The Lindenwood Colleges." The two colleges share faculty and facilities on the campus of the parent college which was founded in St. Charles by George and Mary Sibley in 1827. Lindenwood began as a girls' academy and grew into a four-year senior college in 1918. In 1969, a coordinate men's college was founded at Lindenwood.

A coordinating board of control has been established for the cluster colleges with three representatives from the boards of each of the participating institutions. Serving on the coordinating board are, from Lindenwood College: John M. Black, St. Louis, Mo.; Russell J. Crider, M.D., St. Charles, Mo.; and Armand C. Stalnaker, Ph.D., St. Louis, Mo. From Lindenwood College II, George W. Brown, St. Louis, Mo.; Walter L. Metcalfe, Jr., St. Louis, Mo.; and Carol A. Mundt, St. Louis, Mo.

John M. Black, vice president of Fruco and Associates, Inc. of St. Louis, Mo., was elected first Chairman of the Board at an organizational meeting this month.

## Enrollment grows

Enrollment has increased this year at The Lindenwood Colleges. Total enrollment for the two colleges is now 693 students, up 33 over last year.

The men's college, which opened in the fall of 1969 with a total of 118, enrolled 182 students this September. Current enrollment in the women's college is 511.

A total of 306 persons, the largest summer enrollment in the history of the College, registered for classes and workshops during the 1970 summer session.

Of the total, 95 were Lindenwood students, 40 were students from other colleges, and five were high school students banking credit.

Of the 156 school teachers enrolled 88 were from St. Louis County, 30 from St. Charles City, 21 from St. Charles County and 17 from as far away from the metropolitan area as Oregon.

Dr. John A. Bornmann, professor of chemistry and chairman of the Division of National Sciences and Mathematics, conducted research in aerospace medicine this summer at the NASA Manned Spacecraft Center at Houston, Texas.

## New members join faculty as retirees named emeritus

Seven new full-time faculty members joined the Lindenwood teaching staff this fall.

Michael Arthur Allen, named assistant professor of sociology, holds the Bachelor of Science and the Master of Science from Illinois State University. He is a doctoral candidate at Southern Illinois University, where he worked as a faculty assistant, instructor and pre-doctoral assistant.

Dr. Daryl Anderson, newly appointed assistant professor of biology, earned her bachelor's degree from Western Michigan University and the Ph.D. from Washington University. Last year she was a post-doctoral fellow at Washington University's Center for the Natural Systems, headed by ecologist Barry Commoner. Dr. Anderson has published articles in the *American Journal of Botany* and the *Journal of Phycology*.

Joining the Education

Banks, associate professor of education; Dr. C. Eugene Conover, professor and chairman of the Department of Religion and Philosophy; Dr. Marion Dawson Rechtern, professor of biological science; and Miss Dorothy Ross, professor and chairman of the Department of Physical Education.

Dr. Rechtern, longest in service to the college, taught biology at the College since 1936. She was advisor to Alpha Lambda Delta, freshman women's honorary and to the student nurses since 1956. She also sponsored the Triangle Club, a science honorary. A Ph.D. graduate of Cornell University, she has published articles in the *American Journal of Botany* and in *Science*.

Professor Ross, second in years of service, came to Lindenwood 24 years ago as chairman of the Physical Education Department. She initiated courses in camp counseling and studies in body mechanics. Under her chairmanship the department expanded to offer extramural programs in basketball, field hockey, tennis, and volleyball, and intermural programs in softball, hockey, volleyball and basketball. Types of course offerings were expanded to include swimming, water safety, gymnastics, and equitation. Miss Ross is an M.A. graduate of Colorado State College of Education.

Dr. Conover joined the Lindenwood faculty in 1948, serving for twenty-two years as professor of philosophy and chairman of the Department of Philosophy and Religion. He was also Dean of the Chapel for eight years and chairman of the Division
