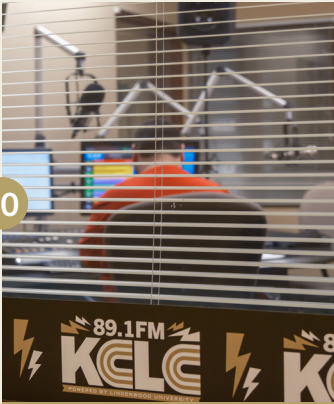

If you haven't been to campus recently, I invite you to visit us here in St. Charles! Incredible things happen daily at Lindenwood, and I look forward to seeing you soon.



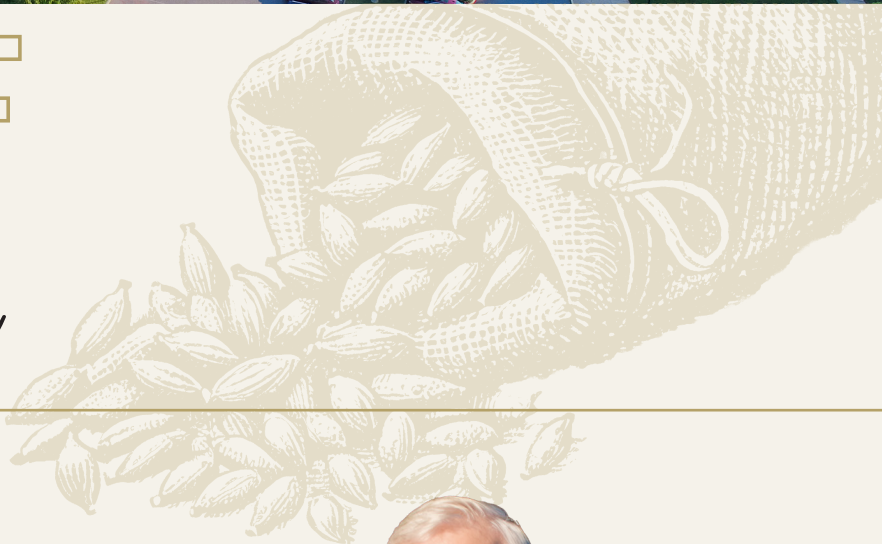

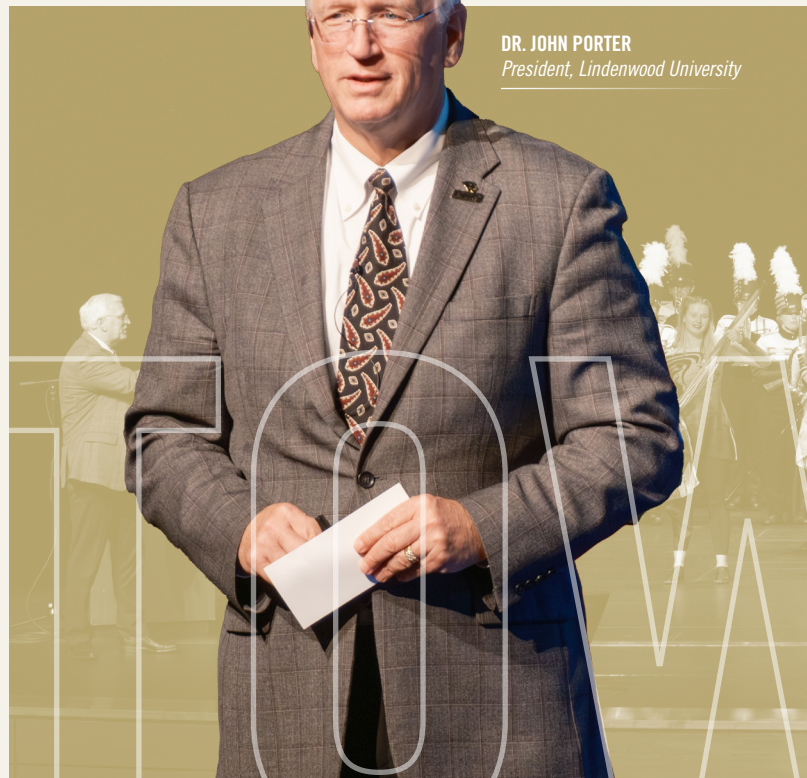

In the pursuit of continuous improvement and the alignment of its core values, Lindenwood University embarked on a transformative journey. This journey involved redefining the core values and recognition of exceptional individuals who exemplify these principles. Led by

a dedicated team from the Human Resources division and inspired by the Barrett Model and the Organizational Culture Assessment Instrument (OCAI), Lindenwood's new values now reflect a profound commitment to its students, fostering a culture that not only benefits the institution but also deeply resonates with its entire community.

As an academic institution steeped in tradition and with a close-knit community, Lindenwood recognized the need for a more comprehensive and inclusive set of values that would resonate with its diverse stakeholders. To address this

need, Drs. Deb Ayres, Amanda Price, and Brittany Brown, key leaders within the Human Resources division, consulted with the University’s Q2 Champions, a group of comprised of both faculty and staff known for their commitment to serving, students, fellow colleagues, and the broader community. Little did anyone expect that this endeavor would evolve into a journey of profound self-discovery and cultural transformation.

Several Q2 Champions from each division and college stepped forward to assist in re-energizing and recommitting the university community to the core values. These champions took on a new identity as VIP (Values in Practice) leads, which recognized their crucial role in this endeavor. Their dedication to fostering a culture of excellence made them a natural fit for this strategic initiative.

In the pursuit of a more values-driven and authentic culture, Lindenwood developed a robust framework leveraging the Barrett Model and the OCAI to delve into the intricate relationships between culture, values, and behaviors, guiding them through a journey of self-discovery and transformation.

The HR team, in tandem with the VIP leads, embarked on a comprehensive analysis reviewing the OCAI assessment results, first discovering the different facets of the University’s culture, then diving into the behaviors promoting the culture, to get to the core values instilled in all University employees.

This work involved delving into the intricate dynamics of their organization, uncovering both strengths and areas for improvement. The transformational journey demanded countless hours of thoughtful and rigorous discussion—a process that required unwavering commitment from the VIPs and HR leaders.

Collaborating with the University Cabinet, the VIPs played an instrumental role in reshaping Lindenwood’s values. This partnership was critical in developing a set of values that would resonate deeply within the university community and extend its influence beyond its borders. The resulting values now reflect the very essence of Lindenwood’s commitment to its students, faculty and staff, and the community it serves.

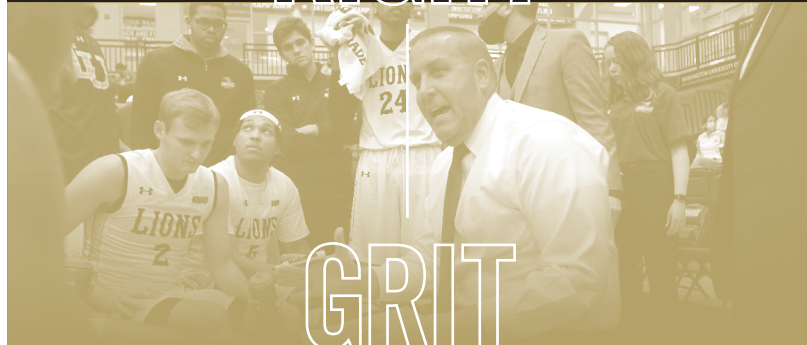

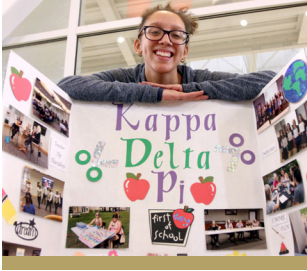

GREEK LIFE CONTINUES TO GROW

For the first time in five years, Lindenwood University fraternities and sororities saw an increase in recruitment. Collectively, Lindenwood Greek life added more than 100 new members—a 44% increase from 2022. Lindenwood fraternities and sororities ended the 2022–23 academic year by raising more than \$21,000 for their philanthropic partners and completing more than 1,400 hours of community service.



STUDENT LEADERSHIP INSTITUTE GETS GOING

Lindenwood University's annual Student Leadership Institute was held August 26 for student leaders to gain information regarding policies and procedures for running an organization, budgeting planning events, etc. The Student Leadership Institute provided a keynote session delivered by Dr. Gary Stocker, along with various breakout sessions covering topics, such as “How to Lead When You’re Not in Charge” by Dr. Julie Turner, “Event Planning 101” by Sam Sorrick, “Recruiting and Retaining Members” by Melissa Bidinger, “Pop Pop Goes the Spinning Top: Conflict Resolution,” by Dana Moore, and “Leadership (Taylor’s Version),” by Madison Shaw.



NEW DINING OPTIONS UNVEILED

In Fall 2023, Lindenwood University unveiled new dining options across campus. Lindenwood partnered with Sodexo, a multinational food service and management company, to provide dining, catering, and other services. In January, Pizza Hut will join the retail operations in Spellmann Center and an autonomous marketplace will be installed in Harmon Hall. Additionally, the dining hall in Evans Commons underwent a makeover with new furniture. The partnership with Lindenwood and Sodexo is a milestone in putting students first and enhancing the student experience.

The College of Arts and Humanities hosted KCLC's 75th anniversary celebration November 9 in Spellmann Center. Former KMOV news anchor Robin Smith was the keynote speaker. 2023 HALL OF FAME INDUCTEES

CORY ARENTSEN | MEN'S BASKETBALL |

2014–16 During his two-year career as a Lion, Cory Arentsen solidified his legacy as one of the best shooters in program history, averaging 19.8 points per game, while knocking down a staggering 42.4% of his attempts from 3-point range. As a senior in 2015–16, Arentsen set a school record by averaging 24.2 points a game and led the team in assists and steals. During his senior campaign, Arentsen was recognized as a first-team all-MIAA and NABC second-team all-region selection.

DEDE DORSEY | FOOTBALL | 2004–05

DeDe Dorsey was tabbed as a first-team NAIA All-American at defensive back as a junior in 2004 after he scored three defensive touchdowns for the Lindenwood football team. Dorsey also contributed on the offensive side of the ball in 2004 rushing for 842 yards and nine touchdowns. As a senior in 2005, Dorsey became the first Lion to earn AFCA All-American honors, rushing for 1,600 yards and 16 touchdowns. Dorsey became the first player in NAIA history to be named as a first-team All-American on defense and offense in successive seasons.

MIKE FAILONI | BASEBALL | 2012–14

Mike Failoni compiled one of the greatest single seasons in Lindenwood baseball history during his junior campaign in 2013. As a junior, Failoni was a unanimous first-team All-MIAA selection, first team all-region, and ABCA/Rawlings All-American after breaking the MIAA single-season batting average record by hitting .500. Failoni led the MIAA in four other batting categories, including on-base percentage, hits, doubles, and total bases. At the end of his career, Failoni was the program's all-time leader in batting average and OPS.

AMANDA GREENE | WOMEN'S BOWLING |

2009–13 Amanda Greene spent four years competing for the Lindenwood bowling program and finished her career as one of the most decorated and accomplished bowlers in program history. Greene was a NCBCA first-team All-American three times throughout her time as a Lion, earning the distinction in 2011, '12, and '13. Greene became the program's first ever All-American. From 2011–13, Greene amassed four singles titles, seven second-place singles finishes, and 23 top-10 singles finishes.

ALECIA MCGILLIVRAY | WOMEN'S SWIMMING & DIVING | 2013–17

Alecia McGillivray became Lindenwood's first individual NCAA National Champion in any sport after winning the 1,000-meter freestyle and 1,650 free titles at the 2015 National Championships. McGillivray concluded her Lindenwood career as the record holder in seven different events, two of which remain today. McGillivray earned All-American honors in 10 different events over the course of her four-year Lindenwood career.

DON ADAMS JR. | MERITORIOUS SERVICE AWARD

Don Adams Jr. has spent nearly two decades covering athletic events at Lindenwood as the primary photographer for the Lions. Over the course of his career, Adams Jr. has attended and covered an unmatched amount of Lindenwood events and provided imagery for some of the most memorable moments in Lindenwood's illustrious athletic history. Adams Jr. remains passionate about serving Lindenwood's coaches, staff, and, most importantly, the thousands of student-athletes he has covered during his time.

DR. CHARLES TSAI CONTINUES SUPPORTING LINDENWOOD THROUGH GIVING BACK

Dr. Charles Tsai idolizes Master Chu Chen Nan, a Lindenwood University alumnus and famous artist from Taiwan.

So much so that Tsai developed a relationship with Lindenwood through Chen Nan's artwork.

In July, Chen Nan donated two of his calligraphic pieces of artwork to the French government as part of an effort to promote cultural exchanges between the two countries.

"Master Chu is very famous for his calligraphy in Taiwan, and to see an artist and advocate of my nation of this stature inspires me to maintain good relations with the University," Tsai said. "Additionally, Lindenwood just began to start an exchange program with a Taiwanese university, and I want to be a strong supporter of this program."

Lindenwood and Tsai have developed a partnership with the National Taiwan University of Arts through an Academic Exchange Agreement. Under the agreement, two students from Taiwan will come to Lindenwood and two students from Lindenwood will go to Taiwan. Additionally, art exhibitions, and feature exchange activities will be established upon discussion between both universities. These exchanges will help bring



cultural awareness to students, so they are more interested in studying abroad for a semester or an entire academic year.

Tsai comes from a family of physicians and graduated from medical school in Taiwan. He later studied pathology to learn more about diseases and cures. Eventually, Tsai took a job at St. Louis University School of Medicine, where he served on the pathology faculty for 16 years beginning in 1972.

In 1990, Tsai joined the largest private medical practice group in the St. Louis area, WCP Laboratory, as a specialist and partner. There, Tsai helped establish advanced diagnostic technologies in the fields of cancer and immunology. After 25 years of practice, Tsai retired from the medical field and focused his attention and time to promoting, understanding, and advancing the cultures, arts, and politics of the Taiwanese American community in both the United States and Taiwan.

“After being connected back to the University by the Lindenwood Advancement team and the College of Arts and Humanities, I can now say how much I love being involved with the University and visiting the campus,” Tsai said. “I love seeing where the University is heading in the future and want to continue to support its needs.”

Throughout their friendship, Tsai bought pieces of artwork from Chen Nan for his own catalogue. Over the years, Tsai has donated numerous pieces to Lindenwood.



I am truly grateful for Lindenwood University’s decision to accept these pieces of work from an alumnus,” Tsai said. “Master Chu is not just an esteemed figure in the world of arts but also a dear friend of mine. The fact that Lindenwood is dedicated to appreciating his legacy over the years means a great deal to me. MICHAEL WOODS GIVES BACK THROUGH PHILANTHROPY ORGANIZATION

Michael Woods and Neal Richardson first met at Transformation Christian Church, off Page Boulevard in St. Louis, in the mid-2000s.

The two stayed in touch and, eventually, forged a lifelong friendship. That bond they shared led them to a life-changing experience later on. In 2016, the two friends co-founded Dream Builders 4 Equity, a non-profit 501c, that works to develop economically sustainable and socially engaged communities by growing equity for youth, businesses, residents, and real estate.

Through this philanthropy, Dream Builders 4 Equity is attacking vacant homes in North St. Louis city by employing local minority youth (ages 18–24) and contractors to do large-scale, community-led development projects—putting money and equity back in the pockets of people within the community

while creating workforce development and scaling minority-owned contracting businesses

The company’s vision is a “world in which all communities have the courage to dream, the skills to build, and the resources to own their future.”

“Their efforts can turn into money,” said Woods, a 2014 Lindenwood University alumnus and is now the president/CEO of the company. “It’s proving to them ownership is a somewhat a key to freedom.”

Minority youth working within the program get hands-on experience that, Woods says, will help them in the future. Not only are they making a difference in their respective communities, but they are getting paid for their work, while gaining exposure to real estate from the legal side, the agent side, banking principles, insight from investors, as well as construction experience.

“They’re learning and being exposed to those things,” Woods said.

Moreover, profits from each house that is sold or restored go back to Woods’ employees, who then can use those funds for post-secondary education.

Currently, Dream Builders 4 Equity is working on a 50-property development project that includes rehabbing and building homes for seniors..

Woods and his team then compile all of the journals and craft them into a book. Each employee gets their own copy, and then there is a book signing they can attend.

“Every dollar that comes through that door goes to our students,” Woods said.

Additionally, Dream Builders 4 Equity also has a retail store, where it sells clothes, all types of apparel, as well as books. The store also houses a screen-printing machine and an art studio, where people can create their own projects and then sell them.

Woods’ company also employs fun and games. Dream Builders 4 Equity runs a student-led chess program. High school—and college-aged students visit six different area elementary schools and teach kids how to play chess.

Woods, who graduated with a BA in psychology, credits his time at Lindenwood to helping him get to where he is today.

“The biggest thing I took away from Lindenwood is the tenacity it takes to be able to complete something and seeing things through,” he said. “At the time I was attending LU, I was working a full-time job, just purchased my own property and just published my first book. ... I loved that it was testing my mental fortitude. ... Definitely being a psychology major, but understanding human behavior is so important in the work that I do.”

The most important thing to Woods is making an impact on kids’ lives, as well as watching them evolve—personally and professionally.
