"And Now We Are Two"

"If we are going to keep pace with today's world, and have some voice in what happens to that world, we must be prepared for change. Change although inevitable, can be planned rationally for the improvement of mankind. We must face the future deliberately and courageously as educated men and women using all the knowledge that we have acquired to change those things which need changing and preserve that which is worthwhile."

On January 6, 1969, the Board of Directors of Lindenwood College unanimously decided to cooperate with a new college to be established by a group of incorporators in ways that would relate the new institution very closely with Lindenwood College.

The decision was a commitment that ended many, many years of discussion and debate. Long ago, land had been acquired with the thought that a men's college might be enticed to accept it. Dr. McCluer had held conversations with St. John's College in Annapolis, Maryland, with the thought that they might wish to establish a second institution in relationship to Lindenwood. They did not respond to the overture and went further west where they established a second college at Santa Fe, New Mexico.

What were the major factors that were back of this extremely important decision for Lindenwood College? The years of discussion had come to a close with two years of intensive involvement of faculty, students, and alumnae. Most of the faculty had written careful statements in response to the President's invitation, giving their views on the future of Lindenwood College, and the development of a men's college, or the admission of men to Lindenwood. Many students had responded to his invitation to do the same thing. The Alumnae Council had had several long discussions with the President about the issue and had given their views for consideration. The administration had been involved in careful planning and projections, and had secured information from many other colleges which were going through the same kind of self-study.

The planning activity of the past two years can be best described if we look at it from the faculty point of view, if we review it as students saw it, and if we consider it from the point of view of the problems raised by Lindenwood College's commitment to the separate education of women for the administration.

Faculty Discussion and Unanimity

The College has published the very careful report of faculty planning prepared by members of the faculty and unanimously endorsed by the faculty at a meeting on December 11, 1968. The unanimity of the faculty resulted from several basic considerations:

(1) The nature of classroom activity is changing in liberal arts colleges. The day when almost all work was pure lecture, with the expert passing what he knew on to eager students, has been affected by the great contemporary emphasis on discussion and independent study. When the teaching technique is almost exclusively lecture, the problem for the students is to take notes accurately and return to the lecturer on considered response to what he has presented. When there is great emphasis on independent study and discussion, a class comprised of all women or all men, whether the subject is the field of International Affairs, Sociology or

Psychology, Literature, Religion or Philosophy, seems to be handicapped by the absence of the point of view that is to be found among the males not present at a school like Lindenwood, or as the Princeton study of the same problem indicated, the females not present in the classes at Princeton.

(2) The faculty was additionally influenced by the failure of our women's college, and many other colleges for women, to be really different from coeducational institutions. Our curriculum, our teaching methods, even our goals and objectives as a college were not greatly dissimilar from those of coeducational institutions. This being the case, it seemed to many faculty that our restriction of enrollment to women was for social, rather than academic reasons, and was not justified on an academic basis.

(3) The faculty was naturally influenced by the basic facts revealed in our intensive study of students and their own attitudes. The faculty quickly learned that only a handful of the students graduating at the upper levels of their high school classes would consider either a men's or a women's college. The Princeton Report, which indicated that an institution as prestigious and well established as Princeton was losing many good students because they would not consider going to a sexually segregated college, had great impact on us. The fact that high school counselor after high school counselor responded to our admissions representatives with comments to the effect that our program was fine, but not many of their students were interested in a women's college, was well known to the faculty. Our faculty became well acquainted with studies made at other women's institutions, particularly the Vassar materials. All of it indicated that the sexually segregated college was having increasing difficulty attracting top students.

(4) The faculty became aware that men's colleges across the country were competing with us by opening their doors to women students in a rather dramatic way. Kenyon and Hamilton colleges, very fine men's colleges with excellent programs and national prestige, had started coordinate women's colleges. Princeton announced that it was going to begin the admission of women; Yale did the same thing in its own way. The reasons given by these institutions were reasons that seemed to apply directly to us. They wished to have both the male and female points of view in the classroom; they found it difficult to academically justify sexual segregation; they all recog-

nized increasing difficulties in attracting students because of their sexual segregation.

(5) Our faculty was fully aware of the social predicament in which many of our students at Lindenwood found themselves. So-called mixers, which once seemed to work effectively, no longer served the purpose of bringing young men of the kind that we wanted in sufficient number to our campus. Indeed, students had discussed in the months just prior to our decision on several occasions the discontinuance of mixers because they did not seem to be working. Vast increase in the enrollment of women at both St. Louis and Washington universities had made it less likely that young men from those institutions would come to Lindenwood for female companionship.

(6) Finally, the faculty became clearly aware that the new curriculum, new emphasis in the social sciences, our new and very flexible calendar, and new emphasis on independent study at Lindenwood, were all leading to a new kind of academic life here which was very attractive to young men. In the midst of faculty consideration of the basic issues they became convinced that our program would attract highly qualified male students, and that outstanding male students in a chain reaction would attract more highly qualified female students.

Thus, after committee meetings, and discussions, sometimes formal and more frequently informal, the faculty in several key votes indicated unanimously that action which would bring men to the campus should be taken. A minority favored simple coeducation; an overwhelming majority favored the development of a coordinate college with its own emphasis and program.

Student Discussion and Ambiguity

Student discussions of the problem were seriously affected by several very clear problems. The students at Lindenwood had chosen a woman's college; thus, their discussion was discussion by young women who had evidenced their preference for a woman's college by coming here, and any student discussion was marked by the fact that those who left, after they found they did not wish to be in a sexually segregated institution, were, of course, not participating.

When students were given access to the basic facts about enrollment and the retention of students at Lindenwood, they were quite startled to learn that of almost 3,000 transcripts sent to other institutions by students who wished to transfer from Lindenwood over the past fifteen years only fifty or so had been sent to women's colleges. The deeper students dug into the story of those who left Lindenwood to go to another institution the more convinced they became that many students, without openly declaring their feelings, preferred to go to a coeducational institution. As the students often put it, "Many of us come to Lindenwood because she is a woman's college, and leave a year or two later for the same reason."

Students were deeply concerned about the possibility that they would lose the opportunity a woman's college gives them to gain leadership experience in various

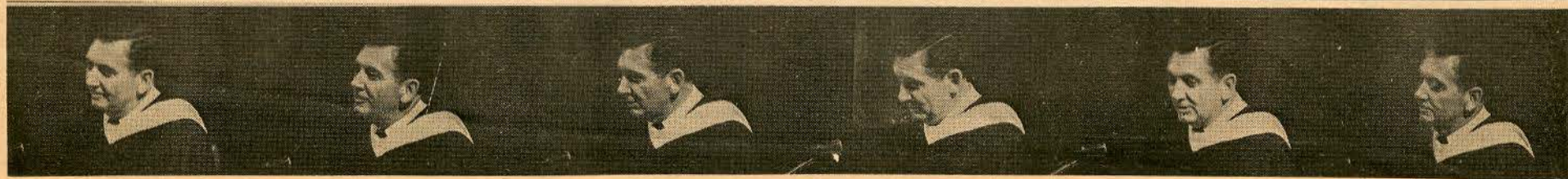
student activities. They learned that at co-educational institutions the overwhelming majority of presidents of all student organizations are men, while the overwhelming majority of secretaries of such organizations are women. But at Lindenwood they had experience as presidents, as leaders, and they worried about what would happen if men came into the environment. Would they not take away the newspaper and the yearbook and dominate the student government and control the International Relations Club? In ways which were very objective and very fair, students discussed the difficulties they were having on the campus maintaining a vital activities program without men. The newspaper had been barely kept alive over past years. The student government had had a serious struggle to be effective in spite of very hard work on the part of a relatively small number of students.

As the students mulled over the many issues involved, there were shifts of opinions, there was much honest confusion, there was a great deal of nostalgia about the past, but a kind of consensus eventually emerged. When the student report was presented at a convocation by the Chairman of the Student Planning Group, Miss Victoria Lowe, of the Class of '69, discussion was entirely about ways in which Lindenwood traditions could be preserved, ways in which Lindenwood's concern for the education of women could be maintained, ways in which Lindenwood College for Women could be made a stronger institution by relating it to a new men's college. While a significant group of faculty, perhaps as much as twenty to twenty-five percent, favored simple coeducation, in my judgment the Lindenwood student body was overwhelmingly opposed to coeducation as the answer, and accepted the concept of a coordinate college as the only approach that they would be willing to seriously consider.

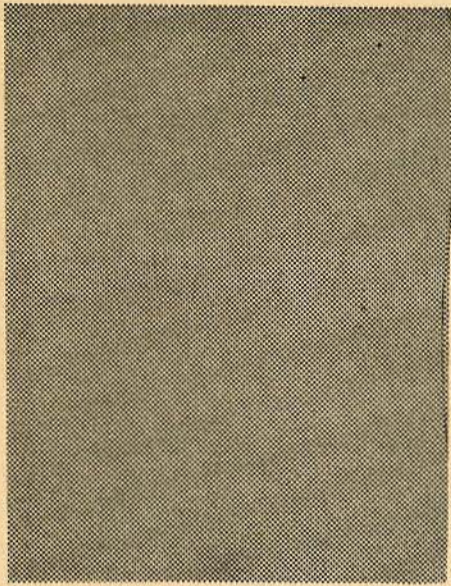

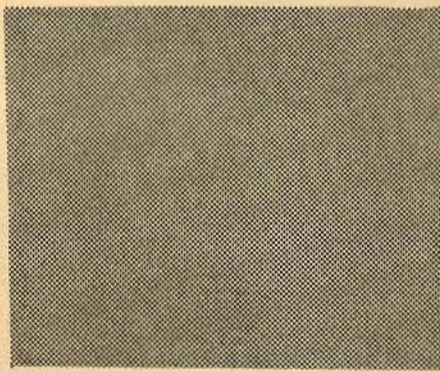

Frankly, as President of the College, it was the student report and the discussions I had with students that convinced me that the development of a second college, with all the complexities and difficulties attendant to that approach, was a better one than the simpler, more direct solution of coeducation. It was the students who gave me the vision of a woman's college maintaining its identity and particularly its concern for the role of women in our society and an education appropriate to that role that caused me to eventually endorse enthusiastically the concept of a coordinate college rather than coeducation.

The Administration and the Cost of Indecision

In a very literal sense, the administration talked while Lindenwood College's "image" burned. We had a fine reputation as a woman's college; we had a loyal clientele, who had turned to us as a woman's college over the years. Nevertheless, it was widely known that we were talking about the admission of men. In my inaugural speech, I had suggested that because of superb facilities in science we ought to begin admitting men in that field on a trial basis as quickly as possible. With the generous help of a Director of the College, Mrs. James A. Reed, (Neil Quinlan '09) we began the development of a very strong program in mathematics with the thought that it would appeal to men and that it would be a logical extension of our work in mathematics which had marked us for many years. We had admitted fifteen men in the fall of 1968 to help us consider the issues and to assist in the planning of a new college if we were to have one. Thus, we were no longer a deeply committed woman's college in the eyes of many. But for those who were opposed to a woman's college, we had far too few men. The uncertainty as to whether we would become coeducational or develop a coordinate school made it impossible for people to be really sure whether they agreed with us or not. The administration became acutely aware that it was very difficult to present Lindenwood to prospective students and to prospective donors, whether private individuals or corporations or foundations, until we had resolved the ambiguity which is part of the decision-making process.

In the fall of 1968, as President, I had become convinced that I had to bring the discussion and debate to the point of decision. It had become too well known that we were about to do something; we had to let the public know what it was going to be. We moved from the phase in which we encouraged everyone to talk, read, discuss, debate, to a point at which we began to set deadlines for a final decision.

Studies made by the administration of the resources available at Lindenwood College began to attract our concentrated attention. To our delight, we found that the terrace levels of several of our residence halls could be developed at low cost in ways that would provide additional student housing. A study of classroom utilization indicated that we could enlarge the size of the student body rather dramatically before we had to build new classroom space, particularly once our new fine arts building was completed. The library expansion had been conceived for a student body much larger than Lindenwood would be likely to have if it maintained its role as a woman's college. The new science building with its fine laboratory space, and our new computer center provided facilities for a great many additional students. It became very clear to us that, in a physical sense, facilities, with the exception of recreation and health and physical education facilities, necessary to introduce a significant group of men into the community here were already available. Thus, instead of building a new college, which is what we had always assumed we would have to do, the possibility of leasing and sharing facilities already constructed, and not fully used, arose as something that would be highly desirable, and certainly advantageous economically.

Then we began to study faculty resources. We were functioning at a faculty-student ratio of one faculty person for each nine students. We had many, many classes with less than ten students. Indeed, a majority of the classes in the upper division of the college were very small. We had adopted a policy of strengthening departments in which we permitted students to major by adding additional faculty in recent years. Thus, there were new strengths in Psychology and Sociology and several other areas. Intensive study indicated that as many as three hundred men could be introduced into the Lindenwood community without the addition of more than two or three new faculty. When the student-faculty ratio was nine to one the marginal

utility of bringing two or three hundred men with the addition of only two or three new faculty was very obvious. Therefore, administrative studies indicated that the possibility of launching a mens college could be undertaken without an extensive and costly capital outlay for buildings or additional faculty. Indeed, the income from men could be used to supplement the college's support of its library, its faculty, and its science facilities. Thus, it became clear that we could do rather exciting things in several areas that would be of interest to men, as well as young women--Communication Arts and Mathematics particularly--and that a relationship based on contracts, leases, and mutual understandings with a second college would not be a heavy economic burden on Lindenwood College, but could actually strengthen the work of that institution.

Once the administration had come to this conclusion, and was able to demonstrate to the faculty and Board the validity of the conclusion, the necessity to act became very clear.

Thus, on January 6, 1969, the Board unanimously gave the signal to move ahead as rapidly as feasible. A group of incorporators: John M. Black, John Anthony Brown, Franc L. McCluer, Steven Hirsch, Howard A. Barnett, and Walter L. Metcalfe, Jr., chartered Lindenwood College II.

The name Lindenwood College II is not popular with all segments of the Lindenwood constituency. It was used for purposes of incorporating the new college because it reflected exactly what we were doing. Lindenwood College II is not new buildings, and a massive debt, and a series of promises. It's an extremely carefully designed program of education for young men, a new concept of college organization, with great emphasis on community government within the college, and a series of contracts and mutually advantageous relationships with an older, well-established college named Lindenwood. The income that comes to Lindenwood College II can be devoted to strengthening an already fine faculty, to adding additional equipment and facilities (next year Lindenwood II will support the Mathematics and Communication Arts Programs generously).

Where Do We Go From Here?

We had a dual concept at The Lindenwood Colleges. Remember, remember above everything, that there are two colleges. In Lindenwood College for Women we are deeply concerned, as we have been for many years, with the care and feeding of a woman's mind. Lindenwood College for Women will continue down the road of concern for the future of women, for their role in our society, for special kinds of education that will help prepare them for that role.

Lindenwood College II, without the heavy encumbrances many colleges have in the form of buildings and debt can find new and innovative approaches to higher education. Lindenwood College II, confining its enrollment to males for some years, can bring a new dimension into a very well-established and stable woman's college without destroying in any way the traditions and strengths of that institution.

Why The Lindenwood Colleges?

Private colleges across the country are finding it increasingly difficult to attract levels of support and, indeed, levels of student enrollment which they need. Why will students come to The Lindenwood Colleges? Why will donors give to The Lindenwood Colleges? Why will foundations support The Lindenwood Colleges? If The Lindenwood Colleges are to attract good students and secure the necessary financial support, they must respond in effective fashion to the needs of tomorrow. It will be the adequacy of this response that will determine our success. And, of course, by its very nature, founded by the Presbyterian Church, and nurtured for almost a century and a half by very dedicated people of high standards and clear values, this college must continue, even in times of great instability and insecurity, its tradition of helping people find meaning and purpose for life.

We are dealing with a generation determined to do something definitive about problems with which some of us have lived for generations. This activist impulse on the part of young people can be a constructive thing in a small college; we must make it so.

This generation with which we work is determined to find its own way and not to follow in a pattern we have established. This determination has its dangers, but far more than its dangers are its po-

tentials. There is every day a new world; we walk on the moon. There must be, at the same time, new approaches to life in that new world. We at the small college which has its deep commitments to the development of individuals ought to be able--must be able--to help in this search for "one's own way."

We will work in the years immediately ahead with a generation that would use the college sometimes for purposes other than those to which we have been traditionally committed. Colleges and universities everywhere are being invaded from all directions by those who would use the institutions in ways that would surely raise grave doubts about their future. We must hold before our students and faculty our past, and open into the future new vistas for worthy endeavor. But we must resist the invasion of those who would use us for special transitory causes.

We are, by the recent events at this institution, and particularly by the decision of January 6, a more diverse institution. There will be men here; there are more students here of other races, including the black race from within our own social milieu. In spite of this greater diversity, we live closely together. We do not want to be the same; we do not want to forget the things we hold in common or the differences we may wish to maintain.

So it's two colleges; it's men and women; it's blacks and whites; it's Americans and international students; it's science and the humanities; it's art and mathematics; it's today and an indescribable tomorrow, that are all mingled in The Lindenwood Colleges.

We would not be where we are if we had not been what we were in the past one hundred and forty years. We will need the support of those who believed in us as we were. We know that many of them fully understand that change is inevitable, but that planned change--the future faced deliberately and courageously, and indeed rationally--is the kind of change that the educated man brings about.

Largest Graduating Class In History

President Emeritus Franc L. McCluer returned to the campus Friday evening, May 30, to address one hundred forty-six seniors, the largest graduating class in the history of the college, at the annual baccalaureate services. The following day he presented The Honorable Paul Findley for the honorary degree of Doctor of Humane Letters. Findley, Republican Representative in Congress from the 20th District of Illinois, serves on the House Foreign Affairs Committee and is active in the International Movement for Atlantic Union. He is a Trustee of Illinois College and a member of the American Academy of Political and Social Science. Representative Findley spoke at commencement on "The Quest for Personality", by individuals and nations. He cited the vast increase in military manpower and spending in the United States as a symptom of change in our personality as a nation. Also honored at the commencement exercises was former St. Louis Mayor Raymond R. Tucker, who is currently Professor of Urban Affairs at Washington University. Mr. Tucker received the honorary Doctor of Laws degree.

Lindenwood Receives Three Publication Awards

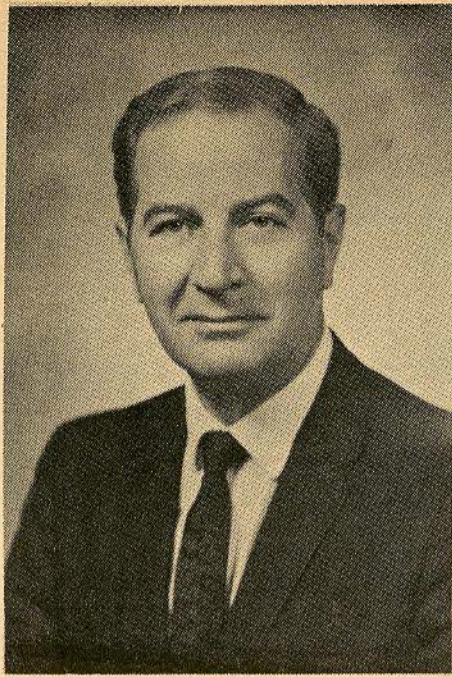
The Lindenwood Colleges received three awards for excellence in college publications at the combined annual meetings of the American Alumni Council and the American College Public Relations Association held in New York during July.

The American Alumni Council awarded second place honors in the 1969 Direct Mail Competition to Lindenwood for an announcement that was prepared for the launching of Lindenwood II. A third place award was received for a general brochure and viewbook describing the programs of the two colleges for prospective students. Mrs. Nancy McClanahan, Director of Alumnae Affairs, accepted the citations awarded by the American Alumni Council.

The American College Public Relations Association presented a certificate of special merit to Lindenwood for a large black and white poster announcing the formation of The Lindenwood Colleges. The poster features a reply card for use by persons interested in obtaining information about the colleges. Vice-president for Public Affairs, B. Richard Berg, accepted the special merit award. In a speech to delegates at the convention entitled "The Single College Takes a Mate", Mr. Berg described the procedures involved in the development of the new college for men.

New Bachelor Of Science Degree Program Established

The Bachelor of Science degree will be offered by both of the Lindenwood Colleges in addition to the Bachelor of Arts degree in selected areas of concentration. The faculty has authorized the new degree program which will require three exploratory electives in each division instead of two. The departments of Political Science and Sociology also require a course in Social Science Statistics. The Bachelor of Science program will not require proficiency in a foreign language. Those areas of concentration offering the B.S. degree option are: Studio Art, Biology (including physical education and nursing), Chemistry, Communication Arts, Economics, History, Mathematics, Music, Philosophy, Political Science, Psychology, and Sociology. Students interested in a divisional area of concentration in preparation for an elementary teaching credential may work toward the Bachelor of Science degree. Students interested in a secondary teaching credential should complete requirements for the Bachelor of Arts degree. Areas of concentration in which students must meet the requirements for the Bachelor of Arts degree are Art History, Classical Civilization, English, Modern Languages and Religion.

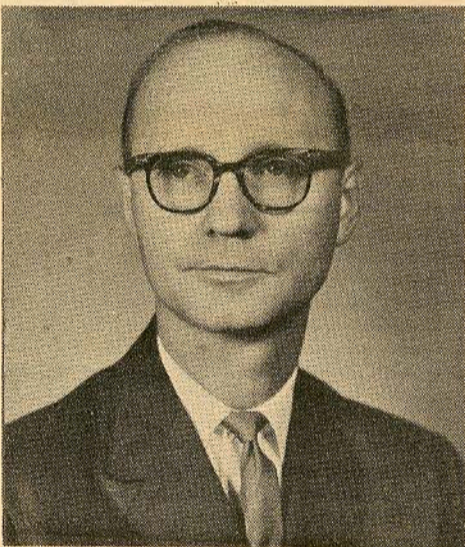

Named Associate Dean



Dr. James F. Hood, a member of the Lindenwood College faculty since 1961, has been named Associate Dean for Special Academic Programs of the Lindenwood Colleges. Professor Hood is also chairman of the Department of History.

Dr. Hood will serve both Lindenwood College for Women and Lindenwood College II, the new coordinate college. He will direct the Summer Session, the January Term program, and the Evening Division program. Dr. Hood will also be responsible for directing all special institutes and conferences and for coordinating the growing number of cooperative programs that The Lindenwood Colleges have developed with other colleges and universities in the metropolitan region.

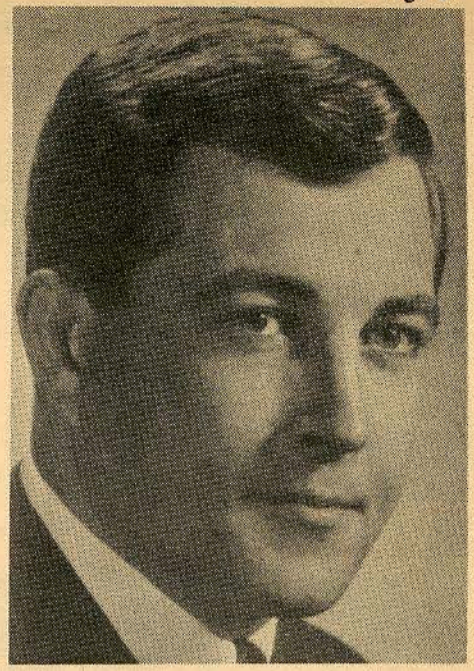
Dr. Hood received his bachelor's, master's and doctor of philosophy degree from the University of Illinois. He taught at Northeast Missouri State College before joining the Lindenwood College faculty in 1961. He resides in St. Charles with his wife, Jane, and their two sons, John and David.

Seven College Consortium

The Ford Foundation has approved a grant of \$200,000 to Lindenwood and six other liberal arts colleges in Missouri to assist the colleges in recruiting and providing counseling and tutoring programs for disadvantaged students. The grant also will make possible the development of workshop programs for faculty members of the colleges, and the organization of a scholarship fund-raising program for needy students. Participating in the seven college consortium will be Fontbonne, Lindenwood, Maryville, Park, Tarkio, Webster, and Westminster Colleges. Lindenwood President, John Anthony Brown is the founding chairman of the consortium.

Administrative Changes

The establishment of the new coordinate college, Lindenwood College II, has resulted in some major administrative changes to provide leadership for the new college. Dr. Gary H. Quehl, who has served as Dean of Lindenwood College for Women for the past two years, has become Vice-President and Dean of Lindenwood College II. His special talents in research and planning will be most helpful in the development of distinctive approaches to higher education at the new men's college. Dr. Howard A. Barnett, Chairman of the English Department and Director of the Senior Synthesis course, has assumed his new duties as Vice-President and Dean of the Faculty of Lindenwood College for Women. Dean Barnett came to Lindenwood in 1965 and holds the Alice Parker Chair of English Literature. He received his Ph.D. from Indiana University and has taught on the faculties of Morris Harvey College and Wisconsin State University. Dr. John Anthony Brown serves as president of both colleges.

Operation Minibus Reaches Halfway Mark

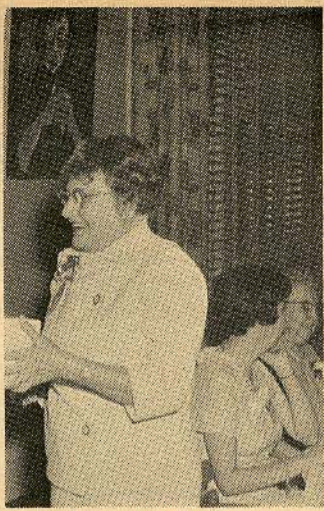

We are deeply grateful to those of you who have already mailed your contribution.



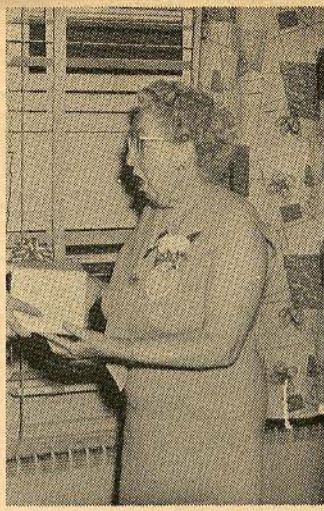

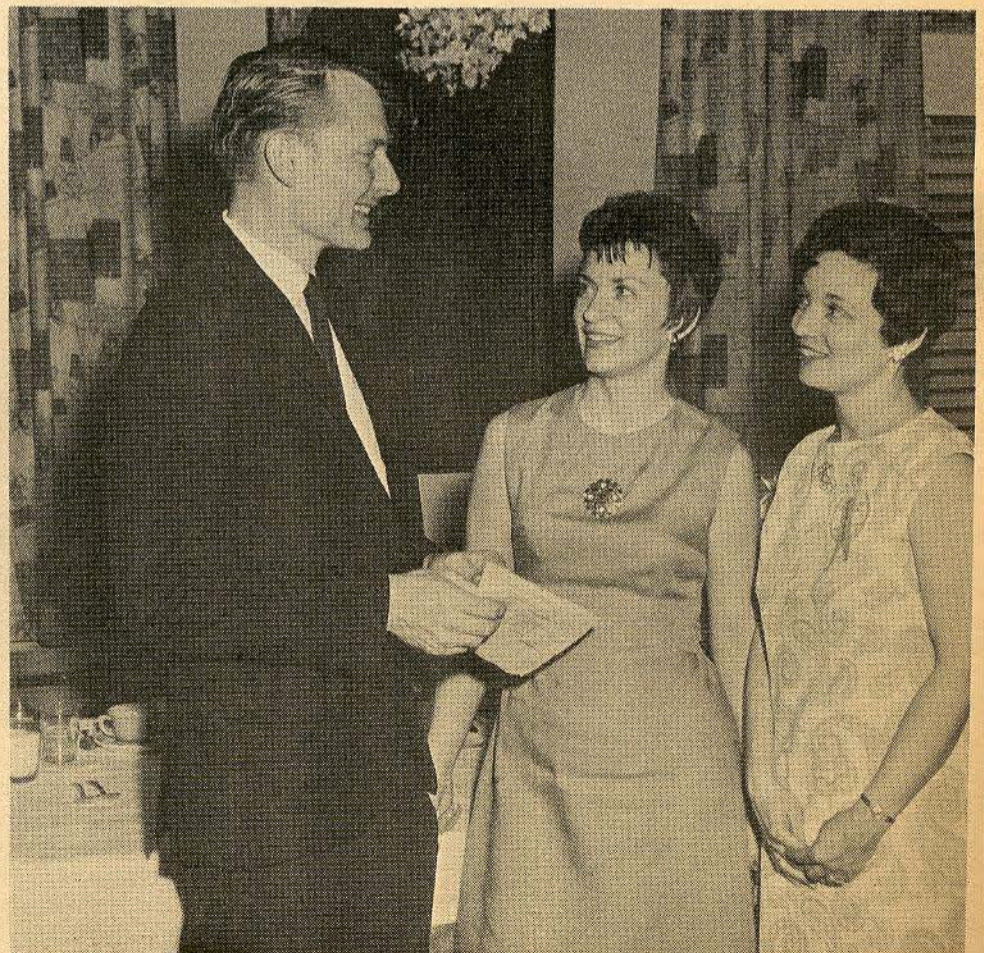

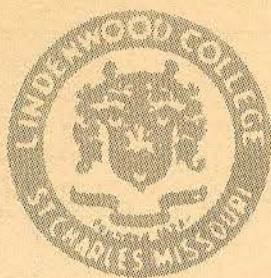

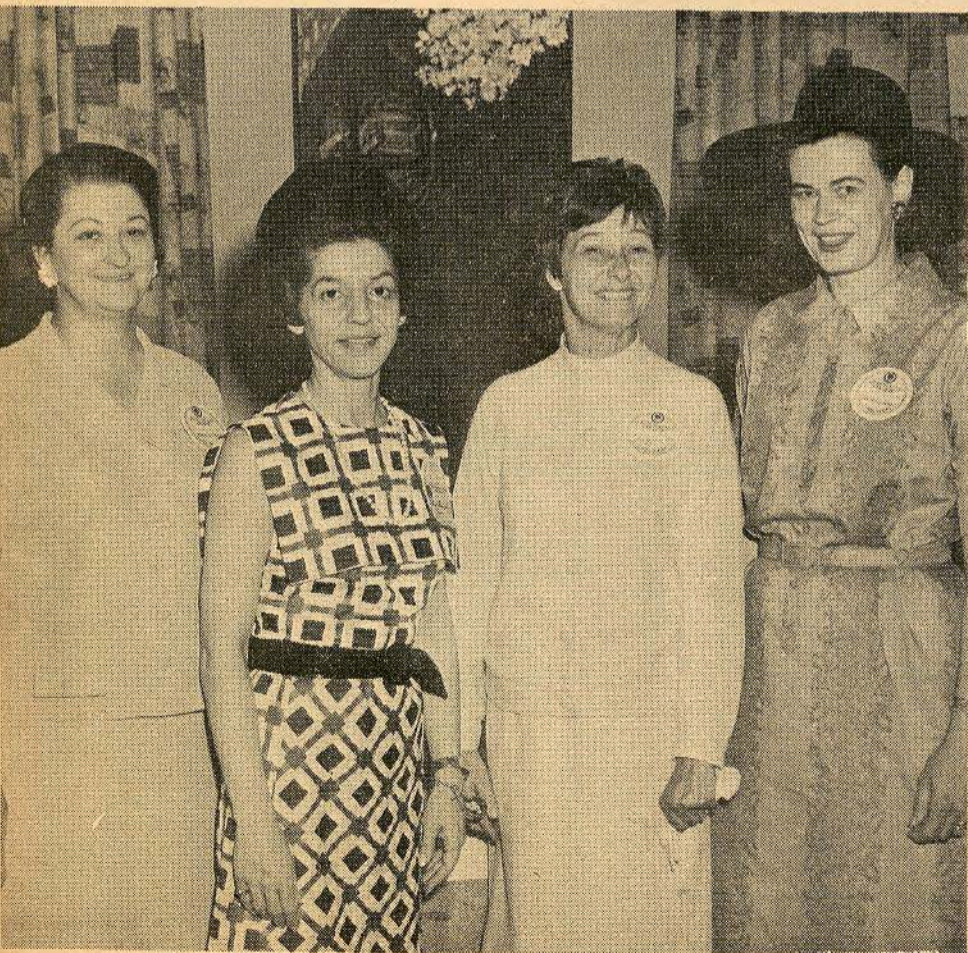

As Chairman of the Nominating Committee, Rosanna Veach Bruere '40, submitted the following slate of officers: for vice-president: Barbara Wexner Levy '47, Fort Lee, N.J., for treasurer: Carol Gardner Transou '58, Johnson City, Tenn., for council-at-large: Folsta Bailey Gibbons '49, Kirkwood, Mo., Sarah Hall Fandey '49, Redondo Beach, Calif., Judy Letson White '63, Atlanta, Ga. No additional nominations were made. It was moved that this slate of officers be unanimously accepted. Seconded. Carried.

Ed Van Woert '58, co-chairman Alumnae Annual Giving expressed a great disappointment in the Annual Giving Program for the past year. He felt there were three reasons for the lack of response.

1. Generally, the image of higher education has suffered.

2. As taxes have gone up and causes become more demanding the idea prevails to "let the government do it, don't ask me".

3. Today there is a rapidly changing image of the college and the curriculum. Mis-information is another cause for lack of giving. The goal for this year was \$20,000 with an average of \$2.00 per alumnae. (Annual Giving Report elsewhere in this paper) The endowment has shrunk with the purchasing power down 30%. He stressed that the alumna who is really interested will get the facts and tell what really is going on. Nancy Alvis McClanahan '56, Director of Alumnae Affairs, stressed that industry always seeks information concerning the percentage of alumnae that give to their college.

President Barbara Hamill '32 thanked Ed and Julie Van Woert for their devoted service that spoke proudly for Lindenwood College. The Van Woert's were reappointed to serve as Co-Chairmen of Annual Giving for 1969-70.

A report on the Alumnae Directory was presented by Nancy Alvis McClanahan '56, in the absence of Nancy Montgomery Orr '35, Chairman. The preparation of the Alumnae Directory began in June 1968. The Directory contains three listings: Alphabetical, with a cross reference for both maiden and married name the address will be found by the maiden name; Geographical; and Class. The addresses are up-to-date through January, 1969. Lost alumnae are not listed and deceased alumnae are not listed, unless recently deceased. Deceased alumnae are not listed, due to the fact, that these were not recorded in the Alumnae Office records until about 1960. The publication is the first Alumnae Directory since 1936. (to date 1661 Directories have been sold.)

Sharlene Agarter Glock '52, Chairman of Clubs, reported that a workshop for club presidents was conducted on Friday, May 2, 1969. The following club representatives met at 2:00 p.m. in Young Lounge: Hetty James Price '58, Kansas City; Marie Christensen Robb '38, Indianapolis; Barbara Wexner Levy '47, New York; Nancy Hollett Woods '63, Atlanta; Kathy Kaiser '64, Southern California.

There are two recently organized clubs located in New York City and Atlanta, Georgia. The following clubs were recognized and asked to stand: St. Louis, Kansas City, St. Charles, Dallas, Oklahoma City, New York City, Southern California, Northern California, Atlanta, Chicago, Indianapolis, Columbus, and Minneapolis. Oklahoma City announced the publication of a recipe file which will be ready for mailing during the fall of 1969.

The Alumnae Council voted to save trading stamps for the purchase of a mini-bus for the use of Lindenwood students. Rosanna Veach Bruere, chairman, asked each club to concentrate in their area to gather as many books as possible. A series of mailings will go out during the summer.

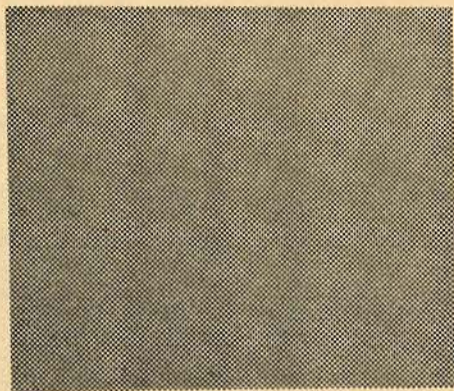
Helen Culbertson Beste, Chairman of

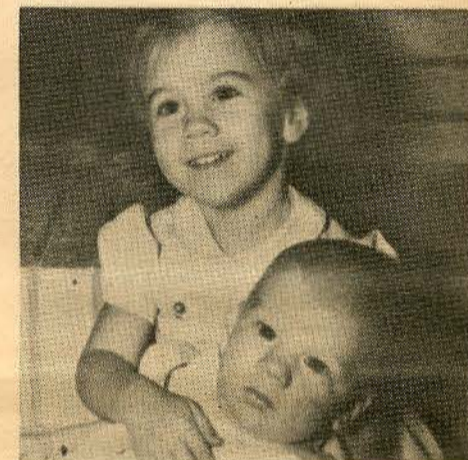
