This summer we will also be finishing preparations for our decennial Higher Learning Commission (a.k.a North Central Association) accreditation review, getting ready for another heady fall sports season in the NCAA, running a very populated and vigorous summer school, hiring the last few new professors for 2013-14, and upgrading and grooming the campuses for your homecoming. Whew!

Before closing this letter, I would be remiss if I did not publicly congratulate two of our most eminent and accomplished alumni: Jane Calvert Rogers ('67) for receiving Lindenwood's Lindy award for achievement in the field of Communications and Cortney Hupper Lenk ('99) for receiving the 2012-13 Alumni Merit Award. University Honors Reynolds at Dedication Ceremony

Gene Reynolds is a lifetime educator, but these days he sounds a little like a stockbroker.

Reynolds spent an afternoon at Lindenwood University in late winter doling out his personal investment strategy: invest in Lindenwood.

“The dividends are incredible,” Reynolds said. “If you invest in Lindenwood and its students, it returns dividends for lots and lots of people.”

Those were just a few of Reynolds’ eloquent words on Wednesday, February 20, as Lindenwood University dedicated Reynolds Hall, a 199-bed residence hall near the Lou Brock Sports Complex. Lindenwood’s Board of Directors agreed to name the residence hall after Reynolds following his very generous gift to the university.

“I’ve had a variety of relationships with Lindenwood over the last couple of decades,” said Reynolds, who earned his doctoral degree from SIU-Edwardsville in 1987. “Lindenwood has influenced me so very much. So I have taken some of my assets and made a decision to invest in Lindenwood. The dividends pay off

for young people, and that’s a wonderful legacy.”

After teaching in the Hazelwood School District for many years and serving as an administrator there, Reynolds started teaching as an adjunct professor at Lindenwood in the 1990s. He also coordinated Lindenwood’s teacher education classes in Hazelwood.

Simultaneously, he started ACE Learning Centers, which focuses on empowering students with skills to be productive and responsible members of society, providing a non-traditional approach to unique learning styles.

Reynolds and his wife, Joyce (’78), began hiring Lindenwood graduates to teach at ACE.

“Over half of our teachers are Lindenwood alums,” Reynolds says. “Lindenwood supplies the best teachers we know of.”

ACE has been wildly successful and “we wanted to do something important and give back to the institution that provides so much to our society,” Reynolds said. Reynolds’ speech to a crowd of about 100 people at the dedication ceremony was like a trip down memory lane. He recalled all of his old Lindenwood friends who “invested”

in him over the years—Francis Huss, John Feely, Rick Boyle, Larry Doyle, Dennis Spellmann, and many more.

Reynolds is paying forward their investment.

Donated Dress Spurs Memories of May Day Tradition

A new display installed in the exhibit case adjacent to the cafeteria entrance in the Spellmann Center celebrates May Day or May Weekend, a spring festival that was observed at Lindenwood from 1915 through 1961.

The centerpiece of the display is a gown worn by LU student Lois Luckhardt (Carroll), who was May Queen in 1923. According to Steven Gietschier, PhD, University Curator and Assistant Professor of History, the 90-year-old gown was a gift to the school from Luckhardt's granddaughter. It embodies the grace and elegance that marked this annual highlight of the Lindenwood College social calendar.

While the origins of May Day are debated by scholars, most authorities believe that the celebrations began during pre-Christian times. By the 14th century, May Day was firmly established throughout most of Western Europe, Great Britain, and Ireland. Just as debatable is the meaning behind the celebration. One widely held belief is that day was an annual rite that allowed young maidens to meet potential suitors.

Others believe that the May pole used in the celebrations was a form of worship of trees by Scandinavian and Germanic cultures. Regardless of their beginnings, by the time the tradition reached modern times, most people viewed May Day as a rite to celebrate the beginning of spring.

The earliest known May Day celebration at Lindenwood was in 1915. The College embraced many of the traditions at eastern women's schools, and May Weekend was

one such tradition. Lindenwood observed the tradition by designating the first weekend in May not only as May Weekend, but as parents weekend.

Over the years, the celebration grew into a cultural event for the entire community. By the late 1950s, May Weekend began to fall out of fashion; in 1961 it ended, save for an unsuccessful attempt, a decade later, to revive the tradition.

The cover photo was taken in 1958 at the Irwin Hall song-fest by an alumni parent.

The May Queen in 1958 was Joan Broeckelmann, and the Maid of Honor was Diane Floyd (Goldtrap, '59). Senior attendants were Carol Gardner (Transou, '58) and Heather Armour (Hellmich, '58). Junior attendants were Julie Orr (Van Woert, '59) and Verna Lou Lloyd (Wood, '61) and sophomore attendants were Mary Fletcher Cox (Branch, '60) and Joan Meyer (Wolfe, '60). Freshman attendants were Cynthia Richards and Claire Schlosberg (Woodcock, '61).

Margi Bassnett (Burton, '61), an Irwin Hall resident, was asked for her memories of the 1958 celebration and she writes:

"I remember singing 'Sleepy Time Down South' and 'Stars Fell on Alabama' that weekend. Sally Miller (Perdue, '60) led the ladies of Irwin Hall in singing some beautiful southern songs, even though Missouri was probably as far south as many of them had ever been.

"Being from England, my father adored all that 'ceremony.' I loved making the floppy hat we were required to wear, since I was an art major at that particular moment

in time. Mine was a work of art but fell apart before the ceremony was over.

"The freshmen, all in formal dress, lined the path from Sibley Hall down to the stage where the most beautiful among us were crowned queens and princesses and what have you. Either my dress was too tight, the oppressive Missouri heat got to me, or I was just incredibly excited about the whole thing. I started to pass out as the royalty progressed along the path and had to sit down on an adjacent chair, unceremoniously drop my head between my legs and breathe deeply.

"By my senior year, the celebration had become a relic of a previous era. We took no chances on the weather and staged the May Weekend coronation in the Lindenwood College Chapel. As Senior Class President, I was the announcer who described the girls, the dresses and the

escorts who assisted the 'ladies' down the center aisle in mock wedding fashion. It is serendipitous that one of the escorts from Rolla became my husband two years later, and we will celebrate 50 years of marriage this May.

"To this day, I judge the advent of summer in Missouri by the leaves on the trees on the first weekend in May. People will say that summer is early or summer is late and I will always think, and often say that I

remember worrying that the leaves would not be out on the trees at Lindenwood for May Weekend and every year they would fully pop out the week before and everything would be beautiful. It is funny, the unimportant memories that stick with you for the rest of your life.”

Kay Dunham Wilkinson ('60) remembers that Ellie Mansfield (Gawdat, '60) was the May Queen in her senior year and that when she was a freshman she nearly froze to death in her formal while lining the path for the court from Sibley Hall to a platform

in front of Irwin Hall. She said that a dance was held on the parking lot behind the Memorial Arts Building her junior year and that her date stayed in the Quonset huts that were located on back campus.

Kayte Fellabaum Hueser ('60) says that although she was a resident of Irwin when the cover photo was taken, she does not remember the horrible hats. The photo (on page 4) of her with President McCluer, his wife, and Mary Lichliter indicates that she ditched her hat as soon as she could. Other Irwin residents recall paying their friends to

make their millinery creations.

In the final May Court in 1961, Terrill Ross (Meyer, '61) was the May Queen and Mary Margaret Warnecke (Hull, '62) was the special maid. Senior attendants were Mary Lou Reilly (Garbe, '61) and Linda Suellen Markuly (Markuly-Silvasy, '61), and junior attendants were Catherine Crebs (Ferrell, '66) and Imelda Harra (Farmer, '62). Sophomore attendants were Barbara Mogg and Melba Lee Counts and freshman attendants were Barbara Sue Widman (Badgett, '65) and Jeanine Schmidt.

Many of the Lindenwood students of that late 50s and early 60s with whom we spoke recall May Weekend as a special occasion that attracted parents and townspeople alike.

Professor Joe Cernik Carves out a Niche in LU, Politics, Baseball

A person need only speak to Joe Cernik, Chair of the Political Science Department, for a couple of seconds before his hard-bitten accent gives away that he is from the Northeast. Nonetheless, his bright red Cardinal jacket proudly displays his love for St. Louis' favorite sports team. Additionally, his office is filled with colorful red and white memorabilia from the team as well as other items that pertain to his love of politics.

Those who have not seen him on campus or taken his classes during his 23 years at Lindenwood may know him from his regular appearances on the KTVI and KPLR news shows as a political analyst, which he has been doing dozens of times a year since 2002.

"I've always liked politics," he said.

Cernik has a master's and a PhD in politics, both from NYU, and in the mid-1970s, he worked as a paralegal on the AT&T antitrust case.

"I helped lawyers out by reading a lot of notices and background information on whether or not AT&T was a monopoly," he said.

After a stint as editor of a newsletter called *Local Taxation*, published by the Henry George School in New York, he started his teaching career. First, he spent 11 years teaching at the University of South Florida and St. Leo University, which is also in Florida. He has won two

fellowships, one from the Alfred P. Sloan Foundation and one from the U.S. Army Training and Doctrine Command, for which he spent a summer in the mid-1980s studying military history at West Point. He came to the St. Louis area with his wife Chris, who died five years ago.

"She was from here," Cernik said. "We had to decide whether she was going to move to Florida or I was going to move

here, and we decided to come here."

Cernik joined the faculty at Lindenwood in 1990, after which he earned an MBA from the school. Since that time, he has carved out quite a niche for himself in the University and the community. He was a consultant for the St. Charles County Home Rule Commission in the early 1990s, and he has two regular shows on LUTV: *Insight* is a discussion of political books, and *Books and Strikes* is, as he describes it, "all things baseball." He won a Lindy Award from the School of Communications for *Insight* in 2006 and another this year for a show on Negro League baseball.

He is also the recipient of a Governor's Excellence in Teaching Award, an Emerson Electric Excellence in Teaching Award, and an LSGA Teacher of the Year Award. He is clearly proud of his students, over 60 percent of which have gone on to graduate school and/or law school.

"I think that is a reflection of the quality of student Lindenwood is attracting," Cernik said.

Currently, his department has grown to about 50 political science majors, which he said is a marked change from his early days.

"When I started, classes were so small I could teach them in my office," he said.

Today, that would be much more difficult, especially with all that memorabilia.

School of Nursing Introduces Dean, New Building

Lindenwood University's new School of Nursing and Allied Health Sciences is preparing to begin operations this fall at a 69,000-square-foot building in Dardenne Prairie.

University officials celebrated with a dedication ceremony in late March, introducing Dean Peggy Ellis, who has worked in nursing education for more than 35 years at all program levels, including associate, bachelor's, master's, and doctorate.

At the ceremony, Lindenwood President James D. Evans, along with St. Charles County Community College President Ron Chesbrough, signed a lease agreement that brings the community college's nursing program under the same roof as Lindenwood's. SCC is constructing a state-of-the-art simulation lab and virtual hospital at the site, and the two schools are collaborating on curriculum and the transition of two-year students into a four-year program.

"Lindenwood's mission of concern for the worth and integrity of the individual, along with its reputation for innovation, makes it a great environment for educating nurses," Ellis said. "Nationally, we need nurses who can provide high quality healthcare with concern for the worth and value of the individual patient."

Lindenwood will offer coursework for students who already have obtained a two-year associate degree at a community college. The program is intended to address an increasing requirement among many hospitals that nurses have four-year nursing degrees.

"The goal is for all nursing to have their BSNs by 2020, or at a minimum, 80 percent of the workforce," said Mary Frey, vice president of nursing at SSM St. Joseph Health Center in St. Charles.

Lindenwood has a history of nursing education and many nursing alumni. Lindenwood first graduated a nurse's aid in 1945 and began developing partnerships with area hospitals in the 1950s.

Gazebo Revitalized on Campus; Dedication Scheduled for Alumni Picnic

In the mid-1980s, students and alumni from the classes of that era raised funds to construct a gazebo on the Heritage Campus of Lindenwood College. An architect was commissioned, blueprints were drawn up, and some money was raised. The project was started, but not fully completed, resulting in a white wooden structure in front of Irwin Hall—until recently.

This fall and winter, a new brick gazebo was constructed in its place according to the original plans. It started last summer with an idea from Jack Beckerle ('00), Chair of the Fire and Paramedic Science Department and Associate Professor in the School of Human Services. Beckerle thought it would be a good idea to spruce up the structure with some fresh paint and maybe some plantings.

"I was going to get some students together and freshen up the gazebo as a project, but when we went to determine what we needed, we found that it was going to take more than paint to make a difference," said Beckerle.

A few weeks later, Lindenwood Archivist Paul Huffman ('06) came across the original blueprints for the gazebo, at which point Lois Evans ('77, '85, & '97) became involved in the project. The wife of President James Evans was extremely supportive of the idea of rebuilding the gazebo.

"With Lois' help, we were able to get some University funding, and we are reaching out to our alums who might be interested in supporting this project," said Elizabeth King ('00, '01), Director of Alumni Relations. "We removed the old wooden structure and built the gazebo to the specifications intended by the students who originally designed the project. The

beautiful new structure honors our alumni and the thousands of students who became alumni on the St. Charles campus of Lindenwood University."

For nearly 30 years, even partially completed, the old gazebo became "the meeting place" on campus. Students used the gazebo as the place to gather and study. It was a stage for one-act plays, a platform for student bands, and the focal point of the day all students looked forward to—graduation. Tens of thousands of Lindenwood students became Lindenwood alums as they walked across the gazebo platform, accepted their diplomas, and moved their tassels from one side of their

caps to the other.

With the support of all alumni, a new brick gazebo now stands completed, the culmination of the original vision of the students of the 1980s, using those original blueprints. The new structure commemorates and honors Lindenwood's history and heritage and those who have helped build Lindenwood—the alumni. The structure will be dedicated at the annual Alumni Picnic on Saturday, June 1, 2013, at noon.

New Photo Alumni ID Cards to Replace Current Ones

All Lindenwood alumni will have the opportunity to receive a new photo Alumni ID card that will make taking advantage of on-campus benefits easier. The plastic cards will be equipped with a bar code and will be available June 1 at the annual Alumni Picnic and through the Alumni Relations Office after June 3, 2013.

The new cards will replace the current paper alumni cards, which have a thin plastic backing. As card scanning systems become incorporated into more areas and services on campus, the new alumni ID cards will be used in those areas. It is a goal of the Alumni Relations Office to get a better idea of the services alumni are using on campus.

How to obtain a new card

Alumni can walk in to the Office of Alumni Relations with a request for a new ID. Your photo and information will be taken, input into the system, and sent off to a processing center, which will generate the cards, which will be mailed upon completion.

Alumni can call in or email card requests as well. With a call or email request, the Alumni Relations Office will do the data input and the alum will email a photo of his or her face to the office. Should an alum lack the ability to email a photo, a hard copy photo can be sent by U.S. mail. All photos will be returned.

The ID cards will contain a photo, first and last name, year of graduation, and a bar code.

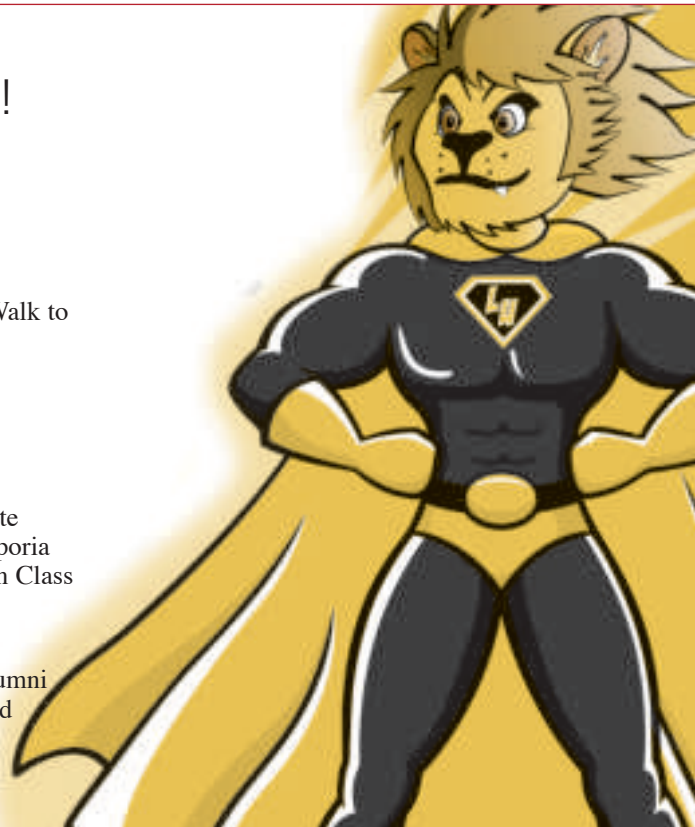

Kate Frisina-White Says TV Show has Made Family Closer

If you've wondered what it must be like to be the star of a reality TV show, to live your life in front of a camera lens, Kate Frisina-White ('06) could tell you. White, who got her master's in teaching from LU, is one half of the title duo in Nickelodeon's show, *Mom Friends Forever*, which airs on Nick Jr. at 10 p.m., central time, on weeknights.

The show follows White, who lives in Creve Coeur, Mo., and friend Judi Diamond and their families. White, originally from Taylorville, Ill., lived in Los Angeles for 20 years, where she worked as an actress in commercials and sitcoms.

"They liked my Midwestern look," she said. "It was different."

White's undergraduate degree is a BA in theatre from the Goodman School of Drama at DePaul University. She said she and her husband, Jack, moved back to the Midwest in 2004 to be closer to her family. They have two kids: Max, who is 18 (and is slated to attend Lindenwood in the fall), and Duke, who is 14.

She met Diamond, who is a producer and on-air talent for the Cornbread Show on WIL-FM radio, in 2007 at a talent agency that both of them used. The two of them hit it off, finding they shared the same sense of humor and had kids the same age. In 2008, they decided to launch a video blog called

Lipstick and Laundry, geared toward moms.

"It became pretty popular," White said. "We thought, 'Why not take it to the next level?'"

About three years after starting the vlog, they contacted a local production company called Cool Fire Originals, though they were not sure what kind of show they wanted to do. The people at Cool Fire suggested it might make a good reality show, and they produced demo, what is known in the business as a "sizzle reel." Nickelodeon was interested.

"They were starting a block of programming called NickMom on Nick Jr., designed for moms who still had the TV on after the kids had gone to bed," White said. "It was perfect."

Nickelodeon originally bought 20 episodes of the show and later added another six, which equates to two years of episodes. It started airing in October 2012. The show is more documentary than reality show; they call it a "docuseries." White admits it took some convincing to get her kids and her husband on board with being on the show, but they have come around. One episode, in fact, included a college visit with Max to Lindenwood.

The biggest surprise, White said, is the effect it has had on her family.

"It has forced us to sit down and talk to each other," she said. "We just happen to do it on camera. I didn't expect it to enhance

our relationship in that way."

Currently, White and Diamond are waiting to hear if Nickelodeon will order a third season of the show. Regardless, White said she and Diamond will continue to do what they are doing, with the video blog if need be.

"It makes us feel good as women," White said, "and it helps me to be a better wife and mother. I love the opportunity to get other people's opinions about things. We will never stop doing that."

99-Year-Old Alum Reflects on Life for Student Interviewers

Can you imagine a time when Lindenwood was an all-girls college? Where there was no visitation and you had to sign out when leaving campus? What about doing homework without Google? While this described campus culture during the 1930s, transcendental events were going on outside of the classroom such as the Great Depression and the creation of HP (Hewlett-Packard). As proud Lindenwood students, we wanted to be part of our school legacy and took advantage of the opportunity to interview Marietta Hansen, a Lindenwood graduate from the class of 1934.

Even though this assignment started only as an honors project for Professor Behrman's Intercultural Communication class, it turned out to be more than just an interview or a requirement. We came back from Brentwood's retirement home in downtown St. Louis with our expectations blown away and a strong sense of pride for LU that many students don't appreciate. Overall, many students today complain about visitation rules, the food, and the lack of things to do in St. Charles. However, after interviewing 99-year-old Marietta, we have seen the progress that LU has made over the years and the change in culture as well.

Back in the days when Dr. John Roemer was president, Hansen said, his wife prohibited campus residents from entering automobiles. Not even taxis were allowed on campus. In addition, Marietta and her friends looked forward to Saturdays where they would walk to town and enjoy the famous "West End's" hamburgers with mayo. Even in the 1930s the students complained about the cafeteria food, about which Marietta happily explained, "you weren't one of the gang unless you complained." Yet, they anticipated Sunday brunch, which consisted of raisin bread and seven canned cherries—counted. Almost 80 years later, we know the two of us look forward to Saturday brunch for omelets; at least we don't have to count our ingredients and can come back for more.

Marietta loved her time here at Lindenwood and is very grateful that her parents were able to send her here to pursue her passion for writing as a journalism major while the country was suffering the impact of the Great Depression. Marietta's Lindenwood education cost \$750 a year, including room and board without the extra help of work and learn that nearly every student benefits from today. As an active leader of many clubs around campus,

Mrs. Hansen's effort was recognized and rewarded with Lindenwood's "\$500 Fellowship Scholarship," which covered all of her graduate study costs at the University of Chicago.

It was a difficult transition for her at first to go to such a big grad school, because she enjoyed the small and familiar campus culture of Lindenwood. Here, she could walk to class and greet all of her friends and classmates. Although today campus is much more diverse with nearly 1,000 international students and 47 different sports, LU students can still relate to the small, yet varied campus culture.

After fulfilling her studies, Marietta started with a wage of \$14.40 a week as a proofreader in Chicago. Eventually, as she moved up in her career, she ended up reaching her goal of earning \$25 a week. When she took a job back in St. Louis as a secretary of a Unitarian church, she met the love of her life. Like every proud mother, Marietta's mother-in-law showed empathy when she expressed, "You have a very good looking son." Her mother-in-law responded, "Ms. Hansen, he's just as good on the inside." Shortly after marrying, she retired with her dream salary and now she is proud of her granddaughter who continues her legacy as the editor of *Elle* fashion magazine in New York City. Her

granddaughter, along with her other family members, will be coming in from the East Coast and other parts of the country to celebrate her 100th birthday on May 30, 2013.

We are inspired by the fact that Marietta has been all over the world, from the Caribbean to South America and all the way up to Europe. We are a Spanish/international business (double) major and a non profit administration major. Therefore, we aspire to travel the world, meet new people, and pursue our dreams, which she commended as "ambitious and memorable." As she talked and shared her experiences with us we were further inspired to follow our dreams and reach our goals in life.

Marietta loved her years at Lindenwood, reached her goals in life, and continues celebrating her happiness with her family and friends. Many people believe that the college years are the best ones in life, but don't forget that we, like Marietta, are capable of accomplishing so much in life by living it to the fullest. Like Abraham Lincoln says, "it's not the years in your life that count. It's the life in your years."

Belleville Communications Center Features New Studios, Radio Home

Lindenwood University-Belleville is celebrating the opening of a new \$2 million communications center. The facility already is paying dividends by attracting new students.

The communications center opened following the Illinois Board of Higher Education approval of new communication degrees in advertising, public relations, corporate communications, interactive media and web design, and mass communications with an emphasis in sports information. Jerry Bladdick, Vice President and Chief Administrative Officer for LU-Belleville, said the communications center houses the LU-Belleville radio station, television station and studios, classrooms, and offices.

“It is one of the crown jewels in the academic tree at Lindenwood-Belleville,” Bladdick said. “While we strive to make a name and a place for our students, we are so very fortunate to have the model created for us in St. Charles and the assistance we receive from that campus.”

Mike Wall, Dean of Communications in St. Charles and architect of a cutting edge communications program, has been instrumental in designing the LU-Belleville communications center. He said that while the radio station is now only streaming on the World Wide Web, the Belleville campus is actively seeking an opportunity to move to a live broadcast radio station to create even more opportunities for students. In addition, LU-Belleville is working on creating a partnership that would lead to a 24/7 television station on campus.

Wall said the 6,700-square-foot communications center has two radio production studios and a large video production studio. He said a new video

editing lab also serves as a classroom. There are two additional high-tech classrooms, as well as a video checkout office for students to obtain equipment for use in projects and assignments. The communications center is situated in the back of the administration building.

LU-Belleville Dean of Academics Keith

Russell said Wall “has been a great asset” and continues to provide leadership and guidance for the budding communications center. He said Wall and the Lindenwood-St. Charles video production team have assisted with live video streaming of football games and other campus activities and events.

New Residence Hall Under Way in Belleville

The Lindenwood University Board of Directors approved in March the construction of a \$4 million dollar residence hall for the Lindenwood University-Belleville campus. The 25,000-square-foot project is expected to be completed during fall 2013.

“Lindenwood is pleased beyond words that our Board of Directors has approved the construction of a new residence hall at our Belleville campus,” said James D. Evans, PhD, President of the University. “It will be a beautiful addition to the city, and it will help us accommodate the continuing demand of a full-service residential college experience at the campus.”

The building will be located near the school's existing U.S. Senator Alan J. Dixon Student Center, which was

constructed in 2011. The traditional dorm will accommodate up to 180 residents and will house female students only.

“It's a very accessible location where students can get to class, computer labs, and the dining hall,” said Jerry Bladdick, Vice President and Chief Administrative Officer. “This is a major step in helping us achieve our goal of 1,200 residents and a total of 2,000 students on campus.”

Bladdick said the new residence hall will make Lindenwood-Belleville the only university in the Metro East that offers four different housing options for students. The school already offers apartment-style housing, family-style housing in several homes purchased by the school, and resort-style lodging in a nearby former hotel.

Lindenwood-Belleville's growth

and ongoing campus expansion is enthusiastically supported by the surrounding community. Mayor Mark Eckert said city leaders were thrilled with the school's plan to add a new dormitory.

“The city of Belleville is extremely excited about the continued growth at Lindenwood-Belleville. This dorm marks a significant step in that growth, and we are excited to be working with Lindenwood to make it a reality.”

Opportunities for Charitable Giving Still Exist Under New Tax Law

For 2013, most people will not see significant tax increases under the new American Taxpayer Relief Act ("ATRA"). However, those earning more than \$400,000 (\$450,000 if married) will be subject to a new maximum tax rate of 39.6 percent. For these persons, charitable deductions may actually become more valuable in reducing their tax liability. Although the Act contains an itemized deduction phase-out for those with more than \$250,000 of adjusted gross income (\$300,000 if married), as a general rule, only very high income taxpayers and residents of states with no income tax will have their charitable deductions affected. Therefore, for most people, charitable gifts would still have tax advantages, and we ask that you consider a gift to Lindenwood!

Avoid Capital Gains By Donating Securities to Lindenwood

Certain persons will also see an increase in capital gains taxes in 2013. Those with income of more than \$200,000 (\$250,000 if married) will pay an additional 3.8% tax on capital gains under the Affordable Care Act of 2010. In addition, under ATRA, those with taxable income of more than \$400,000

(\$450,000 if married) will have their capital gains tax increased to 20 percent, making their total capital gains rate 23.8 percent.

One way to avoid the higher capital gains tax is to donate certain types of securities or real estate that you have held for over a year and that have increased in value to Lindenwood. You would receive a charitable deduction for the fair market value of the property, and no capital gains tax would be due on the appreciation in value. Please note that certain types of property would not qualify and limitations apply. In addition, you may be able to contribute property that has increased in value to a charitable remainder trust and receive income in return. Due to the fact that the trust is exempt from income tax, no capital gains tax will be due when the property is sold.

IRA Charitable Rollover Extended

ATRA also allows donors age 70 ½ or older to make a qualified charitable distribution of up to \$100,000 directly from an IRA to a charity. A qualified charitable distribution is not added to the donor's income for tax purposes, which is particularly beneficial for those receiving social security and for those who do not itemize deductions. Due to the fact that

there is no charitable deduction related to this gift, there is an advantage for donors subject to the charitable gift percentage limitations and donors for whom the itemized deduction phase-out may apply. The IRA Charitable Rollover will expire at the end of 2013, unless extended by Congress. If you are interested in making a qualified charitable distribution, please contact us for assistance.

It is possible that Congress may make changes to the laws relating to charitable giving when it addresses automatic spending cuts and other budget issues. LU Business Students Demonstrate Financial Prowess

A team of graduate and undergraduate students from Lindenwood University's School of Business and Entrepreneurship (SB&E) competed this year in the annual intercollegiate Chartered Financial Analyst (CFA) Institute Research Challenge. The University bested five other teams from area schools to advance during its inaugural year as a participant in the invitational tournament.

At the local challenge level, Lindenwood's team competed against groups from St. Louis University, Washington University, Fontbonne University, Webster University, and the University of Missouri-St. Louis. Each group was asked to perform a corporate analysis of Sigma-Aldrich, a Fortune 500 company whose headquarters are located in St. Louis, Mo. Each team compiled a thorough examination of the company's financial profile and made investment recommendations under the guidance of an appointed industry mentors and faculty advisors.

The challenge consisted of two parts: a written equity research report and an oral presentation to a panel of local expert CFA professionals. Lindenwood's team submitted its written report in December 2012 and made its presentation along with all competitors in February 2013 at Edward Jones in Downtown St. Louis.

Judges compiled the scores and, without knowing which schools were represented by which teams, selected Lindenwood as the winner. The team then advanced to the next level of competition against groups from all over North and South America during a tournament in Toronto, Canada, March 20-21.

During the Americas Division challenge, Lindenwood competed directly against teams from the University of Findlay, the Universidad de los Andes, the University of Pittsburgh, Montana State University, and the University of Hawaii. Lindenwood did not advance to the global finals, but its team members left with a strong sense of pride in their efforts and accomplishments.

"We're glad to have taken part in this prestigious competition, because it's given our students practical experience as equity analysts and expanded their networks to include leading industry professionals," said James Boyd, PhD, professor and chair of the Lindenwood SB&E Finance Department. "We're also incredibly proud of our team members for competing against such strong academic peers and doing so well. It speaks to the character of our students and to the quality of our programs."

Lindenwood Community Mourns Loss of Professor Jim Feely

Longtime Lindenwood University Professor Emeritus Jim Feely II passed away March 21, 2013, at the age of 85. Feely taught English, Shakespeare, literature, creative writing, and many other courses at Lindenwood from 1958 through 1997. But as colleague and now-President James D. Evans said, “His learning and teaching connected with many other fields, including the sciences and social sciences.” Evans said that it was not unusual for Feely to note astutely that music has an intrinsic mathematical basis and surmise, for example, that talent in those two disciplines might be expected to go hand-in-hand naturally.

“He linked literature with philosophy and poetry with religion,” Evans wrote in a campus-wide email about Feely’s passing. “He had an extraordinary mind and was the consummate example of the modern-day Renaissance man and the foremost champion of the ‘Lindenwood Commons’ class, which helped teach freshmen how to think along with the great intellectuals.”

Feely’s family said his favorite courses were Shakespeare, Literature and the Art of Love, Creative Writing, The Bible as Literature, and independent study projects with students on topics ranging from Keats’ appreciation for and use of Shakespeare to interrelationships among the works of James Joyce.

Feely was born November 20, 1927, in Bozeman, Mont., to Walter and Adeline Feely. He was a wonderful husband and father, preceded in death by his wife, Marilynne Bulla Feely, and daughter Jeffrie



Lynne Feely. Survivors include his sister, Jayne Feely Loomis, and two sons, James Henry Feely III, and John Warren Feely, a Lindenwood alumnus and current Associate Dean of Evening and Graduate Initiatives. Some of the early highlights of Feely’s Lindenwood career include

- With Alice Parker, presented the English literature survey courses on public television in the 1960s, sponsored by a grant from the Ford Foundation.
- With Professor Hendren and Dr. Sibley in the mid 1960s until the 1980s, developed and taught interdisciplinary general education courses in the humanities that studied world art, literature, and music in relationship to their various world cultures.

Feely had a profound impact on countless students over the years, and he was honored in 1995 with the Emerson Award for

Teaching. He was also known as a civil rights activist, and in the 1960s and 1970s was involved in St. Louis CORE (Congress on Racial Equality) and ACTION.

Memorial contributions may be made to the James H. Feely Renaissance and Literature Award at Lindenwood University.

Basketball Makes Mark on MIAA in Opening Year

The Lindenwood men's basketball team made a big statement in its first season as a member of the MIAA. The Lions finished third in the final standings, just one game behind the conference co-champions.

The Lions showed no fear entering their new league, picking up statement wins over co-champions Central Missouri and Fort Hays State, as well as a victory over NCAA Tournament participant Northeastern State. Lindenwood finished the season with a 12-6 conference mark and a 19-7 overall record.

Lindenwood won by having the top offense in the MIAA. The Lions scored a league-best 78.6 points a game and were one of the top shooting teams in the conference with a .481 field-goal percentage and a .388 three-point percentage. Lindenwood also led the league in rebounding and three-point field-goal defense.

Lindenwood's successful season was built on a team-first philosophy. Only one player was voted as one of the top 34 players in the league, but the Lions still competed for the league title. Nine players regularly saw action, led by second-team All-MIAA Alex Bazzell. The senior guard averaged 16.8 points and 6.2 assists a game. All of the other seniors also contributed throughout the year. The trio of Cody Sorenson, Richie Thompson, and Brett Thompson combined to average 32.3 points and 18.1 rebounds a game, and they shot 56.9 percent from the field. Efan Eren was a key contributor off the bench and averaged 4.9 points and 3.8 rebounds a game.



Attendance is up at most Lindenwood contests, according to Athletics Director John Creer.

Football Opens at Home Sept. 5

The Lindenwood football team will play 10 games in 2013, including nine MIAA contests and five games at Hunter Stadium.

The Lions will open the year under the lights with a Thursday game against Lincoln on Sept. 5. The contest will be the second time in program history that Lindenwood has opened the season with a home Thursday night game.

Lindenwood will celebrate Homecoming on Oct. 19 with a contest against Emporia State. The Lions will also appear on the MIAA Game of the Week two times with an Oct. 5 game at Nebraska-Kearney and a Nov. 9 contest at home against Pittsburg State.

Other games at Hunter Stadium are a Sept. 28 non-conference game with

Missouri S&T and an Oct. 12 MIAA game against Fort Hays State. Lindenwood will travel to Southwest Baptist on Sept. 14, Central Missouri on Sept. 21, Washburn on Oct. 26, and Missouri Southern on Nov. 2.

Lindenwood will be competing in the MIAA for the second season in 2013. Last year, the Lions finished fourth in the league with a 7-3 record.

Women's Lacrosse Wins WILA

The nationally-ranked women's lacrosse team won its second consecutive Western Intercollegiate Lacrosse Association championship in April by defeating Regis University. The Lady Lions were a perfect 8-0 in the WILA conference and ranked 15th nationally headed into the final week of their season.

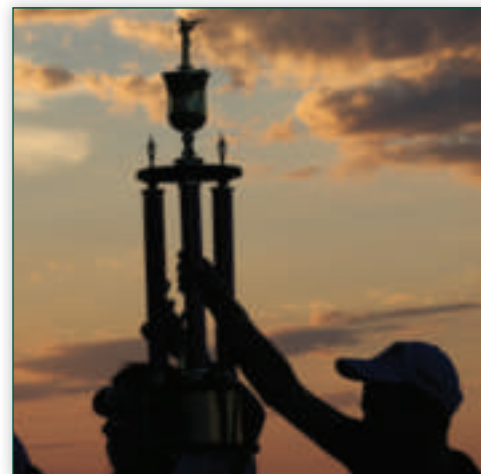

The Lindenwood-Belleville Lynx have been making strides since the athletic department was started in 2009, but this year those strides turned into full-blown success in the first season as a member of the National Association of Intercollegiate Athletics (NAIA).

From the fall and winter sports, to most recently the spring season, each program has found success in the NAIA and has stepped up to the level of competition to show the Lynx's place in their new association.

Under the direction of Head Coach Jeff Fisher, the Lynx football team went 4-6 during its inaugural season, as the squad faced some of the toughest competition in the country. LU-Belleville won four of its first six games, defeating Avila, Iowa Wesleyan, Robert Morris, and Central Methodist.

Both basketball teams had stellar performances throughout the season, with the women putting together a 20-win season and a trip to the USCAA championship game under the direction of

The Lynx baseball took on the challenge of a strong NAIA schedule, facing the top-ranked teams in the country. The Lindenwood women's gymnastics team had high expectations heading into its inaugural season, and the Lady Lions surpassed those lofty goals. The Lady Lions qualified six individuals for the USAG National Championships and captured their first individual national title in program history.

Rachel Zabawa won the national title in the beam event. She scored a school-record 9.875 in the prelims and then repeated that score in the finals. Zabawa tied for first-place with Texas Woman's Bethany Larimer. Zabawa also advanced to the finals in the vault and finished fourth nationally after a 9.7875.

The other Lady Lion to advance to the finals was Alicia Floyd. She scored a season-high 9.850 in the prelims to advance, and then recorded a mark of 9.750 in the finals to finish seventh nationally.

The other Lindenwood gymnasts to advance to nationals were Courtney Heise and Emily Turik in the all-around, Valeri Ingui in the beam and floor exercise, and Trystien Charles in the bars.

As a team, Lindenwood put together its best performance at the Midwest Independent Conference (MIC) Championships. The Lady Lions had a

team score of 193.050, one full point better than their previous season-high.

Lindenwood's coaches were both honored for helping lead the team through such a successful first season. Annie Alameda received a national coaching award at the USAG Championships and Jen Kesler was named the MIC Assistant Coach of the Year.

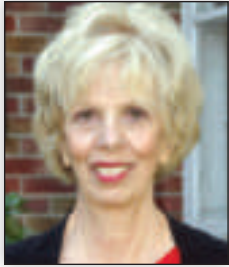

In addition to winning the team title in San Antonio, the Lions also won 10 individual championships. Sarah Hughes earned her third straight women's high overall (HOA) title and Lindenwood swept all three medal positions in men's HOA competition. Matthew Fuqua led the way, followed by Dustin Perry and Colton Raley. Perry also won three other individual championships including men's International skeet, along with the combined International and combined skeet events. Elliot Toll captured the men's International trap and combined trap titles while Casey Jones earned the American skeet championship and Matt Hughes won the combined clay target title. Lauren Mueller hit 155 straight targets to claim the women's American trap championship.

The unprecedented accomplishment by the shotgun sports team has been noticed not only in specialty publications, but also the general media. Garden & Gun magazine followed the team the entire week of the competition and will publish a feature about the 10th championship for the Lions, and head coach Shawn Duloherly was recently interviewed by St. Louis radio station KMOX.
