## MINUTES OF THE SIBLEY SOCIETY

Jan 9th 1863 -

The young ladies of Lindenwood met for the purpose of organizing a literary society. Miss M. G. Brown was called to preside over the meeting. Miss M. L. Anderson to act as Secretary. The object of the meeting was laid before the members and fully discussed. Mr. Barbour kindly offered to draw off a Constitution and By Laws. The meeting then adjourned to meet Jan. 13th.

Jan. 13th. 1863

A meeting was held Jan. 13th according to adjournment. House was called to order by Chairman. Mr. Barbour presented a Constitution which was read before the members, each article was then voted upon. A motion was made that in view of the smallness of the number that the Art. 4th, Sec. 1st with reference to officers be set aside for the present, and that the Officers consist for the present of a President, one person to fill the office of Secretary Rec. & Cor. one to fill Librarian and Treasurer. Motion carried. House proceeded to the election of officers. Miss M. G. Brown was then elected President unanimously, Miss M. L. Anderson Cor. & Rec. Jec., Miss A. Boal Treas. & Liora., Miss F. J. Barbour Sr. A. Officers took their seats. A motion was made to set aside Art. 6th Sec. 1st with reference to an initiation fee. It was thought advisable to consider 25¢ sufficient initiation fee for the present, but resume the regular one the next session. It was proposed that the President read her inaugural address the next meeting. Appointments for the regular duties of society, Misses Boal and Rood debate, subject. "Is the hope of reward a greater incentive to exertion than the fear of punishment. For essay, Misses Apperson & Lewis, selections Misses Gamble & Provines . House adjourned.

Jan. 20th -1863

Society met as usual. House called order. Sec. called the roll, all members present, minutes of last meeting read & adopted. The President read her inaugural address. Reading of essays, selections, and debate followed, decission of the President in favor of the negative, decission of the house in favor of ditto. No new business before the house. Appointments for the next regular metting were made. Misses Provines and Gamble on debate, subject "Is the mind of woman inferior to that of man"? Miss Provines negative, Miss Gamble affirmative.

Misses Buckner & Sigerson essay, selections, Misses Rood and Apperson.

Nothing further before the house. Society adjourned.

Jan 27th -

Society met as usual. House called to order by the Pres. roll called, all members present, minutes of the last meeting read, corrected, and adopted. Society proceeded to regular business, first reading of essays, second debate, subject. "Is the mind of woman inferior to that of man?" Pres. in favor of negative, house ditto, Appointments for next meeting, Misses. Apperson and Lewis on debate, subject "Which was the greater Washington or Napoleon?" essay, Misses Rood & Boal, selections,

Misses Gamble and Buckner. Society then adjourned.

Feb. 5th -

Society met as usual. House called to order by Pres. Secretary called the roll and noted absentees, Society proceeded to regular business, essays Misses Rood & Boal, selections Misses Gamble & Buckner, debate Misses Apperson and Lewis, Miss A. maintained that Napoleon was the greater, Miss L. that Washington was, decission of Pres. in favor of Miss Lewis: By vote of society it was decided that as the number of the society was so small that essays and debate should be alternate. Motion made and carried, Appointments for following week, Misses Rood and Buckner essay, selections Misses Gamble & Apperson. No other business society adjourned.

Feb. 12th -63

Society met as usual. House called to order by Pres. Sec. called the roll, all members present. Society proceeded to regular business. Miss Rood fined 10¢ for non performance of duty, regular duties gone through with. Appointments for next regular meeting. Misses Gamble & Buckner debate subject, "Which affords the most pleasure anticipation or realization?" Miss Gamble affirimative, Miss Buckner negative, selections Misses Provines & Apperson, Pres. laid before the house the propriety of preparing the periodical for the monthly review. No action was taken with reference to the subject. A motion for adjournment was made, house adjourned.

Mar. 12th 3

Society met 12th of Mar. House called to order by Pres. roll called by Sec. All members present. Several weeks have elapsed since the last meeting of society, owing to abscence of the President, Society thought best to defer the meeting until the return of said officer. No decission as but one side of debate was prepared. Miss Buckner fined 10¢ for non performance of duty. A motion was made and carried that the Periodical be published and read at the review at the close of March. Committee appointed to wait upon Mr. Barbour asking hom to excuse the members from regular weekly compositions in order that they might have more time for the paper. Request granted on condition that each young lady be represented in the paper. Elections for editors, Misses Gamble & Boal. On motion a card of thanks was tendered to Mr. John Barbour for a blank book & poems which he kindly donated, also a vote of thanks be tendered to Miss Emma Sigerson for her donation in books. Appointments for next regular meeting, selections Misses Rood & Apperson, essays Misses Sigerson & Lewis, House adjourned.

Mar. 17th 163

Society met as usual, House called to order by Pres. roll called, regular duties gone through with, regular appointments for next meeting. Debate Provines & Barbour, subject, Which is to be prefered a clean scolding wife or a dirty good natured one," selections Misses Buckner & Boal. Elections for new officers. On motion it was decided as the society would receive accessions that the motion Jan 13th be repealed & the regular number of officers be elected. Motion carried, house proceeded to elections, Miss M. G. Brown reelected President, Miss Buckner Vice-do. Miss Provines Secretary, Miss Gamble Treasurer, Miss L. Rood Librarian, Miss Coleman critic, Miss Fannie Barbour fined 10¢ for absence.

Mar. 26th -

Society met as usual. Pres. called house to order, sec. called roll and noted absentees, Society proceeded to regular business, Debate, Misses Barbour and Provines, subject "Which is preferable a clean scolding wife or a dirty good natured one," Miss Barbour mentioned that the dirty good natured wife, Society decided in favor of affirmative. Pres. ditto. Appointments for next meeting were then made, Essay Misses Gamble & Apperson, selections Misses Anderson & Lewis, It was thought Miss Coleman had been elected critic unconstitutionally, her name was therefore with drawn, and her name was then handed in as candidate for membership, which was received, after which she was elected according to the Constitution. Miss Julia Gamble fined for tardiness. Miss Bettie Easton's name was presented to the Society for membership — Miss Fannie Barbour asked for a card of withdrawal from the Society, which was granted. Nothing further before the house, society adjourned.

order and the secretary called roll and noted absentees. The minutes of last meeting were read corrected and adopted. Regular business taken up, Reading of essays first in order, Reading of selections, Misses Rood and Boal, Assignment of duties for following week, Misses Gamble and Apperson essayists, readers, Misses Anderson and Lewis. The name of Miss Bettie Easton having been presented she was elected a member of the society. Misses Anderson and Lewis were fined for non-performance of duty. Miss Brown unanimously elected to fill the vacancy occasioned by the withdrawal of Miss Coleman. A vote was taken on the society badge decided on a rose colored bow. It being the desire of the society to have a motto, Misses Gamble and Rood were appointed a committee to present some mottoes for consideration of the society. On motion house adjourned.

Apr. 9th -63

Society met pursuant to adjournment. Pres. called the house to order. Secretary called roll and noted absentees. The minutes of last meeting were then read, corrected and adopted. The house next proceeded to regular business. Debate Misses Boal and Rood, subjects "Is dancing morally wrong." Aff. Rood, neg. Boal, Decision of Pres. and house in favor of neg. Reading of selections Misses Lewis and Anderson. Appointments of duties for following week. Debaters Misses Anderson & Lewis. Readers Misses Buckner and R. Easton. A motion was made & carried to omit the paper for May. Report of committee on motto indefinitely postponed. On motion house adjourned.

Apr. 13th - 63

By written request of three members a meeting was called on Monday eve to present the names of candidates for membership. The names of Misses Bolton and M. Easton having been presented a meeting was appointed for following eve to take vote. The subject of debate was changed from the one appointed at reg. meeting to the following, "Which exerts the greater influence the man of wealth or man of talent."

Apr. 14th -

Society met according to appointment, house called to order, roll called and candidates elected. The time of meeting was changed from Friday to Thursday eve. House adjourned.

Apr. 16th -

Society met pursuant to adjournment. Pres. called house to order, secretary called roll and noted absentees. Reading of minutes of preceeding meeting. Regular business taken up. Misses Apperson and R. Laston excused for nonperformance of duty. Appointments of duties for following week, Essay Misses Easton, Debate Misses Lewis and Anderson, Readers Misses Boal & Rood. As the number of members had increased, a motion was made seconded and carried that debate become a regular, weekly duty therefore the appointments for two week succeeding were made. Essay Misses Buckner & Apperson, Readers Anderson & Sigerson, debate Misses Gamble & Bolton, subject, "Does novel reading exert a good or bad influence on Society" The members were divided into two classed performing semi-monthly. Miss Buckner was fined for nemperformance of duty. On motion house adjourned.

Apr. 23d.-63

Society met pursuant to adjournment. House called to order, roll called, minutes of last meeting read corrected and adopted. Regular business taken up, Debate, Miss Bolton affirmative, Miss Gamble neg. Decision of Pres. in favor of aff. decision of house in favor of neg. Appointments of duties for following week, Debate Misses Lewis & Anderson, subject, "Is it practicable for young ladies at school to receive the attentions of gentlemen. The following names were presented as candidates for honorary membership, Pres. J. P. Barbour, Mr. S. S. Watson, Rev. R. P. Farris & Miss C. A. Coleman. A call meeting was appointed for the following day to take vote on names presented as candidates for membership. Misses Lewis, Anderson, & Easton fined for nonperformance of duty. House adjourned.

Apr. 27th -

Society met according to appointment. The name of Miss Delia Gibbs having been presented at a former meeting she was unanimously elected a member of the society. House adjourned.

May 1st -

Society met pursuant to adjournment, house called to order by Pres., roll called & minutes of last meeting read corrected and adopted. Reading of essays Misses Apperson & Buckner, selections Misses Anderson & Sigerson, debate Misses Gamble & Bolton. The subject was open to the house and quite an animated discussion was the consequence. Decision of Pres. in favor of aff. of house in favor of neg. Appointment of duties for succeeding week, debate Misses Anderson & Lewis, Readers Gamble and Boal, Essayists Misses Rood & Gibbs, Irregular business; a motion was made to omit the May number of paper the editors for that month were then retained for the June number. The constitution was read for benefit of new members. It was agreed to elect a Pres. for first term next year. On motion house adjourned.

May 8th - 63

Society met as usual. Pres. call house to order secretary called roll & noted absentees, The minutes of last meeting were read, corrected, & adopted. Reading of duties, essay Rood & Gibbs, readers Gamble & Boal, debate aff. Anderson, neg. Lewis decision of Pres. & house in favorof neg. Appointment of duties, debate Misses Buckner & Apperson, essayists Misses Easton, readers Gamble & Bolston. Subject for debate "Do savage nations posses a right to the soil". By invitation of Pres.

Brown, Pres. Barbour favored the society with his presence. He made some very interesting remarks on the debate taking neg. of question also presented a subject for debate "Is Genius innate".

The officers for first term next year were elected. Miss Bolton Pres., Vice Pres. Miss Rood., Rec. Sec. Miss Gamble, Cor. Sec. Miss Gibbs, Treasurer Miss Lewis. Critic Miss Brown. A motion was made, seconded & carried that the constitution be set aside and the Pres. take her seat two weeks before close of school without writing inaugural. The following persons were unanimously elected honorary members of the Sibley Society, Miss C. A. Coleman, Pres. S. P. Barbour, Nev. R. P. Farris, Mr. S. S. Watson. On motion house adjourned.

May 15th - 63

Society met pursuant to adjournment Pres. called house to order, sec. called roll & noted absentees, the minutes of last meeting were read & adopted. Debate, aff. Miss Buckner neg. Apperson. The Pres. decided that the arguments were on a par. Decision of house in favor of aff. Report of committee on motto, Society chose one presented by Pres. Barbour also an emblem sent in by him. A landscape, a mountain in the distance and a youth with a pickerel removing the mountain of difficulty between him & fame. The motto was "Little by little" in French "Pear 'a Pen", On motion house adjourned.

May 22d. -

Society met as usual. Pres. called house to order & secretary called roll & noted absentees. Minutes read & adopted. A motion was made to omit the regular business. A proposition from Pres. Barbour that the Society give a public entertainment on the night of the 24th of June. A motion was made & carried to adjourn to an indefinite call meeting to vote on proposition.

June 1st. -

The Society met at call of Pres. Sec. Stated business before house. A motion was made & carried that the Society hold an open session on the night of the 24th of June. A motion was then carried that debate should be one of the exercises for that night. Election of representatives for that evening were then made. Debate Misses Bolton & Provines. Essayists Misses Gamble, Lewis, Rood Boal. Permission was granted the Cor. Sec. by the Pres. to take money from treasury to buy paper, envelopes, & stamps. House adjourned.

June 8th -

Society met as usual. After debatint the question it was decided that the debate should be omitted and the young ladies be retained on essay. New Pres. took her seat. Debate, Misses Gibbs & Boal, decision of Pres. in favor of aff. decision of house in favor of neg. House admournment.

June 15th -

Society met pursuant to adjournment. minutes read corrected & adopted. The excuses of absentees were accepted. Miss Gibbs fined 50 cts. for non performance of duty for open session. On motion house adjourned.

June 22d -

Society met. Report of officers whose term had expired were read. The Cor. Sec. made a call on treasury for money to purchase envelopes & stamps. On motion house adjourned to meet on the 25th day of September 1863.

Jesie Provines Rec. Sec.

A meeting of the Sibley Society was held in the Hall on the 3d Oct. 1863. The regular time for meeting was deferred on account of there not being members present to constitute a quorum. President Bolton being absent Vice President Rood to the chair, called the house to order and proceeded to business. Rec. Sec. called the roll: Misses Easton, Buckner and Anderson were absent and were fined for unexcused absence. As several members wishes to withdraw and new ones to enter no duties were assigned for the following week. Nothing more before the house Society adjourned.

Society met as usual on the 8th Oct. 1863. President called the house to order. Sec. called the roll all present but Miss Boal. Excuses of absentees received. Minutes read and adopted. The names of Misses Stacy, Johnson, Axtell and Gamble were presented for admission. A motion was made and adopted that a meeting be called for the purpose of woting on the names of new members. Three cards of withdrawal were read. Miss Anderson's was received but was asked to take a week for con-

sideration before acting rashly. Those of Misses Brown and Barbour were not received but they were relieved from the regular duties of the Society. Miss Brown resigned her office as critic. Miss Provines was elected in her place by vote of a large majority. Miss Apperson was elected Treasurer. A motion was made and adopted that the Society have an open session Christmas and that our first paper should appear then. It was also moved and adopted that the proceedings of the Society be kept secret. Duties were assigned for the next meeting. Misses Boal and Gibbs Debate. Subject Is a lawyer justifiable in defending a bad cause? Essayists, Misses

Oct. 15th -Society met on Thursday Oct. 15, 1868. Roll called, Misses Axtell and Provines absent. Excuses of absentees noted. Minutes read, corrected and adopted. President Bolton read an Inaugural address. Miss Buckner failed to perform the duty assigned her was fined 10 cts. Miss Boal was not prepared with debate. She sent an excuse out Miss Rood failed to deliver it. She was fined 5 cts for nonperformance of duty. Miss Gibbs was was prepared but did not read as she was the Negative. They were put on duty for the next week. A motion was made and adopted that the young ladies failing to perform should be put on duty the next week and not be relieved from the regular school duties. The names of those indebted to the society were read out in the Society. The fines were not doubled. It was suggested and finally moved and adopted that the money be appropriated to purchase some books to read from in Society. It was maved that the selection of the books be left to Mr. Barbour, motion adopted and Misses Brown & Boal were appointed on Committee to wait on Mr. Barbour. Miss Anderson requested that her card of withdrawal he received, her request was granted. It was moved and adopted that the new members should not be put on duty

till after hearing the Constitution. Duties assigned, Debaters Misses Boal and Gibbs, Misses Buckner and Apperson and Essays, Readers Misses Easton and Roal. House adjourned on motion.

Oct. 23 - Soc. met Thursday Oct. 23, 1863. Roll called. Misses Stacy, Axtell and Barbour were absent. Minutes read, corrected and adopted. Excuses of absentees received. Debate and Essays followed. President decided in favor of Miss Boal, house in favor Miss Gibbs. An interesting oral debate followed by members of Society. On motion an amendment was made in the constitution in regard to the duties of the critic as Miss Provines wanted to resign her position. The names of Misses Kerr, Davis, Vlstk and Baker were presented for admission.

Duties for following week Debaters Misses Provines & Rood, Miss Rood affirmative, Miss Provines negative, Subject, Is any human act purely social. Essayists gamble & Stacy. Readers Easton and Axtell. On motion house adjourned.

Oct. 29 -

Society met as usual on Thursday Oct. 29, 1863. President called the house to order.

Rec. Sec. being absent on account of sickness Cor. Sec. took her place and called the roll and noted excuses of absentees. Misses Brown & Easton were absent but sent in excuses that were received. Minutes read, corrected and adopted. The regular order of exercises followed. Miss Stacy failed to perform but was excused by Presdt. The debate was exceedingly interesting; pronounced the best since the organization of the Society. President decided favor of the affirmative, the wote of the house was a motion made and carried that all fine Essays and Debates be preserved for the paper. As the duties of the Treasurer were becoming so onerous it was suggested that it would be wise to purchase books for the Library. An animated discussion ensued as to what book should be gotten but it ended in nothing definite.

As it was growing quite late it was moved and adopted that a meeting called on the next day to complete unfinished business.

Friday - 12 o'clock.

Oct. 30 -

Soc. met and proceeded to business. A motion was made and carried that we should have a diologue between Misses Davis and Johnson for the Open Session. Misses Bolton, Provines, Stacy and Apperson were chosen for Essayists. Misses Boal, Gamble and Buckner were elected Edittrisses. Misses Kerr & Clark were put on debate for the next week. Misses Davis & Johnson Essayists. Misses Buckner & Provines were appointed to read selections. On motion house adjourned.

Nov. 6, 1863. -

Soc. met as usual. Presdt. called the house to order. Sec. called the roll, Misses B. Easton and Axtell were absent. It was proposed that Society have a badge. The color was discussed for some time but nothing definite decided upon. Duties were appointed for the next week. Misses Apperson and Buckner were put on Debate, the latter on the affirmative, the former the negative, Subject - Is the course of female Education sufficiently Mathematical. Misses Stacy and Baker essayists, Readers Misses Boal and Gamble. On motion house adjourned.

Soc. met Nov. 26, 1863. Presdt. being absent. Vice President took her place. Rec. Jec. took her place again and called the roll. Misses Bolton, Baker and Kerr were absent.

Had no debate as Miss Baker was absent. Miss Jigerson failed to prepare an essay, was fined. A note was read from Mr. Harris in regard to getting the church permission was granted. It was moved and carried that the exhibition should be at the College. Another was made & carried that if the essays and pieces for the paper were not commenced by the next meeting the Open Jession should be indefinitely postponed.

Misses Bolton, Gibbs, provines & Gamble were appointed on Invitation Committee. Duties for the week. Essayists Misses Buckner & Hamilton.

Debate Rood & Boal. Readers Misses Turner and N. Hamilton. On motion house adjourned.

Dec. 3d. -

Sibley Soc. met on Friday Dec. 3d. President called house to order Cor. Sec. called the roll Rec. Sec. being tardy. Misses Provines, Sigerson and Kerr were absent. The regular order of exercises followed. Debate for last evening was read. President decided in favor of the affirmative. Essays were read. Debate for the evening followed. President decided in fav. of negative.

Duties for next meeting were assigned.

Selections. L. Clark and D. Easton. Society adjourned.

Dec. 9th -

The Open Session well attended and the members acquited themselves with great credit.

Miss Boal, Vice-Pres. Miss Gibbs, Rec. Sec. Miss Gamble, Cor. Miss Buckner, Critic Miss ---- Treasurer Miss Johnson, Librarian Miss Edmonson. On motion house adjourned.
