


# A Message From President Evans The Republic Is Here



In an earlier edition of *The Connection*, I expressed one of my highest goals for Lindenwood: That this University will continue to mature as a true Republic of Ideas that fosters an ongoing conversation among our students, faculty, and all other stakeholders of the University. I had communicated this aspiration in the acceptance speech given at my presidential investiture ceremony, in which I said this:

My personal hope is that we will be stewards of a University environment that prizes and nurtures a respectful and informed exchange of ideas and perspectives, as well as generating excitement about the search for new knowledge. That educational setting would engage all of the students and faculty members in the quest for higher understanding, clearer thinking, and effective communication and application of what is learned

I believe that Lindenwood has already established much of the ideal learning environment espoused above. Here are a few examples that illustrate the latter claim:

Not only do our professors now edit and publish several learned journals (some mentioned in previous letters to you) through The Lindenwood Press, but we now feature several speaker series on campus – each being primarily for our students and their professors but also open to the public. Specifically, Lindenwood enthusiastically sponsors the following lecture programs:

- The Lindenwood University Institute for the Study of Economics and the Environment
- The Professional Educators Series
- Lindenwood's International and Global Studies Speaker Series
- The Lindenwood Speakers Bureau
- Lindenwood's Coffee Conversations

All of these venues for the exchange of information and ideas feature prominent experts, visionaries, and intellectuals in the fields they represent. You can find many of the speakers' names, presentation dates, and topics on Lindenwood's Web page (<a href="http://www.lindenwood.edu">http://www.lindenwood.edu</a>).

On November 7, our Psychology Department hosted a state-wide conference for university students and their mentors, the fifth annual Missouri Undergraduate Psychology Conference, in which 16 Lindenwood students and dozens of their cohorts from other regional universities presented their research papers. How inspiring and rewarding it was to see what these young scholars had accomplished! This is but one example of the many conferences we host each year.

I no longer receive much "advice" from various quarters – both internal and external – about what subject matter Lindenwood professors or guest speakers should or should not be addressing.

Last year our Faculty Council and Educational Policies Committee collaborated to develop Lindenwood's modern statement on academic freedom and responsibility, which has been accepted and is supported by our administration. It reflects the essential components in the concept of a Republic of Ideas.

I would be very pleased to receive your thoughts on my thoughts. Lois and I send you and yours our best wishes for a memorable holiday season and the best New Year ever.

More than 130 students, endowed scholarship donors, and faculty and staff members attended the annual Lindenwood University Endowed Scholarship Luncheon October 28 in the Spellmann Center's Anheuser-Busch Leadership Room. The luncheon provides an opportunity for the endowed scholars and their donors to meet.

President James D. Evans provided a state of the University report and discussed the importance of scholarship to Lindenwood's students. Vice President Lucy Morros thanked the donors for their generous support of the scholars.

Leah Shipley, a senior studying elementary and special education, thanked the donors on behalf of all student scholars. She provided her personal story of how important the scholarship is to her as she pursues her degree. Leah is the St. Charles Alumni Club Scholar and is actively involved on campus as a Student Ambassador, member of Circle K International, and co-captain of the Lady Lion Dance team.

"Meeting my students who received financial help in my name and my late husband's is a very enjoyable experience," said Dr. Betty Osiek ('62). "The endowment is so much more meaningful to me because of getting to know the two individuals who are receiving the help to continue their studies. They were not solely names to me any longer, nor I to them. In addition, for them, it was a special moment of recognition for their past efforts and encouragement for their future studies."

The luncheon concluded with Joe Parisi, Dean of Undergraduate Admissions, commending the student scholars for their accomplishments and for receiving, "a prestigious endowed scholarship."

Parisi said that the endowed scholarship program assists more than 200 students with an estimated \$370,000 annually in scholarship money.

# Men at Lindenwood?

## **History Class Project Revisits 1969 Switch Allowing Males on Lindenwood Campus**

Turbulent would be a good word to describe 1969 on college campuses across the country. There were sit-ins and other protests about issues like the Vietnam War and race. On the Lindenwood campus, an additional issue on the minds of students and faculty was a shift in enrollment policy allowing male students for the first time in the school's 142-year history.

Now, a class called History of Gender in the United States, taught by Professor Kris Smith, is revisiting that time with a project designed to add to the University's oral history. Each of the class' 11 students is producing a 10- to 12-page paper on some aspect of the gender integration of the school; they are each interviewing students from that period about their attitudes and experiences during that time. The finished papers will eventually be placed in the University's Mary Ambler Archives, where they will be accessible for viewing by anyone who wants to look at them.

"Throughout the course, I try to pull in as much as I can about Lindenwood since our history often mirrors national issues with gender," Smith said.

Lindenwood Archivist Paul Huffman proposed the idea after coming across a copy of President John Brown's Jan. 6, 1969, report to the Board of Overseers regarding the change in policy.

"We ... were founded to meet a need that no longer exists," Brown wrote, "for

women are now welcome at almost all the great citadels of learning."

He went on to report that surveys of the top quarter of female high school students indicated that fewer than 5 percent would consider attending a women's college.

Connie Bixler ('71), who received a bachelor's in education from Lindenwood,

said she was personally not in favor of the change in enrollment policy, however, she recalled in her interview with senior Tina Smith, "Most students knew that if Lindenwood was to survive, they would need to do something different."

Mary Ratliff Clark ('70), a second generation student whose mother and aunt also graduated from Lindenwood, said in her interview with sophomore Julian Barr that she also recalls resistance to the change, not just among many students, but among alumni.

"You have to understand," she told Barr, "I hung around with a group of my mother's friends who had gone to Lindenwood. 'Aghast' was not a strong enough word to describe the way they felt about the school accepting men."

She described that first group of 15 male students as an "eclectic" group and remembers that she only had a few classes that had men in them.

Bixler, who went on to a career in education and whose daughter completed an MBA at Lindenwood, said she enjoyed taking part in the project and that it brought back many good memories.

"Lindenwood is a wonderful school and I am excited to see it growing and becoming a major landmark in St. Charles," Bixler said.

### "I Waited 50 Years" — Youthful 80-Year-Old Enrolls in Classes

Florissant resident Tom Gibbons decided to pursue a master of fine arts degree in creative writing and enrolled in the fall term of Lindenwood University's College for Individualized Education (LCIE) accelerated degree program. This doesn't sound unusual, until one considers that Gibbons is 80 years old and recently finished chemotherapy treatments for Hodgkin's Lymphoma.

Gibbons said he feels now is a perfectly good time to undertake a new challenge.

"I waited 50 years," he said. "It's the first time I feel like I really have enough time to try to do this."

Gibbons grew up in Brooklyn, N.Y., and began pursuing a degree in English in 1947 at St. John's University, before honorably serving in the Korean War. After the war, he returned to St. John's to complete his degree in 1958.

Gibbons applied his love of writing throughout his life by writing numerous business pamphlets for his job in sales and later in environmental work. He still teaches English part-time at a local community college and is the official storyteller for the local Ancient Order of Hibernians, an Irish Catholic fraternal organization.

Gibbons and his wife, Ann, have raised

five children. They have been a host family to a dozen high school and college-age students from around the world.

While Gibbons' hectic schedule may have finally settled a bit, his insatiable appetite for knowledge and adventure has not.

"This is just for me because I love to learn," he said. "I really don't know what I'll do with my career after I get my master's. Maybe I'm just going to enjoy the satisfaction of knowing I got it."

# Board Member Ohmes Receives 2009 Sibley Medallion of Honor

Ronald W. Ohmes, a member of the Lindenwood University Board of Directors since 1991, received the Sibley Medallion of Honor on November 6 for his deep, ongoing commitment to the institution.

Ohmes retired several years ago from Kirchner Block and Brick, which has supplied an estimated 4.4 million bricks for Lindenwood construction projects since 1994. Before he retired, Ohmes led Kirchner through a period of growth and expansion, not unlike what Lindenwood has experienced over the years. Ohmes serves on the facilities committee and the finance and audit committee of Lindenwood's Board of Directors. He is a generous donor, naming rooms in both the J. Scheidegger Center For the Arts and Harmon Hall.

"Ron's love for Lindenwood has grown along with the campus," said John Hammond, treasurer for the Board of Directors. "...when he retired in 1999, he began stepping away from all the community organizations and boards he had loyally served for so many years. But he didn't step away from Lindenwood."

Hammond and President James D. Evans presented the award to Ohmes at Lindenwood's Butler Society Dinner at the Lindenwood University Club. The exclusive

# Dust Storm of 1934 Had Unique Impact on Lindenwood Girl

Dear Alumni Office,

As I relive my Lindenwood years (what else do 91-year-old women do?) I thought of the night the big dust storm hit the campus. In fact, I wondered how much of the history of the dust storms was being taught, aside from *The Grapes of Wrath* book and movie.

The dust storm in the fall of '34 took the entire St. Louis area by surprise. No one had predicted they would come that far east. Certainly the campus of Lindenwood was caught completely by surprise. Others may have different memories.

At that time only upperclassmen were permitted off campus during the week. Freshmen thus were denied any chance of seeing a movie that would be in St. Charles for only three days during the middle of the week. As I was teaching the freshman class of tap dancing (under the request of Marg. Stookey, head of the dancing department), I really wanted to see Fred Astaire and Ginger Rogers starring in a movie at the local theatre in St. Charles. But of course, that meant the house mother of Niccols would have to stay up to let me in as all doors were locked at 10 p.m., and absolutely no permission was granted.

Not to be deterred, I talked my roommate, Marie Christensen Robb, into joining me. We waited until we were quite sure all the upper classmen had left for the movie, and we left via the fire escape on the back of the dormitory. We were shocked to find a flood light mounted on our building. As we were adjacent to the golf course, we ran across the course to the stone fence bordering the campus along the highway. We scrambled over the fence to walk on the street parallel to the main street to town

to avoid any chance of being seen. We arrived just as the movie began and slipped into seats in the back row. We truly hated to leave the movie before the end, but we could not risk the chance of having to be seen.

As we ran out of the theater and down to the corner we were met with a blast of wind and dust that nearly knocked us off our feet. We stumbled and ran hoping we could find our way back in the darkness. When we came to the highway we actually had no idea where the campus ended. Relieved to feel the stone wall after we ran across the highway in the dark, we followed as far as we felt was beyond the campus. Scrambling over it we were delighted we were on the golf course, and a dim light showed up on the right in the distance. Yes, it was the flood light on the back of our dorm.

As we scrambled up the fire escape we prayed that no one had seen the window open and closed it. We congratulated ourselves as we were able to scramble through, getting to our rooms unseen. Nobody saw us, but two sets of very dusty footprints from the fire escape to our bedroom was all the housemother needed to see the next morning.

We were told to report to Mr. Motley in the admissions office for punishment and that he would report our crime to the student body, who would meet in assembly the following day. They would report from the stage how long we would be "campused" and we would be humiliated as the entire student body would laugh.

Trembling with fear, we entered his office. He greeted us with a "controlled" smile. "How was the movie?" he asked. We both replied as the same time, "Wonderful! You have to see it!" After a sufficient pause he asked, "And how did you find your way back in the storm without being seen?" As we related the tale of finding our way across the golf course, our fear of being seen by a sophomore, his smile broadened. He explained the seriousness of being off campus without permission. Two incidents and you are sent home. After assuring him it would never happen again, he promised to keep it to himself. He would not tell the student body president.

Mr. Motley kept his word. No wonder he was so well-loved by the students. As for the dust storm, it covered everything on campus. Dusty footprints entered every building. The sneezing and coughing and red eyes of most of us lasted only a day or so. I don't believe as heavy a dust storm hit eastern Missouri again.

I hope that you get a good laugh out of my memory of 1934, and that everyone has an enjoyable year (and no dust storms).

# Students Give Kubicek Hope for Future of Mental Health Care

Ken Kubicek's first taste of teaching at the college level came in 2006, when he was invited to come teach a couple of classes by Marsha Buono, the coordinator of the counseling program at Lindenwood's Belleville campus at that time.

"She had seen a couple of local articles I had written for a magazine called Health Now in the Sunday Belleville News Democrat and called me asking if I would be interested in coming in to teach some classes in substance abuse and family counseling," Kubicek said in his neatly organized office in Lindenwood—Belleville's administration building. "That was the summer of '06, and I had taught as an adjunct for the first time in spring of

'06 at Saint Louis University. I really liked it and told her that if she ever had anything

permanent available I would be interested."
About eight weeks later, Buono called about an opening, and he has been on Lindenwood's full-time faculty at Belleville ever since. Kubicek's career started in teaching at the high school level; he was a math teacher at St. Henry's Prep Seminary, an all-boys' boarding school in Belleville.
Most of the teachers there were priests, he said, and because he had a couple of accounting classes on his transcript, he was

also appointed the school's bookkeeper.

He later transferred to a position as business manager at the Shrine of Our Lady of the Snows, but after four years he wanted

to get back into teaching and was appointed retreat coordinator at King's House, a retreat center in Belleville.

"The hot topic at that time was adult children of alcoholics," Kubicek said. "So, I designed a series of retreats, workshops, seminars, and support groups for people like that. I realized my heart was in mental health and chemical dependency, so I got a job at Memorial Hospital in Belleville and started my doctorate in counseling and family therapy at Saint Louis University."

Kubicek worked for 16 years in inpatient and outpatient psychiatric and chemical dependency at Edgewood Chemical Dependency and Treatment Center in Edwardsville, Ill., and Memorial

Hospital, which is where he was when he got that fateful call about teaching at Lindenwood.

In addition to teaching, Kubicek has also published a book, *Recovering Alcoholics: Why They Say They are Successful*, and is working on another one that focuses on alcoholics who have quit drinking without the help of Alcoholics Anonymous or other external support.

"I enjoy teaching, particularly having input into the future careers of people entering the mental health field," Kubicek said. "It surprises me, the quality of people going to work in mental health—the intelligence and desire to help people. It gives me hope for the future."





The number of members continues to grow, making planned giving expectancies the key in our development efforts.

IRA Rollover Institutional Advancementjust processed another savvy donor's IRA rollover gift. 

# Hall of Fame Adds Nine to Membership

The Lindenwood University Athletic Hall of Fame opened its doors during Homecoming Weekend and ushered nine new members into the exclusive club that represents the very best in the history of Lions and Lady Lions sports.

The Class of 2009 was inducted at the third annual Hall of Fame Banquet on Oct. 10 and more than 100 people were present at the emotional event welcoming in the newest members.

Leading the 2009 class was meritorious service winner Randy Biggerstaff, a Lindenwood employee since 1997 who started the school's athletic training education program. Biggerstaff fondly remembered inductees Steve Crotz, Max Brown and others, and thanked the Lindenwood administration for the "opportunity of a lifetime."

Crotz, who served as Lindenwood's athletic director in the mid-1990s, earned induction honors in the coaching category for leading the women's basketball team to five conference championships in his six seasons at the school.

Five student-athletes earned a place in the Hall of Fame: Max Brown (football), Marijke Callebaut (women's soccer), Edward Donnie Dillard (track and field), Skip Hall (men's basketball/baseball), Branko Savic (men's soccer), and Kelli Wind (diving).

Brown was a three-time all-conference quarterback who led Lindenwood to its first postseason appearance in 1998. Brown joked with Biggerstaff, his former trainer, and said he would love to play again on the turf at Harlen C. Hunter Stadium.

Callebaut was a three-time All-American and led the Lady Lions to three NAIA

quarterfinal appearances.

Dillard was the first Lindenwood athlete to win an individual national championship when he won the 60-yard dash at the 1994 NAIA Indoor Championships.

Hale was a two-sport star who earned all-conference honors in baseball and basketball in the late 1970s.

Savic collected 80 goals and 58 assists, and was a four-time All-American in his career from 2000-03.

Wind was a three-time national champion diver and was named the NAIA Diver of the Meet in 2002.

The final induction was the 2001-02 roller hockey team which won the NCRHA National Championship and started a string of seven straight national titles for the program.

# Volleyball Continues Dominance; Soccer, Field Hockey, Water Polo Wrap Up

It is a great accomplishment for any team to go undefeated for an entire conference season, but the Lady Lions volleyball team has taken it to another level though in 2009 by not losing a conference match for the third consecutive season. Lindenwood went 28-11 during the regular season and captured its fifth straight HAAC Championship.

#### Soccer

Both Lindenwood soccer programs had roller coaster 2009 campaigns, but when the dust settled the Lions and Lady Lions tied for fifth in the HAAC standings. The women's soccer team defeated four nationally-ranked teams but struggled

offensively in conference play and finished with a 4-4-1 mark. The men's team played for second-place in the HAAC on the final day of the regular season but lost and ended with a 5-3-1 HAAC record.

#### **Field Hockey**

Under first-year head coach Meg Lake, the Lindenwood field hockey team won six of its final seven games to finish with a 6-5 record. The late season push enabled the program to finish above .500 for the third straight season.

#### **Men's Water Polo**

The first conference championship of the 2009-10 school year came in the pool

when the Lions water polo team won the Missouri Valley Division Championship. Lindenwood went 14-5 during the regular season and advanced to the Division I National Tournament in its first season at that level.

### Undefeated Lions Enter Postseason on Top


Lindenwood University football Coach Patrick Ross has built such a strong program that expectations are always high. Despite the lofty goals for the 2009 Lions, Lindenwood easily exceeded them during the regular season with one of the top teams in school history and one of the most explosive offenses in NAIA history.

The No. 3-ranked Lions finished the regular season with a 10-0 record, just the second time at Lindenwood that a football team has not lost a game before the postseason. Lindenwood captured its third Heart of America Athletic Conference (HAAC) Championship in the last six years and extended its conference winning streak to 19 games.

The turning point when the Lions

turned their season into something special came during week three of the season against nationally-ranked Missouri Valley. Quarterback Philip Staback led a last minute drive and threw a game-winning touchdown pass with just 20 seconds remaining. A week later in a top-10 showdown with MidAmerica Nazarene, Lindenwood delivered an early knockout blow with 21 straight points in the first five minutes of the game. With wins over the other two top teams in the conference, Lindenwood cruised through its final six games without another game being closer than 10 points.
