DAYTIME ENROLLMENT SHOWS SLIGHT DECLINE

Total full-time day enrollment this fall is 429 students as compared to 446 last fall. Despite a decline of 17 students this year, both the number of new students attending day classes and the number of students living on campus have shown sharp increases, President James I. Spainhower reports.

Currently, there are 216 students living on campus, compared to 138 last fall. This year's resident population is the highest since 1977 when Lindenwood had 221 students living in dorms. New full-time day students total 181, compared to 128 students last fall.

"More important than the number of new students is the quality," Spainhower said. "Their grade-point average and ACT scores are above that of the national average for entering college students. I expect total headcount to be slightly under last fall's 1,985 total. But, by the second semester, I expect enrollment to exceed 2,000 students," he added. Last fall's enrollment was the highest in the institution's 156-year history.

LINDENWOOD BOARD OF OVERSEERS EXPANDED

The Lindenwood College Board of Overseers, an advisory body to the board of directors, is operating at nearly maximum strength for the first time in more than a decade. According to President Spainhower, Lindenwood's bylaws call for a board membership of up to 21 to serve under the direction of the board of directors. Spainhower has been instrumental in recent months in securing nominations of individuals for service on the board of overseers. With all appointments confirmed by the board of directors, members, several of whom have voting rights on the board, serve for three-year terms.

Area residents appointed to serve on the board of overseers include Roger A. Deppe, superintindent of St. Charles Public Schools; St. Charles County Court Judge Thomas Glosier; William G. Lewis, public relations manager of Continental Telephone Co. in Wentzville; Boyle O. Rodes, coowner of Ellis, Rodes, Meers & Co., a St. Charles-based insurance company; Frank E. Roeder, Jr., vice-president of engineering and physical resources for Schnucks Markets, Earth City; David Skiles, president of Landmark Bank, St. Charles; Mrs. Henry K. Stumberg of St. Charles, a Lindenwood alumna; and St. Charles Mayor Melvin Wetter.

Other recently-appointed members are St. Louis County Councilwoman Ellen Conant; Mrs. Morton C. Mallory of Chesterfield, a Lindenwood alumna; Rabbi Alvin Rubin of Temple Israel, Creve Coeur; KMOX-TV newscaster Robyn Smith, a Lindenwood alumna; and Mrs. Dorothy J. Trump of St. Louis, also a Lindenwood alumna.
