Alumnae Officers Ask Help; Deserve It

Dear Alumnae:

Lindenwood alumnae everywhere must be pleased and proud, as is the college administration, at the initiative of the officers of the Lindenwood College Alumnae Association and at their plans for making the association an effective organization as outlined in their recent letter to you. Their goal is to make the association an instrument of service to alumnae clubs, a bond between individual alumnae and their college, and an organization of strength for the college.

Their enthusiasm and energy will receive the overwhelming cooperation of Lindenwood women, I feel sure. The last of the letters were mailed only five days ago, and already every mail is bringing returns. On behalf of the officers, I wish to remind you, if you have not replied by the time this bulletin reaches you, that your response is eagerly awaited.

The officers are hoping for an unprecedented return from Lindenwood women. They need your one dollar dues to finance the ambitious program which they have outlined, and your college needs your gifts to carry on its program. I call your attention to the story in this bulletin about the Missouri College Joint Fund Committee, Inc., which states that corporations which are asked to support privately supported liberal arts colleges repeatedly inquire, "How strong is your support from your own groups?" Outside gifts will come to Lindenwood in large measure in proportion to the support it receives from its own alumnae.

College Joint Fund Committee Expands Program, Appoints Dr. Eugene Page Director

The Missouri College Joint Fund Committee, Inc., composed of all 14 of Missouri's four-year, church-related, privately supported colleges, early this spring expanded its program by employing Dr. Eugene R. Page of Webster Groves, Mo., as full-time executive secretary. Through the committee the participating colleges, including Lindenwood, jointly seek support from corporations, instead of making 14 separate appeals.

Dr. Page is acquainted with college education in Missouri through his former posts as chairman of English at Central College, 1936-43, commander of the Navy V-12 Unit at Westminster College, 1943-44, and assistant dean of University College at Washington University, 1946-52. He has gained business experience through serving as educational director of the St. Louis Chamber of Commerce and executive secretary of the Missouri Consumer Finance Association.

Support from corporations is sought to *supplement*,

A recent report on alumni giving in the country states that with an average gift of less than \$25, alumni gave over 25 million dollars of expendable money to their respective colleges last year. "This, as living endowment," the report continues, "is the same as interest on 625 million dollars or nearly three times the amount of the Ford gift."

You may be interested to know that in each of four recent years, 1951, 1953, 1954, and 1955, alumni of a neighboring Missouri college contributed more to the alumni fund than the college's total income from endowment.

What your alumnae officers and your college are hoping for is that large numbers of alumnae will make contributions, however small. One alumna, responding by return mail to the officers' letter with her dues and a small gift to the college, wrote that heretofore she had been embarrassed to respond with a small donation, because she had assumed the college was interested only in large gifts. She said that now that she realizes that the goal is many gifts, large or small, she is happy to send hers.

I salute, as I am sure you do, the zeal of Donalee Wehrle Hood, your association president, and the other officers. They meet often. They work hard. They have big plans and high hopes. They need your dues, your moral support, your ideas, and your willing work. I know you will give them all these things.

not replace, the individual efforts of the colleges and the loyal assistance of their own supporting groups. In fact, the success of the program and the willingness of corporations to participate depend in large measure on the colleges' assurance that their immediate "families" of alumni, friends, board members, church members, and others are continuing to do their share.

Lindenwood has shared in fund gifts from more than 50 corporations to date, but the question most often asked is, "How strong is your support from your own groups?"

The work of the joint fund committee is carried on by the 14 presidents and the executive secretary. Lindenwood's President F. L. McCluer is president of the committee. The Missouri committee is one of 35 similar state or regional associations.

Chapel Cornerstone Laid May 6 In Impressive Ceremony

The new Lindenwood chapel came nearer to reality on Sunday, May 6, with the laying of the cornerstone. The ceremony started with a service in Roemer Auditorium and continued, following a procession, at the site of the rising building which will serve Lindenwood College and the congregation of the St. Charles Presbyterian Church.

The Rev. Dr. Harry T. Scherer, minister of the Webster Groves Presbyterian Church and president of Lindenwood's board of directors, preached the sermon in Roemer, where the service was opened with a call to worship and prayer by the Rev. Dr. W. Sherman Skinner, minister of Second Presbyterian Church in St. Louis and member of the LC board. Scriptures were read by Ann Carlisle, senior of Petersburg, Ind., and president of the Student Christian Association, and Russell Crider, Jr., of the Westminster Fellowship of the St. Charles Presbyterian Church.

Greetings were given by the Rev. Charles E. Andrus, minister of First Presbyterian Church in Hannibal, Mo., who is moderator of the Missouri Synod. Two anthems were sung by the St. Charles Presbyterian Church choir under the direction of Miss Pearl Walker, professor of music.

Dr. F. L. McCluer, president, and the Rev. Thomas

C. Cannon, minister of the St. Charles Presbyterian Church, were joined in the cornerstone laying services by the following: Mr. Arthur Goodall of St. Louis, member of the LC board; Mr. A. F. Berger of Ownesville, Mo.; the Rev. W. Robert Steinmeier of Nelson Presbyterian Church, St. Louis; the Rev. G. Scott Porter of the Presbyterian Church in Rolla; the Rev. R. A. Schondelmeyer of the Presbyterian Church in Steelville; the Rev. Dr. M. F. Stuart of Tyler Place Presbyterian Church in St. Louis, and the Rev. Dr. W. Davidson McDowell of Ladue Chapel in St. Louis County.

The service was held after this issue of the bulletin went to press.

Lindenwood's 129th Commencement To Be Held June 2

Mayor H. Roe Bartle of Kansas City to Give Address—Dr. Theodore A. Gill to Preach Baccalaureate—32 Seniors Candidates for Degrees

Mayor H. Roe Bartle of Kansas City, a lawyer and youth leader, will give the address at Lindenwood's 129th annual commencement on Saturday, June 2, at 10:30 a. m. Dr. Theodore A. Gill, former dean of the chapel who left Lindenwood in January to become managing editor of the "Christian Century" magazine, will preach the baccalaureate sermon at 7:15 p. m. on Friday, June 1. Thirty-two seniors are candidates for degrees.

Dr. Oreen Ruedi (A.B. 1924), professor of sociology at Southwest Missouri State College, Springfield, will be awarded the honorary degree of doctor of laws. She holds an M. A. degree from Smith College and a Ph. D. degree from Clark University.

Dr. Ruedi's picture was carried in the February bulletin, which announced her appointment to membership on the National Social Studies Committee. As was related in that bulletin, she is co-author of a social problems textbook, "The American Way of Life," and formerly taught at Mount Union College in Ohio and Hollins College in Virginia. She is active in the Amer-

ican Association of University Women, the Missouri Association for Social Welfare, and welfare and mental hygiene organizations in her community.

Mayor Bartle holds the LL. B. degree from Chattanooga College of Law, the J. D. degree from Hamilton College of Law, and two honorary degrees, an LL. D. from Missouri Valley College in Marshall and a Doctor of Humane Letters from Center College in Kentucky. He has been president of the board of Missouri Valley College since 1945, and served as its president in 1948-51.

He is a member of numerous boards and commissions, including the executive committee of the National Conference of Christians and Jews, from which organization he received the citizenship award in 1953, and the national board of the National Council of Churches of Christ in U.S.A. He is an executive of the Kansas City area council of the Boy Scouts of America. His daughter, Mrs. John James Taylor (Margaret Roe Bartle), attended Lindenwood in 1942-43.

Women's Vote Won by Struggle, Mrs. Gellhorn Tells Students

Young women of today who take for granted their right to vote at the age of 21 might value that right more if they knew something of the struggle to achieve it, Mrs. George Gellhorn of St. Louis, civic leader and pillar in the League of Women Voters, told Lindenwood students recently.

Mrs. Gellhorn spoke at the annual Citizenship Day Convocation on the campus, at which Mayor Henry C. Vogt of St. Charles administered a citizen's oath to students who will be of voting age by next November.

In a lively, colorful talk Mrs. Gellhorn gave details of the long campaign in Missouri, in which she participated, to get the state legislature to act favorably to give Missouri women the vote. She told of a parade which the women held in St. Louis, during a state Republican convention, in an attempt to get the party to put suffrage in its platform. The women wore white, carried banners, and one woman rode a white horse at the head of the parade.

Again when the Democrats met, the women, carrying yellow parasols, lined the streets through which the delegates walked from their hotel to their convention hall. On the lawn of a public building along the route, the women had a striking tableau: A woman dressed as the Statue of Liberty was centered on a platform, flanked by women wearing banners of the states which already had granted suffrage, and lying at their feet were women dressed in black who represented the women of Missouri, still denied the vote.
