A Joint Church and Chapel

THE PURPOSE of a liberal arts college is to develop and foster intellectual and moral integrity. In a successful liberal arts college young people learn how to think, they acquire a fine independence in their own thinking without scorn of contrary opinion, and they become sensitive to the good and to the beautiful.

We are striving at Lindenwood College to develop and maintain a community in which intellectual life may flourish and spiritual truth may be apprehended. We seek to be a community of scholars and students united by mutual respect and affection, by a shared eagerness to know the truth in the realm of the spirit as in the realm of things.

The river without banks loses direction and power. Learning without the faith and hope of religion may not have lost power but it has lost the direction that makes the use of power salutary. A Christian college is free to assert its belief in the Christian faith as the soundest basis for the cultivation of character. It is not sectarian nor is it afraid of the discovery of new truth. It must be hospitable to all truth, proud of its religious faith, fiercely free.

Lindenwood, we hope, is such a college. Its facilities have been provided in large measure by the church of which it is a part. Indeed the college is the church in one aspect of its life and it is proud of its identification with the Synod of Missouri of the Presbyterian Church, U. S. A.

For this reason the recent decision of the Board of Directors of the College and of the congregation of the St. Charles Presbyterian Church to unite in erecting a house of worship to be used by each is of far reaching significance. The College has no chapel building. The St. Charles Presbyterian Church, composed of the congregations of the former First Presbyterian Church (U. S.) and of the former Jefferson Street Presbyterian

Church (U. S. A.) has no adequate sanctuary. The logic of the situation compelled consideration of the possibility of a joint effort. This joint enterprise was endorsed by the Synod of Missouri at its last meeting as it gave its approval to a campaign within the bounds of Synod for the College's share in the cost of such a building. This enterprise is being carried on by a committee of ten, five from the congregation of the Church and five from the Board of Directors of the College. Mr. P. John Hoener has been employed as architect and preliminary plans have been examined by the committee. It is estimated that the total cost of the building will be between \$400,000 and \$450,000. Of this amount \$150,000 will be raised by the St. Charles Presbyterian Church. The campaign for the College's share of the funds is being organized now and will be carried to the churches, to alumnae, and to friends of the College during the spring.

The building will be located on a four and one-half acre lot recently purchased by the Church immediately adjoining the campus of the College. The sanctuary will have a seating capacity of 90+. The College will use the building for its regular chapel and vesper services and such other public meetings as may be appropriate in it. The College will also have office space in the building for the Dean of Chapel and adequate room space for its own nursery school.

We rejoice that this cooperation will enable the Church and the College to provide a finer building for less money than either might secure alone, but economy is not the paramount thing. In joining together in the use of this house of worship the Church and the College alike will be strengthened, each in its own life and both together in their life in this community. The service that each may render to God's Kingdom will, we believe, be extended.

Religion in Life Week Led by Dr. Hans Hofmann

LATER this year Evanston, Ill., will be the site of the second assembly of the World Council of Churches. Not again in our lifetime will this extraordinary gathering take place in our country. Meeting once every six years, and with more than 50 countries waiting to be host to the World Council, it will be a long time before another of these historic assemblies of world Christians comes to America.

The importance of the occasion is reflected in Lindenwood's plans for its own Religion in Life Week (Feb. 14-18). Ordinarily, this week of religious emphasis is given over to arguing the case for Christianity. This year, instead, the leaders used as their subjects the topics to be discussed at Evanston. The aim was to communicate to the students something of the spread and breadth of truly Christian concern. Discussion centered on faith and order, missions, voca-

tion, social problems, and international relations. The outcome should be a new sense of the scope of the Christian faith, for or against which all must finally decide. An important additional effect of the week should be a better informed understanding of the widely publicized Evanston meetings in August.

Anticipating the cosmopolitan character of the World Council sessions, Lindenwood's meetings were led this year by Dr. Hans Hofmann, lecturer at Princeton Seminary in Princeton, N. J. Dr. Hofmann is a young Swiss minister and theologian who took part of his doctoral work at Union Seminary in New York City. Last year he was Chaplain of the University of Zurich, in Switzerland. His collaboration with Lindenwood's chaplain at St. Charles is a sequel to their cooperation on leadership of the Religious Emphasis Week at Princeton University earlier this school year.

Nuelsen in Arlington, Va., where they will live again.

Lindenwood to Be Host in March for Human Relations Conference

Lindenwood will be host to representatives from accredited colleges and universities in the Mississippi valley, March 18-20 for a Human Relations Conference.

Norman Cousins, editor of the Saturday Review, will be a featured speaker at the conference. The conference will open with a lecture on Thursday evening, March 18, by Dr. Morris I. Stein, clinical psychologist at the University of Chicago, on sources of tension within the individual. On the following morning, Dr. Thomas Eliot, chairman of the Department of Political Science at Washington University, formerly from Harvard and former congressman from Massachusetts, will give a lecture on the tensions involved in group relationships, involving the area of prejudices and international conflict.

Mr. Cousins will speak on Friday evening on the general theme of what can be done by individuals about these problems. Saturday morning, March 20, will be devoted to a general question and answer period and to the showing of relevant moving pictures.

Plans for the conference have been made by a committee of administration and faculty members, aided by a student committee headed by Sandra Lunak of West Chicago, a senior majoring in psychology.
