

Lindenwood's 127th Commencement To Be Held May 29th

Federal Judge Florence Allen to Give Graduation Address—Rev. Dr. C. Ralston Smith Will Preach Baccalaureate Sermon

LINDENWOOD COLLEGE'S 127th annual commencement will be held at 10:30 a.m. on Saturday, May 29, climaxing a weekend of activities for seniors and their families. Twenty-nine seniors are candidates for degrees. Following custom of recent years, the commencement program will be held outdoors if the weather permits.

Dr. Florence E. Allen of Cleveland, judge of the U. S. Court of Appeals, will deliver the commencement address. The baccalaureate sermon will be preached in Roemer Auditorium on Friday night, May 28, at 7:30 o'clock, by the Rev. Dr. C. Ralston Smith, pastor of the First Presbyterian Church in Oklahoma City.

Other activities include the President's reception honoring seniors and their families and friends to be given with the assistance of Alpha Sigma Tau at the home of President and Mrs. F. L. McCluer following the baccalaureate service on Friday; the annual senior prayer meeting with the President at 7:15 a.m. com-

mencement day, and the breakfast for seniors, their families and the faculty at 8 a.m.

Judge Allen is the first woman to be appointed to an important judicial post in this country. Born in Salt Lake City, Utah, she received her A. B. and A. M. degrees from Western Reserve University and her LL. B. from New York University. She holds honorary degrees from 17 institutions of learning.

She began the practice of law in Cleveland in 1914. In 1919-20 she served as assistant county prosecutor of Cuyahoga County. In 1920 she was elected judge of the Court of Common Pleas in Cleveland, and in 1922 she was elected to the Ohio Supreme Court. She served on the Supreme Court until 1934 when the late President Roosevelt appointed her judge of the United States Circuit Court of Appeals for the Sixth Circuit, which includes Michigan, Ohio, Kentucky, and Tennessee.

Judge Allen was Lindenwood's commencement speaker four years ago, in 1950.

Five Seniors Awarded Fellowships

Jo June DeWeese of Hugo, Okla., senior English major, was awarded a national Woodrow Wilson fellowship for graduate study next year at the University of North Carolina. Miss DeWeese was one of 25

woman in a total of 144 college seniors who received Wilson fellowships. Her fellowship is for \$1,610.

At Lindenwood Miss DeWeese is president of Butler Hall and of the Poetry Society; an editor of the Griffin, literary magazine; a member of Alpha Sigma Tau, upperclass scholastic honorary. Last year she was a Washington Se-

mester student, and this year she is writing original poetry as an honors project in English.

Choosing from four fellowships offered her by four institutions, Yu-Chen Li, majoring in both biology and chemistry, has accepted a \$1,500 fellowship in biochemistry at the University of Wisconsin. An honor student during her four years at Lindenwood, Yu-Chen this year is president of Alpha Sigma Tau.

Three other students had received graduate scholarships by the time this issue of the Bulletin went to press.

Janie Evans, biology major from Malden, Mo., has a \$1,200 fellowship for graduate study in education, preparatory for secondary school teaching, awarded jointly by the George Peabody College for Teachers and Vanderbilt University in Nashville, Tenn.

Cora Lee Critchfield, art major from Tecumseh, Neb., was awarded a tuition scholarship of \$720 for graduate study in history of art at the University of Chicago. Mary Nell Van Bibber of St. Charles, majoring in education, has a tuition scholarship for a year at the Nursery Training School of Boston, affiliated with Tufts College.

MORE OR LESS PERSONAL

Social welfare work in Wisconsin, three years of overseas Red Cross work during World War II, and administrative work in welfare service have added up to a busy, useful life since her graduation for Lillian Nitcher (A. B. 1933). These facts are brought out in a recent, lengthy feature story about Miss Nitcher published in the Wisconsin State Journal and sent to Lindenwood by Josephine Lupfer Fitschen (1924-26).

Miss Nitcher since 1948 has been associate executive secretary for the Madison (Wis.) Community Welfare Council. In addition, she is co-director of welfare in the city-county Civil Defense organization, a member of the Madison Mayor's committee to study teen-age drinking in Madison and of the Governor's state committee on children and youth.

During the war she served with a Red Cross unit for an American general hospital near London, and later at a hospital in Augsburg, Germany. She received a citation for her outstanding work in the Red Cross. Miss Nitcher lives at 1 Langdon St., Madison.

Continuing in the field of social work, I went to the University of Chicago and in March 1948, secured my MA in the School of Social Service Administration. Since my specialization was child welfare, I first worked in a private children's agency and later with the Illinois Department of Child Welfare. In the fall of 1949, however, I married Bob who was at the University of Chicago working towards his Ph. D. in Physics. We stayed in Chicago and I continued to work until Bob completed his work in June, 1953. We also stayed long enough to have Ann Phyllis, who was born June 3, 1953. The following month we were here in Lawrence with Bob a member of the faculty in the Physics Department at the University of Kansas. We are happy in our new location and enjoy our participation in the many activities of the University and town."
