# *Lindenwood's Program*

THE STRENGTH of higher education in the United States is due in part to the differing kinds of institutions in which its offerings are made available to youth. Some of our colleges and universities are financed by taxes, others receive no tax moneys but depend for support on voluntary gifts; some are owned by the state, some by a church, and some by a private foundation. The accountability of these several institutions to various bodies enables each to help others to maintain freedom from improper political or other interference.

Then, too, even among the liberal arts colleges we find variety — the arts and science school in the university with ten to thirty thousand students, the co-educational college with three to six hundred students, and institutions of similar size for women or for men are found throughout the country. Without question, good work is being done in institutions of all these types. To believe in the merit of the program in one type of college is not to deny that there is significance in other programs. Here at Lindenwood we are strengthened by a sense of partnership with those in other types of colleges. Our understanding of our own program and our confidence in it do not lead us to believe that it is the only good program for the education of young women.

But it is a good one! We believe it is an unusually good one, carried on by a distinguished group of teachers supplied with excellent facilities. This program is designed for the education of young women in a college where the education of women is the sole consideration. We understand what we are doing and know why we are doing it. Our enthusiasm for this program has not confined us to a rut, but has made us alert and sensitive to new ways to accomplish our purposes.

During the next few months this space will be

used for a series of comments on the Lindenwood program. Some of the advantages we have in a college for women will be pointed out, and particular ways in which we make use of these advantages will be set forth.

The details of our program may be seen best against the background of our hope that all that is done here will help each of our students who receives a degree from this institution to become a woman who:

- (1) thinks straight and expresses her thought clearly;
- (2) is aware of her responsibility as a citizen and as a homemaker;
- (3) is competent at a specific task (often outside the area of home-making);
- (4) has an appreciation of cultural values that will enable her to lift the tastes and enrich the lives of those with whom she lives; and
- (5) has the keen conscience and the steady faith of the Christian without the narrowing zeal of the bigot and who, therefore, possesses the emotional maturity that enables her to contribute to the emotional stability of the members of her family.

It should be added that we do not hold that the college staff receives young women as passive clay and sets them all in a uniform mold, perfect in each of the five respects mentioned above! We are constantly seeking these ends for ourselves and for our students. The college attracts students who are sympathetic with its purposes and the community is so organized that all within it may contribute significantly to the accomplishment of its purposes. It is a serious task to which we are committed, and students and teachers find happiness in working together toward the accomplishment of this task.

# Lindenwood Begins 126th Year On September 9th

*Full Program Planned for Orientation Week With Classes Scheduled  
to Begin on September 15—Variety of Social Events on  
First Week's Calendar*

LINDENWOOD will officially begin its 126th collegiate year on September 9 when the Freshmen and other new students will arrive on the campus. A faculty conference, opening on September 8 will precede the opening of Orientation Week. Registration for the fall semester will be held September 11-13, inclusive, and classes will be organized on September 15.

New students will have dinner with their Student Counselors on Tuesday, September 9, and Dr. McCluer will welcome them to the campus at a meeting in Roemer Auditorium at 7 p.m. Approximately 60 Upperclassmen and a staff of faculty advisers will assist in the Orientation Program, which includes aptitude tests and physical examinations. The program is designed to introduce new students to all phases of campus life and to permit them to get acquainted with the faculty and their classmates.

On September 10 there will be open houses at KCLC, the college radio station, and at the Stables, and an informal reception will be held in the Fine Arts Building that night. Other social events include a street supper, a student variety show, and square dancing. Dr. McCluer will speak at the first vesper service on Sunday, September 14.

## **Dr. Eunice Roberts Resigns To Take Position at Indiana U.**

DR. EUNICE C. ROBERTS, who has been dean of the faculty since September, 1948, has resigned to accept a newly created position at the University of Indiana, President Franc L. McCluer has announced. In her new position she will be Director of Women's Educational Programs and Assistant Dean of Faculties.

Dr. Roberts came to Lindenwood from Eastern New Mexico University at Portales, N. M., where she was Dean of Student Personnel. She holds A.B., M.A. and Ph.D. degrees from the University of Illinois. She is a member of the Executive Council of the American Conference of Academic Deans.

Dr. McCluer will announce Dr. Roberts' successor later. In accepting her resignation, Dr. McCluer expressed regret that she has decided to leave Lindenwood and sincere appreciation of "the signal service she has given the college during the last four years." Lindenwood's popular dean, he said, "has been a com-

petent and vigorous leader of thought and life and action in the Lindenwood community, and has made a significant and enduring contribution to the strength of the college. She will always be a part of the Lindenwood family."
