Dr. Dorothy Fosdick Gives 125th Commencement Address

*America's Role in International Affairs and Need for Co-operation
With Allies Is Stressed by State Department Official in
Message to the Class of 1952*

THIRTY-SIX Seniors received degrees at the 125th annual commencement of Lindenwood College on May 31. Two of them were graduated "magna cum laude" and a third "with distinction." In addition nine diplomas in music were given. The commencement address was given by Dr. Dorothy Fosdick, a member of the Policy Planning Staff of the State Department, who was one of the four recipients of honorary degrees given by the college.

Dr. Fosdick, who is the daughter of Dr. Harry Emerson Fosdick, nationally known minister and writer, chose as her subject, "On Being Up to Date." The American people, she told the graduates, "need to keep up to date on the international position of our nation and what that position demands of us. Being behind the times on trivial matters may be embarrassing. Being behind the times today in foreign policy may be disastrous. We know that no combination of free states is adequate to meet the Soviet threat that does not include us, and that we cannot meet the Soviet threat except in co-operation with allies. We have become a nation which cannot save itself without saving a whole world."

It is not easy to take our new role in stride, Dr. Fosdick pointed out. "We must leave no doubt in the Kremlin, or among our allies, that America can be counted on to stand firmly against aggression and live up to its commitments. Appeasement is out. While building up our strength, we must conduct our foreign policy so as to guard the chances for peace. If we are fortunate enough to face only the need to outwait and outwit the Soviet system, I believe we are up to it.

"There are a host of positive tasks to be tackled. To say that this is a perilous time is simply another way of saying it is a needy one, demanding practical action. The question primarily at stake between ourselves and the Soviet Union is the method by which the world is going to handle its social, economic and political problems. Obviously they are going to be handled on some basis. Nations have to live together in one fashion or another. Is it to be on the basis of domination and subordination, or is it to be on the basis of adjustment and consideration of mutual interests in loyalty to the central concept of democracy? We are not going to beat the Soviet Union except by beating them to it with a better idea. We have that idea. Our responsibility is to live up to it.

"We are betting that the future lies down another

road than tyranny, and we started on that road a long time ago. We have done well in promoting liberty, establishing justice and insuring domestic tranquility. The supreme task of this generation is to turn that ingenuity, practical wisdom and patience to the terribly urgent demands of foreign policy. There is peril ahead, but there are also possibilities. We need our best talent in public service to make sure we do not miss the hopeful turnings. Our present international position gives us small margin for error in foreign policy.

"I hope the wisest of this graduating class will enter politics or government service. I trust some of you may even have your eye on a career in the State Department. It is a challenge which should not discourage anyone with a pioneer spirit, which certainly must be catching here in the Middle West."

Seniors who were graduated "magna cum laude" were Barbara Beth Luchsinger and Nancy Anne Starzl. Barbara Louise Sutton was graduated "with distinction." The members of the graduating class were presented by Dr. Eunice Roberts, dean of the faculty, and the degrees were conferred by Dr. McCluer.

There was a full program for the commencement weekend. The annual art exhibit opened on May 26 in the Fine Arts Building. The baccalaureate sermon was preached on Friday night, May 30, by the Rev. Dr. Clem E. Bininger, pastor of the Second Presbyterian Church of Kansas City, Mo., who took as his subject, "The Secret of Happy Living." The baccalaureate service was followed by a reception for the Seniors and their guests at the home of Dr. and Mrs. McCluer. On Saturday morning the Seniors met with Dr. McCluer for a prayer service at 7:15 a.m., which was followed by a breakfast for the Seniors and their guests on the archery range.

The annual luncheon of the Lindenwood Alumnae Association was held following commencement and members of the Class of '52 were formally inducted. The annual business meeting of the association was held Saturday afternoon.

Dr. McCluer Named to Board of North Central Association

Lindenwood Gives Four Honorary Degrees at Commencement

Two Members of College's Board of Directors and an Alumna Receive Recognition for Outstanding Services

FOUR honorary degrees were given by Lindenwood College at the annual commencement on May 31. This is the largest number of degrees ever bestowed at a commencement and it marked the observance of the 125th anniversary of Lindenwood. The recipients, who received degrees of Doctor of Laws, are:

The Rev. Dr. James W. Clarke, pastor of the Second Presbyterian Church of St. Louis and president of the Board of Directors.

Howard Isaac Young, president of the American Zinc, Lead and Smelting Co., and a member of the Board of Directors.

Miss Lena A. Lewis, member of the Class of '31 and on the staff of the Cleveland Clinic, Cleveland, Ohio.

Dr. Dorothy Fosdick, a member of the Policy Planning Staff of the State Department.

Dr. Clarke was presented for his degree by Philip J. Hickey, Superintendent of Instruction of the St. Louis Public Schools and a member of the Board of Directors. The citation said in part:

"I have the honor to present one of the great Presbyterian ministers of America, the Rev. James W. Clarke. Dr. Clarke was born in Glasgow, Scotland, with all of the strength and virtues which the Scotch Presbyterians have. He was educated in Glasgow and in Montreal, Canada. Since coming to St. Louis, Dr. Clarke has made a permanent niche in the affairs of this city. His sermons over KSD and KSD-TV have made him probably the best known speaker in this area. At Easter of this year, at the request of the Department of State, he prepared an Easter message for the Christian people behind the Iron Curtain to be broadcast over the 'Voice of America.' In addition to being one of America's great ministers, he is also one of the men most interested in the place of the Presbyterian college in education. He is chairman of the board of Lindenwood College, and on the boards of Westminster College at Fulton, Mo., and McCormick Theological Seminary in Chicago. He has just finished the presidency of the Metropolitan Church Federation of St. Louis and was recently elected Moderator of the Presbytery of St. Louis for 1952."

Dr. Clarke presented Mr. Young, whose citation said in part:

"I bring before you one who represents in his person the infinite variety of the American scene; the plentitude of its opportunities, the genius of its industrial

might, the warmth of its friendship, the strength of its home life, the ardor of its patriotism, the sense of its community and the piety of its religion. Howard I. Young's great capacity in his chosen field has been widely recognized. In 1936 the Missouri School of Mines conferred upon him the honorary degree of Doctor of Engineering. He is now president of the American Mining Congress, a director of several of our great commercial institutions, a past president of the St. Louis Chamber of Commerce, an elder and trustee of the Second Presbyterian Church, a member of the General Council of the Presbyterian Church, U.S.A., and, last but not least, a member of the Board of Lindenwood College."

Miss Lewis was presented by Russell L. Dearthmont, a member of the Board of Directors. Her citation said in part:

"I have the privilege of presenting Lena A. Lewis, a distinguished alumna of Lindenwood College. The daughter of a Presbyterian minister, she came to Lindenwood for her undergraduate study and received her Bachelor of Arts degree in 1931. After serving as a research assistant at Johns Hopkins University, she went on to do her graduate work at Ohio State University and received her Doctor of Philosophy degree in physiology. For the past ten years she has been engaged in research at the Cleveland Clinic, where she has six assistants under her direction. She has been a pioneer in the development of a camera machine for photographing blood filtrates. Daughter of Lindenwood, author and scientist of note, she is a woman Lindenwood College delights to honor."

Dr. Fosdick was presented by Mrs. Arthur Strockstrom, a member of the Board of Directors. The citation said in part:

"It is a pleasure to introduce an outstanding American woman, Dorothy Fosdick. Dr. Fosdick has pioneered with distinction in the work of the State Department, a field in which no woman has previously served. Her career has been one of extraordinary brilliance. Entering the State Department in 1932, she has served as an assistant on International Organization. She has also been assistant to the Director in the Office of European Affairs and in this capacity has made countless trips to Europe. A supreme evidence of her ability is the fact that she is a member of the Top Policy Planning Staff of the Department of State—the first woman in history to achieve this eminence."
