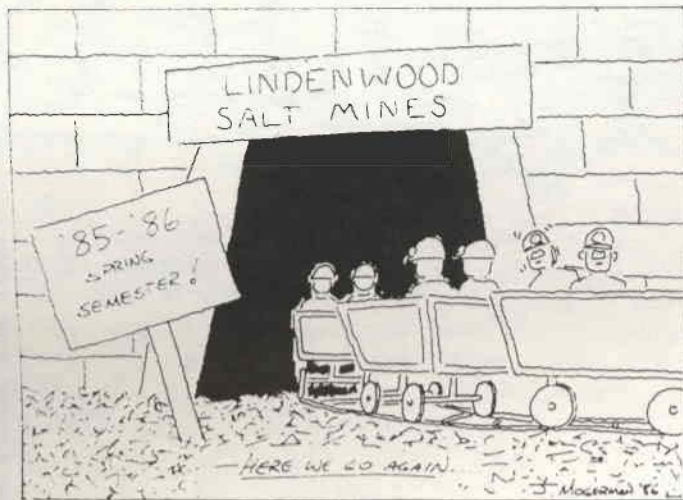

REGISTRATION POLICY CHANGED

TO ALL FULL TIME DAY STUDENTS:

For some time the college has wished to simplify the semiannual registration deposit process, making it less burdensome for you and your families, while still providing sufficiently accurate advance enrollment information to plan effectively. We are pleased to announce a new program is now in place to take effect at the April 1986 registration.

In place of semiannual \$100 enrollment deposits (and an additional annual \$50 deposit for all resident students), the College will now require a one time \$250 deposit under the following guidelines:

1. Each student's deposit money will earn interest at the Certificate of Deposit rate of the bank where invested.
2. The deposit - plus earned interest - will be applied to each student's final semester expenses.
3. A student may realize a 5% discount on tuition room, board, and fee charges (balance due after credit for scholarships and awards) by registering on time in April and November, then paying the balance due by the billing deadlines in August and December.
4. Failure to register in April or November without advance written notice of academic withdrawal will result in forfeiture of the deposit. Another \$250 would be required before any subsequent registration.

In this way, four year students are required to make one, rather than eight deposits (twelve, in the case of residents), the College may expect more reliable advance enrollment data on which to base academic plans, and families may expect a four year savings of \$1000 - \$1500 based on 1985-86 expenses:

5% of \$7,850 = \$392.50 x 4 = \$1,570.00

5% of \$5,030 = \$251.50 x 4 = \$1,006.00 (plus earned interest on a student's deposit applied to the 1st semester's charges.)

We hope this information proves helpful, and that you will feel welcome to check with me or the Business Office on the 1st floor of Roemer for more details or to answer questions. Our best wishes for a memorably rewarding New Year.

Policy on early-registration and enrollment deposits for full time day students:

1. Full-time day students are required to pay a \$250 enrollment deposit by a specified date following first admission to the College.
2. The \$250 is a one-time charge, which is refundable only upon advance written notification of withdrawal from the College.
3. Each student's deposit will be maintained in an interest-bearing account and will be applied, with interest, to tuition for the student's final semester of enrollment. The interest will be the Certificate of Deposit rate at the bank where it is deposited.
4. A \$100 tuition deposit will no longer be required for early-registration, and no additional room deposit will be required. However, any student who early-registers during the specified time (in April or November) and pays in full the balance of tuition and fees (balance due after credit for scholarships and awards) by the due. Returning students who do not early-register do not qualify for the discount. The discount would also apply to new students who pay their bills by the established due date or who have the opportunity to pre-register in the summer.
5. The early registration periods in November and April will end as of the date published by the Registrar. Students who have not registered by the end of the scheduled early-registration period will have to wait for the general registration which immediately precedes each semester.
6. A student who fails to register for any term without giving advance written notice of withdrawal will forfeit the \$250 deposit, and must make another one before a subsequent registration.
7. The room contract and booklet will be revised to contain the following statement: "Residents must register during the scheduled early-registration periods in order to retain the right to residence hall occupancy. Residents who do not register by the end of the scheduled early-registration period will be subject to eviction or loss of housing priority."
8. These policies will take effect with new students who enter in fall of 1986. However, the \$250 deposit will be required of continuing students in order to early register in April 1986.
