

Dr. Paulena Nickell Appointed Dean of Lindenwood's Faculty

Successor to Dr. Roberts Has Been Associate Dean of Home Economics Division at Iowa State College — Other Faculty Appointments Announced

D. R. PAULENA NICKELL, Associate Dean of the Division of Home Economics and head of the Home Management Department at Iowa State College, Ames, Iowa, has been appointed Dean of the Faculty, it is announced by Dr. Franc L. McCluer, Lindenwood's president. Dr. Nickell will succeed Dr. Eunice C. Roberts, who has resigned to become director of women's education and assistant dean of faculties at the University of Indiana.

Dean Nickell will come to the campus for the faculty conference and orientation week, and will move to St. Charles later in the fall. She received her Bachelor of Science degree from the University of Minnesota, a Master's degree in economics from Columbia University, and a Doctor of Philosophy degree in consumer economics from the University of Minnesota. She was a member of the faculty at the University of Minnesota for six years and an assistant professor at the University of Illinois for four years. She has been head of Home Management Department at Iowa State College since 1936 and associate dean since 1947.

Dean Nickell has taken an active part in a number of organizations, including the National Family Life Council, the American Home Economics Association, and the American Association of University Women. She is the author of numerous professional and popular articles in magazines and was a contributing editor to Dameron's "Consumer Problems in Wartime", published in 1944. She is a co-author of "Management in Family Living", published in 1942 and revised in 1950.

Several other additions to the faculty have been announced by Dr. McCluer. Miss Sophie Payne Alston is the new head of the Department of Home Economics, succeeding Mrs. Miriam Hill Houston. She comes to Lindenwood from the Berry Schools and College, Mt. Berry, Ga., where she has been Dean of Women and director of the Home Economics Department. During her administration of the department it was built up to a staff of eight, and a home management cottage and home economics building were built.

Miss Alston is a graduate of the Mississippi State College for Women at Columbus, with a B. S. in home economics. She received her Master's degree from the University of Chicago and has done graduate work at Columbia University and at Peabody College, Nashville, Tenn. Before going to the Berry Schools, she taught in the College Hill, Miss., High School and was head of the Home Economics Department at Grenada College, now part of Millsaps University, at Grenada, Miss.

Mrs. Dora Quinn Arney, who has been teaching physical education and art in the St. Charles Public Schools, has been named instructor in physical education. She succeeds Miss Martha Reese, who was married last June. Mrs. Arney is a graduate of the Southwest State College, Springfield, Mo., and has done graduate work at the University of Missouri. She is the wife of Nelson D. Arney, a coach and teacher in the St. Charles Schools. Last summer she was a supervisor in the city's recreational program.

Robert A. Cruce, assistant professor of music at the Georgia State College for Women, has been appointed to the Music Department faculty. He will direct the college orchestra and teach courses in public school music education. Mr. Cruce was graduated with a music major from Hendrix College, Conway, Ark., and received his Master's degree from the University of Michigan. During World War II he served in the Army overseas. He taught music for one year in the Cape Girardeau, Mo., Public Schools and has been director of instrumental music at the Georgia State College for the last three years.

Dr. Paulena Nickell to Give Annual Founders' Day Address

FOUNDERS' DAY, which this year will commemorate the 125th anniversary of the establishment of Lindenwood, now the oldest college for women west of the Mississippi River, will be held on October 16. The annual Founders' Day address will be delivered by the college's new Dean of the Faculty, Dr. Paulena Nickell.

Alumnae and former students are cordially invited to return to the campus for the Founders' Day program and to meet the new dean. The convocation address will be given in Roemer Auditorium at 11 a.m. Alumnae will be guests of the college at a luncheon in Ayres Hall and the annual pilgrimage to the graves of Major George Sibley and his wife, Mary Easton Sibley, on the campus will be held after lunch.

Dr. Conover Heads Research Group at Regional Conference

Dr. C. Eugene Conover, professor of philosophy and religion at Lindenwood, was chairman of one of four research groups at a regional workshop on the Christian College in Des Moines, Iowa, in August. Representatives of 38 church-affiliated colleges and universities, both Protestant and Catholic, attended the conference.

The workshop was one of six regional workshops held throughout the country this summer as part of a national research program on the Christian College being sponsored by the American Association of Colleges and the Lilly Endowment, Inc., of Indianapolis. More than 300 colleges and universities are taking part in the study.

Dr. Conover is chairman of the Lindenwood faculty committee which is participating in the study. Other members are Dr. Alice Parker, chairman of the English Department; Dr. Homer Clevenger, head of the Department of History and Government; Dr. Mary Terhune, head of the Modern Languages Department, and Dr. John Moore, head of the Economics Department.

Miss Mary Benson on Faculty at Mount Holyoke College

Miss Mary S. Benson, who taught economics and history at Lindenwood from 1935 to 1940, has joined the faculty of Mount Holyoke College, South Hadley, Mass. Since leaving Lindenwood she has been on the faculty of the Milwaukee-Downer College in Milwaukee, Wis.

Dr. McCluer to Head St. Louis United Nations Committee

Advisory Board to Be Named for Lindenwood College

Plan Recently Approved by Synod of Missouri Will Set Up Group of Ten Members to Assist Board of Directors—Three Members of the Advisory Board Have Been Named

LINDENWOOD'S Board of Directors, limited to 15 members, will have the assistance of an Advisory Board of 10 members, under the plan recently authorized by the Presbyterian Synod of Missouri. In addition to approving the Board of Director's recommendation for the Advisory Board, the Synod has elected the first three members of the advisory group, Dr. Franc L. McCluer has announced.

Two members, Mrs. James A. Reed of Kansas City, Mo. and Mrs. J. T. Robison of Texarkana, Texas, will serve the term of 1952-57, and the third elected member, Mrs. Horton Watkins of St. Louis, will serve the 1953-58 term.

Mrs. Reed is a graduate of Lindenwood in the class of 1909. She is the founder and owner of the Donnelly Garment Company of Kansas City, makers of Nelly Don styles. In 1949 the college awarded her an honorary degree of Doctor of Laws.

Mrs. Robison has been an active leader in the Presbyterian Church, U. S. A., for many years, and is now serving on the church's National Board of Christian Education. Recently she visited a number of

European countries as a representative of the church.

Mrs. Watkins' major interest is in child and family welfare. She is chairman of the St. Louis County Division of Family and Children's Service Society, a member of the advisory board of the Department of Welfare of St. Louis County, and former chairman of the board of Macmillan Hospital in St. Louis. A Vassar graduate, she formerly was president for a number of years of the Community School Association, the parent organization of Community School in St. Louis County.

Seven members will be added to the Advisory Board during the next few months, Dr. McCluer said. Advisory members will attend meetings of the Board of Directors.

"It has been felt that the college will be strengthened by this board," Dr. McCluer explained, "not only in having the counsel of representative citizens in the area that Lindenwood serves, but in keeping these leaders acquainted with the work of the college. The character of the three that have been appointed gives promise that this hope will be realized."

Twenty-seven States and Eight Nations Represented on the Campus

Twenty-seven states, two territories and eight foreign countries are represented on the campus as Lindenwood opens its 126th college year this fall. Missouri leads the states in the number of students, closely followed by Illinois. The next four places go to Texas, Tennessee, Oklahoma and Iowa, respectively. Students from outside the mainland have come from Hawaii and Puerto Rico, and from the following countries: Canada, China, England, France, Holland, Korea, Malaya and Turkey.

There are 180 Freshmen this fall, of which 75 per cent were in the upper half of their high school classes and more than 50 per cent were in the upper fourth. Daughters of teachers make up about one-half of the student body.

New students arrive on the campus on September 9 and registration will be held on September 11-13, inclusive. Classes will be organized on September 15. A number of social events are planned for the week of September 9-13 and Dr. Franc L. McCluer will speak at the first vesper service on September 14.
