DRINKING... the campus'challenge'

Is alcohol a problem at Lindenwood?

Answers from the college community to that question vary from "not really" to "definitely." Randi Kapp, director of the Consolidated Advising Program office, said, "I don't think a major problem exists. I hear isolated incidents where drinking has been involved, whether it's to the point of alcoholism, I don't know."

Kapp said only one or two of the incidences that were brought to her attention where intervention by her office was deemed necessary. But, Kapp said, "It sounds like there's a lot of drinking that goes on..but I'm in here and everyone else is out there."

A head resident of one of Lindenwood's dorms said she didn't think there was a real alcoholism problem at the college. But, she did say the school's policy on drinking was, in her opinion, quite lenient.

'I think that the situation is one that the students should take advantage of, but only to the extent of the maturity levels," said one head resident.

"The rules are very liberal, but if they take it beyond a certain extent, they're going to come to the point of losing that liberal feeling. I think students should realize that compared to a lot of schools, they're very fortunate to be able to take responsibility upon themselves."

Lindenwood's policy permits alcohol on campus, an allowance that is not found at many unviversities and colleges. The school does not, however, permit alcohol consumption by minors, in concurrence with the state law.

"It's a priority item of mine," said Schwab.

But, some students said that much heavy drinking does go at the college and it goes on interrupted because of little or no enforcement of Lindenwood's alcohol policy.

Thoug the opinion of students varies on whether a problem exists or not, most feel the manner in which regulations are enforced is not too strict. And even those in authority feel no major problem is present at Lindenwood.



Whatever the case, Allen Schwab, dean of College Life, says plans are in the works for an alcohol education program at Lindenwood "no later than the end of this year."

"It's a priority item of mine," said Schwab. He says such a program is necessary at the college for faculty, staff and students.

Jane Henthorn, R.N. campus health director, said there are both alcoholics and alcohol abusers among drinkers. She added that alcohol problems are present at any college, including Lindenwood, saying peer pressure has much to do with many young people's drinking habits.

Several Lindenwood students explained that drinking is a "challenge"for those under 21 years of age and both that "challenge" and the regularity and severity of their drinking recedes once they reach 21.

"Whenever I could get alcohol before I was 21, I would," said one student. "But now, I'll just drink a soda at a party."

J-Board hears first case

Turn on the cassette recorder and begin recording. "This is a hearing of the Lindenwood College Judicial Board, and today is February 13, 1985." Thus began a judicial process initiated by the Dean of College Life here at Lindenwood.

The purpose of the board is to hear charges of violation of college regulations or guidelines by students as well as student groups while participating in college-sanctioned programs. They are to decide guilt or innocence in each case and to recommend charges of perjury against any defendant(s) or witness(s)

at a Judicial Board hearing. Finally, they are to establish sanctions in case of guilt.

The College Judicial Board consists of Gary Winschel, Ling Fu, Arlene Taich, Paul Binder, Brenda Zurosky, Dean Eckert and Carol Boerding. Acting as Coordinator is Dean Allen Schwab. Three Lindenwood students were charged by the Dean of Students with "violation of posted or published college regulations or guidelines" (e.g., the Residence Hall Booklet and contract of "Special Events Registration").

The defendents were represented by counsel Vic Avellino, for the constitution states that counsel must be from the college community, and not an attorney at law. Counsel may be a student or a member of the faculty and staff.

The ordeal lasted for an hour and a half. Officials agreed that more procedures are needed to make the session run smoother. For 35 minutes, the board deliberated in executive session. The verdict was read and the defendents were found guilty of violation of posted college regulations.

The guilty verdict resulted in the students being given a written notice that continuation or repetition of conduct found wrongful, within this '85 spring term, will be cause for more severe judicial action. The decsion of whether they will appeal has not been made.

Parker Hall, and Irwin Hall were co-educational dorms, while McCluer was the only womens dormatory on campus. Cobbs Hall was the international dorm. A total of 176 lived on campus back then. There was no student center, and Lindenwood students such as Dave Henson, Scott Kohlfield, Becky Rainwater, Bernie Bagen, Pat Lewis, and Paul Englehart, were just beginning their senior years at Lindenwood; Marilyn Morris and Ruth Mitchell were the best known admissions counselors, both are still here.

What was going on back on Thursday September 10, 1981, when the class of '85 was beginning college? First off, The high temperature in the St. Louis area that day was 86 degrees, while the low was 60. The baseball Cardinals were in first place with a 15 - 12 record, (remember '81 was the strike year), a game and a half ahead of the New York Mets. The Cards did not play on Sept. 10. The Football Cardinals record was 0 1, following a previous Sunday loss to Miami.

What songs and albums were Americans and Lindenwood students listening to back then? According to Billboard Magazine, these were the top hits: On the pop singles chart, the number one song was "Endless Love," by Diana Ross and Lionel Richie," Number two: "Slow Hand by the Pointer Sisters' and number three: "Stop draggin' my heart around", by Stevie Nicks, with Tom Petty and the Heartbreakers.

And so it's time for the class of 1985 to finish out and move on. When the diplomas are handed out on May 18, it will be adios to Lindenwood college, and hello to whatever it be a psychologist, nurse, or zoo keeper. For most, the last four years have been an experience they'll never forget.
