Lindenwood Inaugurates a New Honors Program

Under Plan Described by Dr. Eunice C. Roberts Students May Now Be Graduated With Special Honors—Three Students Now Enrolled in This Program

ACTION of the faculty of Lindenwood College last year established an honors program which has been inaugurated this fall. Under this program it will be possible for students to be graduated "with distinction," "cum laude," "magna cum laude," or "summa cum laude."

There is a great deal of variety and elasticity in the projects which a student may undertake for graduation with honors. The entire program is under the direction of a Council on Honors composed this year of the Dean, Dr. Homer Clevenger, Head of the Department of History and Government, Dr. Agnes Sibley, of the Department of English, Dr. Mary Talbot, Head of the Department of Biological Science, and Dr. John Thomas, Head of the Department of Music. The student, working under a faculty advisor, submits an outline of her project for approval by the Council on Honors. Her work may extend over a period of two or three semesters. It may be a reasearch project or special problem in the student's major or minor fields. It may be a creative project such as composition in the field of music. It may be the covering of special assignments in various fields of knowledge designed to supplement the student's work in her major and minor fields and of greater depth than the typical undergraduate course. It may be the reading of a selected list of books.

Whatever the project, it must represent achievement of real distinction on the part of the student. The aim of honors work is not so much the completion of a fixed program as it is the student's self-development. It therefore requires of the student responsibility, initiative, and a genuine intellectual curiosity.

After the program is completed, the student and her work will be examined by the Council on Honors which will make a recommendation to the faculty on the degree of honor the student is to receive. Notation of honor received will appear on the student's diploma.

A student not enrolled under the honors plan but whose grade point average for the first seven semesters of her college work is 3.75 or higher will be recommended for graduation "with distinction."

This year there are three students pursuing work for honors.

Miss Lorraine Peck, a senior, is at work on a program of reading and research which she plans to complete with the preparation of a written report. She has not yet determined exactly what the title of this report will be but her work is in the field of church-state relationship in this country at the present time. She is working under the direction of Mr. Manson M. Brien of the Department of History and Government. Readers will recall that Miss Peck was one of the "Washington Semester" students last year.

Miss Mary Ann Smith, a senior, is working under the direction of Dr. Siegmund A. E. Betz of the English Department. Her work is in the field of English Literature. She is using a study of "Milton" as the basis for research into the seventeenth century, the forces which influenced its literature, and the effects which this century in turn had upon the literature of succeeding centuries. Miss Smith will write either one extensive paper or a series of shorter articles.

Miss Margherita Baker, a junior, is working under the direction of Mr. J. W. Grundhauser of the Department of Biological Science. Her problem is concerned with a study of the effects of various phytohormones on the fission rate of Paremecium. Her work will include much background reading and will involve considerable laboratory experimentation, including the development of special techniques, accurate observation, and the critical analysis of the facts observed.

It is probable that other juniors will begin programs the second semester.

Since graduation "With Distinction" depends entirely upon grades, it is not possible at present to know what students will be candidates for that honor. Two students, JoAnn O'Flynn and Bettie B. Wimberly, were graduated "with distinction" in 1949.

Two Women Are Named to Board of Directors

Mrs. Leo Vogt, of Webster Groves, Mo., and Mrs. Arthur Stockstrom, of St. Louis, Are First Women Ever to Serve on Lindenwood's Board

A PRECEDENT-MAKING announcement was made by the Rev. Dr. James W. Clarke, president of Lindenwood's Board of Directors, on Founders' Day. For the first time in the 123 years of the college's history, women have been named to the Board. The new Board members are Mrs. Leo Vogt, of Webster Groves, Mo., and Mrs. Arthur Stockstrom, of St. Louis.

In announcing their appointment, Dr. Clarke said: "Lindenwood is a women's college. We need the woman's approach to education. The selection of these two outstanding women is a forward step in planning for the Lindenwood of the future."

Both of the new board members have long been active in civic and religious affairs in the St. Louis area. Mrs. Vogt is president of the Presbyterian Women's Missionary Society. She served as a member of the National Board of Foreign Missions of the Presbyterian Church, U.S.A., from 1935 to 1947.

She has been a delegate to the National Council of Presbyterian Women each year since the Council was organized. She is now director of the Church World Service Center of St. Louis, and is a former member of the Board of Education of Webster Groves.

Mrs. Stockstrom was educated at Beaver College, Pa., Vassar College and Columbia University, and she has done graduate work at Johns Hopkins University. She has served as a member of the Board of Directors of the John Burroughs School in St. Louis and as president of the Planned Parenthood Association of St. Louis. She is now a member of the Board of Directors of the Planned Parenthood Federation of America. Mrs. Stockstrom has also served as vice commissioner of the Girl Scouts of St. Louis and as Education chairman of the Missouri League of Women Voters. She is now a member of the Board of Directors of the Social Planning Council of St. Louis.

Thomas H. Cobbs Hall Dedicated on Founders' Day

More Than 1000 Alumnae and Guests Attend Ceremonies at Which Lindenwood's New Building Was on Display - Dr. Arthur H. Compton Gives Address

M ORE than 1,000 Lindenwood alumnae, guests and students attended the annual Founders' Day observance on November 21, at which the college's new residence hall was formally dedicated. Thomas Harper Cobbs, vice president and counsel of the Board of Directors, for whom the building is named, and Mrs. Cobbs were guests of honor.

Because of the inclement weather the dedication program was held in Roemer Auditorium. Loud speakers carried the program to the overflow crowd, in other rooms in the building.

The Founders' Day address was delivered at the dedication program by Dr. Arthur H. Compton, Chancellor of Washington University. He took as his subject, "We Educate For Peace." "The community rejoices with Lindenwood College on the occasion of receiving this fine new dormitory," he declared. "In a democratic society in which the government must follow the thoughts of its people, it is doubly important that the women, who have so large a part in shaping our ideals, have full education. They must have an understanding, a double share of the inspiration to fit life to the needs of the community, and a good knowledge of the arts which they themselves need to use.

"The college that is built on a religious foundation is in a unique position to aid in building American society. Here is a basis for understanding what we mean when we speak of freedom, the freedom to make the world what we believe it should be. In this day we are not concerned with temples built by hand. It is in men and women that our God lives, if indeed, he is alive at all in the life of man. In building men and women who will serve Him, we have before us a great vision that can give us strength in time of peace. These are the men and women who will devote themselves to building the lives of those around them, to insuring that we have a society of people for whom life has worth.

"It is just such an education that we would supply to our community. Lindenwood does this on the basis of its Presbyterian background. The Thomas H. Cobbs Hall will make possible such an education for an expanding group of young women who can build such a spirit into the life of our community."

The invocation for the dedication program, held in Roemer Auditorium, was given by the Rev. Dr. Harry T. Scherer, a member of the Board of Directors

and pastor of the Webster Groves Presbyterian Church. The new residence hall was formally delivered to the Board of Directors by Louis La Beaume, of the firm of La Beaume and Unland, which designed it. The building was accepted and dedicated as Thomas H. Cobbs Hall by the Rev. Dr. James W. Clarke, president of the Board and pastor of the Second Presbyterian Church of St. Louis.

Mr. Cobbs responded to Dr. Clarke's tribute and then greetings were extended to Mrs. Cobbs by Miss Joan Reed, president of the Student Government Association. Dr. Clarke then presented the building to the administration of the college and Dr. Franc L. McCluer, Lindenwood's president, accepted it. The benediction was given by the Rev. Dr. Elmer B. Whitcomb, a member of the Board and pastor of Westminster Presbyterian Church of St. Joseph, Mo.

A luncheon for the alumnae and guests was given at noon in Ayres Hall, and at 1:15 p.m., the alumnae, faculty and student body made the annual pilgrimage to the graves of Lindenwood's founders, Major and Mrs. George C. Sibley. A reception was held in the new residence hall from 1:30 to 3:30 p.m., with the student residents of the hall acting as hostesses.

The installation was followed by a banquet that night. A pledging service was held on December 6, at which time pledge ribbons of red, gold, and white were pinned on the candidates for membership. 
Lindenwood Alumna Writes Book About the Vatican

Mrs. Weygandt was graduated from Lindenwood in 1933, receiving a Bachelor of Music Degree. After she left Lindenwood, she began specializing on the harp, beginning a course of study with Madame Pampari who is a graduate of the Milan Conservatory in Italy, and a protegee of Tedeschi, the Italian harp composer and teacher. During the 1935-1936 season, she became second harpist with the St. Louis Symphony Orchestra, and has just completed her fourteenth year with that organization. She spent five months of intensive study in Italy during the summer of 1936 with her teacher, which experience, she says, was a great inspiration to her.

This summer was her fifth year as harpist with the St. Louis Municipal Opera orchestra. The Opera season is twelve weeks, with a show every night, and a different light opera every week. The average nightly attendance at this open air theatre is 10,000. She says she enjoys being behind the scenes, as it were, when an opera is gotten in shape with just with one week of actual preparation. The chorus rehearses in one building, the main characters in another, and the dancers in another. Saturday night, at midnight, after the regular performance, is dress rehearsal. Sunday afternoon the cast rehearses the music and dances with the orchestra, and the Monday night performance is the first time the whole production is put together in its entirety. She says that it still amazes her that this can be done.

She has also had experience in radio work as harpist with the KMOX studio orchestra in the fall of 1948. Her musical calendar for the year includes various types of single engagements, such as weddings, receptions, funerals, musical shows at theatres, harp demonstration and programs at public schools, recitals, and teaching. She belongs to Mu Phi Epsilon, National Music Sorority, and with a sorority sister, a violinist, gives ensemble programs. In fact, they were musical delegates to the Sorority's National Convention when it was held in Denver, Colo., in 1943.

In addition to her professional activities, she holds office in two church organizations, and at home takes care of her family which includes two daughters, Susan and Shirley.
