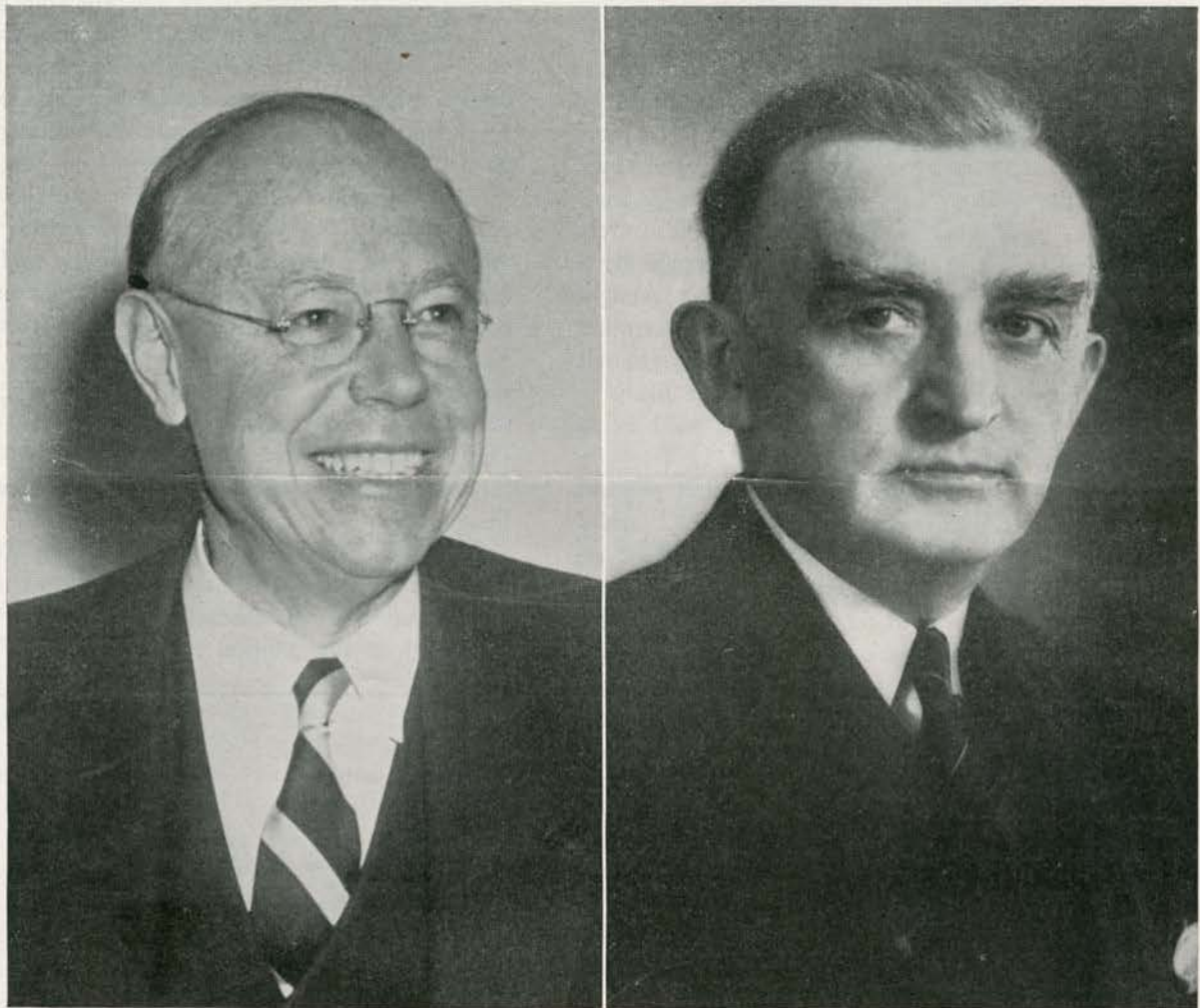

# Current Comment

AS EDUCATION BRINGS TO THE INDIVIDUAL a measure of the understanding of the good, the true, and the beautiful, so should it bring an increased sensitiveness to his social obligations. In a democratic society one of the chief obligations is that of the thoughtful participation in the activities of government. Education should offer adequate preparation for individual achievement together with a lively awareness of one's responsibilities as a citizen. A college graduate does not discharge his duties as a citizen by being a good engineer, or a good social worker, or a talented musician, or an expert in any profession. Whether one be a poet or a chemist, he should be prepared for intelligent participation in the political life of the nation as a voter. Surely the best trained minds in the nation should be seeking an understanding of the political issues of the day. And, surely those privileged to withdraw from the struggle for a living in order to study must not neglect thought about their own political responsibilities. On the other hand, college campuses may well be the testing grounds and the nurturing places of ideas that are likely to prevail in social and political affairs as well as in scientific and aesthetic developments.

The student Democratic and Republican political conventions at Lindenwood College April 1, 2, and 3 are designed to stimulate understanding of these responsibilities. Each of the conventions will be conducted in accordance with the rule of the corresponding national party convention. Delegates from many

of the four-year colleges of the Mississippi Valley will be guests of Lindenwood College during the convention. They will vote by colleges rather than by states and will adopt platforms and nominate candidates for the presidency and vice-presidency.

The key-note speakers will be Senator Robert A. Taft and Senator Joseph C. O'Mahoney. Addresses of these political leaders will be broadcast, as will other proceedings of the conventions. Students will debate current political issues and are now preparing for these discussions in studies of taxation, civil liberties, statehood of Hawaii, the dangers of inflation, foreign policy, Federal aid to education, the Taft-Hartley labor act, universal military training, and so on.

The experience will be a good one for the students, not only in giving them acquaintance with political processes and with the procedures of national conventions, but because it will bring them into immediate contact with the changing world about them. This contact will undoubtedly bring an impetus to their thought about political affairs, but, more important, it will give them further preparation for the part that will inevitably be theirs in a few years.

Without any question students who participate in these conventions will have a quickened interest in political affairs and a better understanding of political issues. The decisions which they make in the mock conventions will be watched with interest by party organizations and political leaders.

# Taft and O'Mahoney to Address Lindenwood Conventions

*College to Sponsor National Student Political Conventions Which Will Focus National Attention Upon Lindenwood on April 1, 2, and 3*

**A**N EVENT which will attract national attention—both from educators and politicians—will be held in the Lindenwood campus on April 1, 2, and 3. These are the dates for the national student political conventions in which it is expected that students from several hundred of the country's universities and four-year colleges will participate.

Headlining the list of speakers who will address these student meetings will be two outstanding national political leaders. The Republican student convention will be addressed by United States Senator Robert A. Taft of Ohio, majority leader in the Senate and a leading candidate for the Republican nomination for President. The Democratic convention will have as its principal speaker, United States Senator Joseph C. O'Mahoney of Wyoming, who has been prominently mentioned as a candidate for the Democratic nomination for Vice President. Their addresses will be broadcast from the campus on network hookups, and will focus national attention upon the college.

These tradition-breaking meetings, Dr. Franc L. McCluer, Lindenwood's president, believes, "will stimulate student interest in and understanding of the political issues before the nation." It is one of the major responsibilities of education, he points out, "to lead students, whatever their major interest, to an awareness of their responsibilities as citizens."

The conventions are being sponsored by the Lindenwood Chapter of the League of Women Voters, of which Miss Linda Blakey, a Senior, of Paris, Mo., is president. Dr. Homer Clevenger, head of the Department of Political Science and Mayor of St. Charles, will work with the student committees in setting up the rules of procedure for the conventions.

The two conventions will be held simultaneously and will meet independently, except when the delegates will assemble to hear the addresses of Senators O'Mahoney and Taft. The conventions will be patterned on the national political conventions and each one will adopt a platform and nominate candidates.

Invitations to participate in the conventions have been sent to approximately 400 universities and colleges. Each school is entitled to send two delegates to each convention and the number of votes of each delegation will be determined by the enrollment it represents.

The tentative program for the conventions includes registration and organization meetings on the opening day, April 1. Following the opening session there will be a dinner that night in Ayres Hall. On Friday, April 2, after the reports of committees are received, the permanent organizations of the conventions will be perfected and the platforms submitted. A college dance for all delegates is planned for Friday night.

Saturday morning nominations for President and Vice President will be made and balloting will start on the nominations. The conventions will adjourn Saturday afternoon.

## **Dr. McCluer to Make Two Weeks' Tour of Eastern Colleges**

Dr. Franc L. McCluer, Lindenwood's president, will leave the campus for a two weeks' tour of the East on March 8. He plans to visit a number of eastern colleges for women, including Randolph-Macon, Sweet Briar, Wellesley, Smith, Wells and Vassar. The trip is planned to observe the programs of the colleges visited.

THE BOARD OF DIRECTORS of Lindenwood College has established what will be known hereafter as the President's Scholarships. They will be given each year by the President of the college to the first five ranking students in the Junior, Sophomore and Freshmen classes. These scholarships are not grants in aid, which obligate the student to accept any employment at the college. They are honor awards in recognition of the excellence of the scholastic records of the recipients.

The first of these honor awards were made at a special assembly of the entire student body on February 25. At that time Dr. McCluer pointed out that they constitute an appropriate recognition on the part of the entire college of the kind of achievement for which the college stands.

# Panel on "Has Radio Come of Age?" to be Held at Radio Conference

*Irving Dilliard, Editorial Writer, Soulard Johnson, Radio Manager, and Ray Dady, St. Louis Newscaster, Are Added to List of Speakers*

LINDENWOOD's second annual radio conference, to be held on the campus on April 23, will include a panel discussion on "Has Radio Come of Age?" Miss Martha M. Boyer, of the Radio and Speech Department and chairman of the committee in charge of the conference has announced. Speakers on the panel will include Ray Dady, manager of Radio Station KWK in St. Louis and dean of the newscasters in the St. Louis area; Irving Dilliard, editorial writer for the St. Louis Post-Dispatch; Soulard Johnson, executive secretary of Station KMOX, and Miss Margaret Fleming, radio consultant of Harris Teachers' College in St. Louis.

One of the principal addresses will be given by Dr. I. Keith Tyler, professor of education and director of radio education at Ohio State University. Dr. Tyler, who is recognized as one of the nation's outstanding authorities on radio education, spent several months in Germany last year as a special advisor to the United States Army. Dr. Tyler is the author of a number of articles on education and is a co-author of "Radio and the School" a new guidebook for teachers and school administrators. In 1944 he was given the Annual Award of Merit by the Advisory Committee of the Chicago School Broadcast Conference for his "outstanding and meritorious service in educational radio."

Invitations to the conference have been sent to the universities and colleges in Missouri and Illinois. Last year seventeen schools were represented, as well as a number of high schools and civic groups in the St. Louis area.

The theme of the conference will focus attention upon the important role the radio now plays in world events and in everyday living and the part higher education must play in its development as a medium of communication and understanding.

Deardorff), Stanton, Neb.: "After leaving Lindenwood I spent one summer and one year in Drake University in Des Moines, Iowa, working on a Masters Degree in Education and Psychology. In 1936, I started putting that education to work and spent nine years in Iowa school systems as a Public School Music Supervisor. I was married two years ago, and my husband and I are actively engaged in the industry of farming. School-teaching was a fascinating business and I loved it, but I can truthfully say that there is never a dull moment on the farm, and the independence is incomparable. However, only a former school teacher could appreciate fully this wonderful independence. If any old friends live in the neighborhood or travel through, we would be delighted to have you stop and see us."
