Dr. Franc L. McCluer Is Named As Lindenwood's New President

College's Twelfth President Is One of Nation's Outstanding Educators and Civic Leader in Missouri-Succeeds Dr. Harry Morehouse Gage

DR. FRANC LEWIS MCCLUER, one of the nation's outstanding educators, is Lindenwood College's new president and the twelfth administrator in the college's 121 years. He succeeds Dr. Harry Morehouse Gage, who retired last June.

Dr. McCluer's selection was announced on March 17 by Dr. James W. Clarke, president of Lindenwood's Board of Directors and minister of the Second Presbyterian Church in St. Louis. He was chosen after the Board had made an exhaustive study of the educators available for the position.

For the last fourteen years Dr. McCluer has been president of Westminster College at Fulton, Mo. His resignation at Westminster is effective August 1, but he plans to come to Lindenwood as soon as possible.

In accepting the presidency of Lindenwood, Dr. McCluer returns to the county in which he was born. He was born at O'Fallon, in St. Charles County, on March 27, 1896. When he was 12 his parents, Mr. and Mrs. C. E. McCluer moved to Fulton, where they still reside. Dr. McCluer was graduated from Westminster in 1916 and received his Master of Arts degree in 1920, two years after he had joined the faculty of the college. He received his Doctor of Philosophy degree from the University of Chicago in 1928.

Dr. McCluer taught sociology and economics at the University of Chicago in 1923 and 1924. In 1925 and 1926 he was visiting professor of sociology at the Southeast Missouri State Teachers College and he has also taught at the University of Missouri.

Dr. McCluer is married and has one son, Richmond Harold McCluer.

At Westminster he founded the Westminster Institute of Public Affairs. The college attracted international attention last year by bringing former Prime Minister Winston Churchill and President Truman to Fulton, where Mr. Churchill delivered the now famous "Fulton" address, which had international implications. The institute's speaker this year is former Secretary of State James Byrnes.

Dr. McCluer is a member of the Board of Directors of the Association of American Colleges, a member of the Board of the Louisville, Ky. Presbyterian Seminary and president of the Board of Curators of Lincoln University. He is a member of a number of educational organizations. He has served as Moderator

She is the representative of the Senior Class on the Student Government Association, is vice president of the Missouri State Sociology Association, and is active in the Athletic Association, the League of Women Voters and the Student Christian Association.

of the Presbyterian Church, a position seldom given to a layman.

Lindenwood's new president has been prominent in civic affairs for many years. He served as a member of the Constitutional Convention which drafted Missouri's new Constitution and was director of the committee which campaigned for its ratification. In 1932 he served as a presidential elector. In 1945 he was president of the Missouri Welfare League. In Fulton, he has twice been given the McCubbin Award, presented annually to the person who has contributed most to Callaway County.

Dr. McCluer has been a frequent visitor to Lindenwood in recent years and has given a number of addresses to the student body.

Lindenwood To Hold Radio Conference On Campus On April 25

Outstanding Speakers Will Address Conference Sessions to Whom Colleges and High Schools in This Area Will Be Invited to Send Delegates

LINDENWOOD COLLEGE will hold its first radio conference on the campus on April 25. The conference will focus attention upon the significant role the radio now plays in world events and the responsibilities higher education shares in its development as a medium of communication and understanding.

Colleges and universities in Missouri and Illinois will be invited to send delegates to the conference and teachers and students of high school radio classes in the St. Louis area will be invited to attend the conference sessions. Colleges and universities to which invitations will go include Washington University, St. Louis University, the University of Missouri, Christian College, McKendree College, Monticello College, Principia College, Stephens College, MacMurray College, Webster College, Fontbonne College, Harris Teachers College, Blackburn College, Maryville College, Westminster College, William Woods College, Shurtleff College and Concordia Seminary.

Plans are now being completed for the conference under the direction of Miss Martha Boyer of the Radio and Speech Department. At the afternoon session, following registration at 1:30 p.m. there will be a panel discussion on "Careers in Radio" in the Library Club Room, The Rev. Elmer Knoernschild, program director of Radio Station KFUO in St. Louis will act as chairman. Speakers and their subjects will be: Miss Kay Morton, Station KXOK, "Programming For Women;" Miss Dorothy Blackwell, assistant director of the Department of Audio-Visual Education, St. Louis Public Schools, "Radio in Education;" Mrs. Ellen Brashear, free lance radio writer and president of the St. Louis Radio Council, "Radio and Public Relations;" Karl Hohengarten, Station KWK, "Radio Music."

At 4 p.m. there will be a demonstration of Lindenwood's radio equipment in the radio studios in the Fine Arts Building by members of the Radio Production Class, who will record a radio script. Members of Sigma Tau Delta will be hostesses at a tea following the demonstration in the Sibley Club Room,

At 6 p.m. there will be a dinner in Ayres Hall, at which members of the Press Club will present a skit dealing with radio.

The evening session will be held in Roemer Auditorium with the theme "Radio Looks Ahead." The speaker will be Lyle De Moss, program manager of Radio Station WOW in Omaha, Nebr.


MORE OR LESS PERSONAL
