Lindenwood Opens Second Semester With Capacity Enrollment

Classes Will Be Organized on February 3—Rising Costs Forces College to Readjust Basic Fee Beginning With Fall Term in 1947

A GAIN this year, Lindenwood will open the second semester with a capacity enrollment. Classes will be organized on February 3. The college regrets that it is unable to accept all the applications for admission.

Advance registrations for the 1947-48 college year are unusually heavy. It is expected that the number of applications will greatly exceed the capacity of the college and alumnae who have relatives and friends planning to enter Lindenwood next fall are urged to make reservations for them as quickly as possible.

Steeply increased operation costs have forced the Board of Directors to increase the basic fee for the 1947-48 year. The new fee is \$1,150, plus the \$30 Student Activity Fee. The Board delayed taking this step as long as possible, but the increased cost of food and supplies and salary raises granted to the faculty and staff to meet higher living costs made it impossible to continue the old fee.

Despite the great demand for registrations Lindenwood will continue to restrict enrollment to the number of students which can be accommodated with the facilities available. This policy assures each student of personal attention and a high standard of scholarship. In this postwar period, when college campuses are crowded and facilities limited, Lindenwood offers exceptional advantages to its students.
