Current Comment

THE April number of BOSTONIA, Boston University's alumni magazine, presents the findings of a notable Institute on Post-War Problems. The emphasis is on education. Speakers on the program may be classed as leading scholars and educators. The record of what they said is, therefore, a source of ready information on topics ranging from Teachers in the Future to Some Responses of the Human Organism to Environmental Stress. Naturally I turned to the magazine to find the chart by which to steer our course. Naturally I was disappointed. There is no such chart. Only an unintelligent and opinionated man—there are more than a few abroad—would attempt to make one.

The Senior Specialist in Higher Education, United States Office of Education, Dr. E. V. Hollis, said "Planning for the future of a college, like that of planning for the future of an individual, is a form of catch-as-catch-can wrestling with several sets of variables that change unevenly and often without relation to each other."

The Vice President of Tufts College, Dr. George S. Miller, after questioning the New England Association of Colleges and Secondary Schools, reported that colleges had advanced to the stage of alertness and had appointed committees on post-war planning.

There is, too, a bright hope that a committee working under the auspices of the American Council on Education will presently present a definite and generally acceptable plan whereby colleges may evaluate credits earned by soldiers and sailors in the Armed Forces Institute.

These findings are not very satisfactory to one in search of ready-made answers to questions about the future. In this situation there is one helpful inference. Those responsible for liberal education are alert and can think. Their adaptations to the requirements of a

changing situation will be promptly and intelligently made. That is one good reason for having liberally educated men on all sorts of jobs and an excellent reason why our liberal arts colleges should and probably will send into the body of society an increasing number of men and women prepared to meet and solve the problems of new situations.

Roger Babson had this point in mind when he recently wrote on investment of money. The only sure investment now is an investment in education. Narrow training for a specific job is not certain to bring returns on time and money spent. The need for any particular skill may disappear quickly. There will be, however, an increasing demand for those who understand the techniques and procedures of science. Moreover, physical science has outrun the controls that may be exercised by those trained in the social sciences. Unless these controls are developed and used physical science may destroy rather than save us. There is quite certain to be a large return on all time and money invested in the study of history, sociology, psychology, political science, and economics. Social services will bulk large in the post-war world. As regards appreciation of its value the liberal arts college faces a new day, a challenging opportunity and a tremendous responsibility.

It is interesting to note that a summary of the proceedings of Boston University's Institute on Post-War Problems contains the following words: "Time and again speakers touched on the social and spiritual requirements of post-war plans, showing how spiritual values had to be re-established in the post-war period, whether related to science, to education, to religion, to business, to research, to government, or to the many other problems discussed."

One comment is appropriate. Within the range of its work Lindenwood will do its part in re-establishing spiritual values.

Eighty-seven to be Graduated at 117th Annual Commencement at Lindenwood

Dr. Guy E. Snavely Will Give Commencement Address on June 5 Climaxing Busy Month on the Campus—Full Program Planned for Alumnae Day on June 3

LINDENWOOD COLLEGE will award degrees, certificates and diplomas to 87 graduates at the college's 117th annual commencement on June 5. Of this year's graduating class, 35 are Seniors and will receive bachelor degrees. Fifty-two students will receive certificates of associate in arts and three will receive diplomas.

The commencement program, in keeping with Lindenwood tradition, will begin with an academic procession headed by Dr. Harry Morehouse Gage, president of the college, under the linden trees to Roemer Auditorium where the commencement address will be delivered by Dr. Guy E. Snavely, Executive Director of the Association of American Colleges.

Dr. Snavely, whose headquarters are in New York City, has been the director of the Association of American Colleges since 1937. He is a graduate of Johns Hopkins University and received his Doctor of Philosophy degree from the Alliance Francaise. He also holds an LL.D. degree from Emory University. During the last war he served in the American Red Cross. From 1921 to 1937 he was president of Birmingham Southern College.

The baccalaureate sermon will be preached in Roemer Auditorium on Sunday, June 4, by Dr. J. Harry Cotton, president of the McCormick Theological Seminary in Chicago, and the author of several books and magazine articles.

A full program has been planned for Alumnae Day on June 3, and a cordial invitation is extended to all alumnae and former students to return to the campus on that day. There will be an open house at the Gables from 2 to 6 p. m. The annual alumnae dinner will be given at 6 p. m. in Ayres Hall. The alumnae speaker this year will be Lieut. (j.g.) Pauline Davis Hedgecock, of the SPARS, a member of the Class of '27. Another feature of the dinner will be the induction of this year's graduating class into the Lindenwood Alumnae Association.

Following the dinner there will be the annual meeting of the association and the election of officers. Miss Pearl Lucille Lammers, of St. Charles, is president of the association. At 8:15 p. m. an hour's program of entertainment will be presented by students of the Music and Speech departments.

Commencement week will climax a busy month on

the campus. On May 20 the annual Senior luncheon was held at the Missouri Athletic Club in St. Louis. The commencement play, "Heart of a City," was presented by Alpha Psi Omega on May 26. The Senior Class had charge of the vesper service on May 28 and of Senior convocations on May 11 and 18.

Irene R. Rogers (Mrs. Kenneth S. Wagner), Edison Place, Belleville, Ill.: "My report is the usual 'homemaker with two children.' My daughter has a son 6 months old. My son is 22, a lieutenant in the A. A. F. in the Central Pacific. I've been active in the Woman's Club, D. A. R., and Red Cross."

Evelyn Lemly (Mrs. Allan Bond), One East End Ave., New York 21, N. Y.: "I lead a very simple life in this big city. I guess I'm what you call a homemaker. We live on the East River away from the rush of the city. My husband and I have a daughter, 12, and a son, 16 years old. Outside my home duties I work at my church and the Red Cross. I'm chairman of the Junior Red Cross at the church."

Helen Craig (Mrs. Alfred Lee Davis), 545 South Losciusko Street, Jacksonville, Ill.: "At the present Mr. Davis and I are still maintaining a home, but we are without a family because our son, George William, is employed in a defense plant in St. Louis, and our younger son, Robert Lee, is enrolled in the V-12 Naval Training Program at the University of Louisville, Louisville, Ky. As for myself, I have been a caseworker in the Morgan County Department of Public Welfare, Division of Public Assistance at Jacksonville, for the past three and one-half years. Our department is under the direction of the Illinois Public Aid Commission and administers Old Age Pension, Aid to Dependent Children, and Blind Assistance programs."
