





Lindenwood's New President Is One of the Nation's Outstanding Educators

Dr. Harry Morehouse Gage, Who Is College's Eleventh President, Was Dr. Roemer's Personal Choice — Has Been President of Coe College Since 1920

DR. HARRY MOREHOUSE GAGE, Lindenwood's new president and the eleventh administrator in the college's 115 years, brings to Lindenwood a record of outstanding service, both in his chosen field of education and in public affairs.

Dr. Gage, whose election was announced by Dr. John W. MacIvor, president of the Board of Directors, on February 11, was Dr. Roemer's choice for his successor. His selection was made after the Board of Directors had made an exhaustive study of the field and interviewed a number of outstanding educators.

"In Dr. Gage," Dr. MacIvor's announcement stated, "Lindenwood will have a president rich in experience in Presbyterian colleges and also in public education. He brings to Lindenwood a record of outstanding service, both to the educational institutions he has headed, and in public affairs, which will enable him to carry forward the program for the college begun by Dr. Roemer."

Dr. Gage comes to Lindenwood with a full appreciation of the things that have been done, and he is deeply mindful of the long line of predecessors whose contributions to the college have made possible the Lindenwood of today. He is especially mindful of the service to Lindenwood of the late Dr. and Mrs. John L. Roemer. Dr. Roemer served as president of Lindenwood from 1914 until his death last August. Under the leadership of Dr. Roemer and his wife, the college was placed on a firm financial basis and became one of the leading women's colleges of the nation.

With this heritage from the past Dr. Gage will guide the college toward the fixed stars of its destiny, with a deep appreciation of his predecessors, particularly Dr. and Mrs. Roemer, and realizing that it is his function to chart new courses, and recognizing that while the fundamental purposes of the college do not change, that we are not bound by tradition, but shall always have a clear path to search for the truth, to respect personality, and most of all to learn the lesson of true human relationships.

Dr. Gage comes from a long line of ministers. Both his grandfathers were ministers and his father, the late John Gage, was a Presbyterian minister and pioneer home missionary. Dr. Gage was born in Franklin County, Ohio, in 1878 at the home of his grandmother because there was no place for a baby to be born in Central City, Colo., where his father was organizing a church.

He attended Grinnell Academy and Wooster College. After receiving his A. B. degree from Wooster, he taught Greek at Huron College, Huron, S. Dak., before going to Columbia University in New York as a University Fellow in philosophy. He received his M. A. degree from Columbia and he has been honored with the degree of Doctor of Laws by Wooster College and Parsons College. The honorary degree of Doctor of Divinity has been conferred upon him by both Emporia College and Illinois College.

He served for seven years as a professor of philosophy at Parsons College, Fairfield, Iowa, and then was called to become president of Huron College. In 1920 he was elected president of Coe College in Cedar Rapids, Iowa, from which he resigned to accept the presidency of Lindenwood.

He is one of the founders and a former president of the American Association of American Colleges, and is a former president of the North Central Association of Colleges and Secondary Schools. From 1928 until 1940 he served as chairman of the North Central Commission on Higher Education. He is a member of the North Central Association Commission on Preparation of High School Teachers by Colleges, and he has directed the North Central Association studies on the modernization of college curriculums, and is an authority on modern trends of education in the combination of liberal arts courses and vocational guidance problems.

Dr. Gage was ordained to the Presbyterian ministry in 1913 and has been active in church affairs for many years. He was moderator of the Synod of South Dakota in 1917-1918, and of the Synod of Iowa in 1924-1925. He is a member of the Board of Directors of the Presbyterian Theological Seminary of Chicago, and was chairman of the board in 1935-1937. He is a trustee of the Presbyterian College of Christian Education, secretary of the Presbyterian College Union, a member of the Presbyterian Board of Christian Education, and from 1926 to 1929 served as a member of the Permanent Justice Commission of the Presbyterian Church.

He was a member of the Federal Regional Planning Board from 1935 to 1937. In 1938 he served as district governor of Rotary International, and he has been president of the Rotary Clubs of both Huron and Cedar Rapids. He is a member of the University Club of Chicago, the City Club of New York, Phi Beta Kappa, Phi Kappa Phi, Pi Mu Alpha, and Phi Gamma Delta.

Dr. Gage's Family Will Come to Lindenwood in June

INDENWOOD is looking forward to welcoming the members of the family of its new president in June when they will move here from their home in Cedar Rapids, Iowa. The family includes in addition to Dr. and Mrs. Gage, five children. The oldest daughter, Mary, is now Mrs. George N. Harless. Avery Morehouse Gage, who is next, is now a flying cadet of the Army Air Corps and is stationed at the Massachusetts Institute of Technology. Then come the twins, William Howard Gage and Elizabeth Reid Gage, who are juniors in Coe College. The youngest daughter, Florence Louise Gage, is a high school student at Cedar Rapids.

An interesting picture of the family, which the Cedar Rapids Gazette calls "typically American," is revealed in the story published in that newspaper after Dr. Gage's election to the presidency of Lindenwood was announced. From it we reprint these excerpts:

"An intimate peek behind the scenes in the Gage home reveals a peaceful living, interrupted only by the excitements which are constantly provided gratis to every American home. There are the usual thrills of someone coming and someone leaving; of graduations, accomplishments, marriages; of someone radiantly in love, of another troubled by a perplexing decision. There is the sharing of confidences and difficulties, teasing and joshing, with a faculty for quick conciliation.

"The family dinner is an event eagerly looked forward to. There conversation ranges from topics of levity to serious discussion of fundamental problems. Arguments range freely, with often the boys opposing the girls, and Dr. and Mrs. Gage sitting back as smiling mediators, occasionally dropping a cogent point on one side or the other.

"There is no subject too big or too small to tackle. In more serious moments they delve into the questions of religion, economics, politics, the pros and cons of the New Deal, and topics in the day's news.

"Quiet, friendly Mrs. Gage is the focal point. Everything revolves around her. Dr. Gage refers to her as the "North Star" of the household. The qualities of culture in the Gage home are a reflection of her. Her appreciation of the arts goes deeper than that of any other member of the family.

"Gage evenings are spent in the library where each one is free to pursue his or her avocation. Early days in his home study with small children crawling about him have hardened Dr. Gage against disturbances as he drafts some of the 200-odd speeches given yearly in coast-to-coast appearances. Shouts and laughter, family friends coming and going, discussions of books, plays and movies among Coe College youngsters cannot disturb him. Like Edgar Guest, Dr. Gage believes 'it takes a heap of living in a house to make it home'."

Lindenwood Student of Sixty Years Ago Recalls College Days

Mrs. Mary Lindsay Johnson, Now Living in Mesa, Arizona, Entered Lindenwood in 1880 When Dr. Irwin Was President of the College

MY daughter in Chicago and Mrs. Zellenger of Florence, Ariz., sent me an article and pictures published in St. Louis Globe-Democrat of Lindenwood College. Writing of Lindenwood connects some of the oldest citizens and Presbyterians of St. Charles. My great uncle was Thomas Lindsay and grandfather James Lindsay who settled at Elm Point in 1812 and 1817. My half-sister, Virginia Durfee Powell, was graduated under regime of Dr. Schenck. I remember the bright dresses of Mrs. Sibley, the long gold watch chain of Mrs. Watson, their golden wedding which as a child I attended. The supper was brought up from St. Louis at a cost of \$500. I wished I could soon grow up and have a dress with a long train.

I entered Lindenwood in the sophomore class under Dr. Irwin in 1880, a shy sensitive girl of 14 years. Mrs. McMillan tried to make one feel at home. I was mortally afraid of Mrs. Jennings. The old log building was used for Negro servants quarters; the gymnasium was used for class rooms; old Sibley Hall had parlor, bedrooms, dining room, basement; then two wings were erected. The bell rang in the morning to arise, second bell, breakfast, then clean room, make bed, study hour, classes. At 4 o'clock we had to walk out as far as old woolen mills, we went in couples; I often went with Ida Richards. After supper, we went to the reading room where students brought fancy work and a teacher read to us such works as "Lorna Doon," or "Pilgrim's Progress," then one hour of study. Woe if all lights were not out at 10 o'clock, Mrs. Irwin taught botany, Dr. Irwin in his study heard class in mental and moral philosophy, Buller's Analogy, Alexander's Evidence of Christianity; Gussie Friedrick taught classes in penmanship.

The Class of 1883 had its baccalaureate sermon on Sunday; the soloist from St. Louis sang "In my father's house are many mansions." On Monday and Tuesday there were musical recitals, Wednesday graduating exercises at which all read essays. Prof. Wolfe had an excellent music department, pianos thumping at practice every available moment. Also an excellent art department was conducted under Miss Potter—I still have a picture of roses given me by Georgia Timken. The most outstanding development in my character learned at Lindenwood is promptness which has

followed me all my life. All I am I owe to Lindenwood. May Dr. Irwin's prayer still follow us: "Dear Lord, keep us under the shadow of thy wing, in the hollow of Thy hand."
