IT Announcement – Workday System Scheduled Outage

Workday outage timeframe:

Friday, March 10, 2017 at 8 p.m. – Wednesday, March 15, 2017 at 11:59 p.m.

Workday will be unavailable beginning March 10 at 8 p.m. to implement Workday Finance. **During the outage timeframe, all features of the Workday system, including time tracking, will be unavailable via all Internet browsers and the mobile app.**

Access to all other IT services, including the website, network, wifi, Canvas, CAMS, the portals and email will be unaffected by this outage. The update to Workday will be completed by Wednesday, March 15 at 11:59 p.m. **Employees that will be working during the outage windows will need to track their time manually and those hours will need to be entered into the Workday system by their manager when Workday is back in service. Note that all hourly employees must have their timecards submitted and approved for that timecard by Monday, March 20, 2017 at noon.**

We are sorry for the disruption in service during this implementation of the next feature in Workday.
