Schrader to Speak at National Conference

Lindenwood University's grant manager, Vicki Schrader, has been invited to speak at the 16th Annual National Conference of the Grant Professionals Association (GPA), to be held October 15-18 in Portland, Ore. Schrader's session is called "Tools and Strategies for the One-Person Grants Office."

Schrader will discuss how a one-person grants office is often bombarded with numerous requests across multiple departments. She will explain how managing these requests while juggling proposal guidelines and deadlines can be done using a five-cycle process. The advantages of this system will be thoroughly explained, detailing how the process is effective in grants management.

The GPA's annual conference has gained a well-earned reputation as the most comprehensive educational and professional growth event available for those committed to excellence in the practice of grantsmanship, she said. The GPA is a nonprofit membership association that builds and supports an international community of grant professionals committed to serving the greater public good by practicing the highest ethical and professional standards.

Romero-Ghiretti Presents at Latin American Studies Conference

Gabriela Romero-Ghiretti, PhD, assistant professor of Spanish at Lindenwood University, presented her paper, "Of Pens and Words, Teresa de la Parra Speaks," at the 47th Southwest Council of Latin American Studies (SCOLAS) conference in San Diego, Calif., on March 29.

Romero-Ghiretti's paper analyzes both the portrayal of female characters and the intellectual position of Venezuelan author Teresa de la Parra. In de la Parra's texts, Romero-Ghiretti states, there is a display of women's negotiations for speech and representation within a shifting background of modernity.

Romero-Ghiretti's paper notes the presence of a dissenting voice from de la Parra as she discussed the role of women in society in a predominantly male environment during three conferences in Bogota, Colombia, in 1930. Romero-Ghiretti argues that these conferences are a blueprint of the writer's intellectual career and a testimony of her involvement in advancing an agenda about gender, which was deployed strategically in order to attain a discursive space among traditional views of gender.

Romero-Ghiretti concludes that the cultural negotiations carried out by the author amidst traditional ideologies about women allowed her to obtain a

medium and a space from which to offer controversial views on women and gender.

The paper is part of larger book manuscript Romero-Ghiretti is authoring that studies the participation of Latin American female cultural figures in the early 20th-century and their struggles with discursive space, ultimately acknowledging the female intellectual as an analytical category in its own right. Romero-Ghiretti hopes to use her research to create a genealogy of the intellectual woman in Latin American letters, establishing a theoretical framework to analyze intellectual contributions of women otherwise eclipsed by male practices in the lettered world.
