Lindenwood University's School of Education ushered in the New Year with the announcement of a new key administrator and two promotions. Dean Cynthia Bice has announced the hiring of Dr. Kim Harding as the school's Director of Field and Clinical Experiences. In addition, Dr. Michael Rankins has taken over as Assistant Dean for the school's Department of Counseling and Dr. Jill Hutcheson has assumed the directorship of the immensely popular Camp Read-a-Lot.

Harding has comprehensive knowledge of the placement process from the school district perspective, having worked most recently as an administrative consultant in the Normandy School District. She has worked in the University City, Clayton, Francis Howell, Parkway, and Columbia, Mo. school districts and served as interim superintendent and assistant superintendent in the City of St. Charles School District.

Bice said the field and clinical experiences position "will be welcome news to DESE (Department of Elementary and Secondary Education) and also CAEP

(Council for the Accreditation of Educator Preparation) as we enter our CAEP accreditation visit this month."

Rankins was hired in 2008 as an assistant professor of counseling. He has been serving as the interim assistant dean for some time.

Hutcheson was hired in 2013 after serving as an adjunct professor.
