Did You Know?

The first paid botanist of Grand Canyon National Park is a Lindenwood aluma. Rose E. Collom was born in Georgia and attended Lindenwood in 1886-87 and 1888-89. In 1938, she took a field trip to the park and exchanged letters with E. McKee, the co-founder of the Grand Canyon History Association. He offered her a grant to enable her to collect specimens in the area, which she did each year until 1954, except for 1948 when her husband was ill. The herbarium at the park has over 800 of her collected specimens.

Lively Named Assistant Dean of New School

Dr. Jason Lively accepted the position of assistant dean for academic affairs for the School of Arts, Media, and Communications on March 3. The position begins in August, when the official merger of the School of Communications and School of Fine and Performing Arts begins.

Lively has taught web design and interactive media for over 18 years. He has been at Lindenwood University since 2007 as a professor and chair of the Interactive Media and Web Design program. Prior to Lindenwood, Lively was a programmer and webmaster at a large computer manufacturing firm and an associate professor at Howard Payne University in Brownwood, Texas, where he was also the director of the multimedia program.



Lively said that he is excited for the position, but his primary focus will be to act as a catalyst for positive change when the schools of Communications and Fine and Performing Arts merge.

"I am eager to work with the wonderful faculty, staff, and administration of the School of Arts, Media and Communication," said Lively. "I am certain that great things are around the corner for the school, and I know that achieving greatness will not rest solely on the shoulders of any one individual, myself included. Through collaboration, innovation, and dedication, I am certain that we will be successful."

Lively has a Bachelor of Business Administration from Howard Payne University, an MBA in computer information systems from Tarleton State University, an Educational Specialist degree from Nova Southeastern University, and a Ph.D. in computing technology in education, also from Nova Southeastern University.

Serving in the Academic Success Center (ASC) as a graduate assistant in 2012 and later as an employee, Render has



played a pivotal role in shaping the structure of this important office over the last four years. Currently, he oversees day-to-day functions of the ASC, including maintaining the computer lab, arranging tutoring and mentoring appointments to accommodate day and evening students, and adding useful academic resources for students and tutors.
