On Wednesday, May 3, 2017, faculty members gathered at the J. Scheidegger Center's Lindenwood Theater for an all-faculty meeting organized by the Faculty Council and the Human Resources Department. In addition to addressing faculty meeting agenda items, the event provided an opportunity to recognize years-of-service milestones of 5, 10, and 20 years, as well as paying homage to the five esteemed faculty members retiring at the end of the 2016-2017 academic year. This is the first time that years-of-service and retirement recognitions have taken place during the annual all-faculty meeting.
